Independent Auditor's Report

To the Participants and Plan Administrator Committee of Robert Charles Lesser & Co., LLC

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Robert Charles Lesser & Co., LLC Cash or Deferred Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

1. PLAN DESCRIPTION

The following description of the Robert Charles Lesser & Co., LLC Cash or Deferred Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and covers substantially all employees of Robert Charles Lesser & Co., LLC (the "Company"). Employees are eligible to participate in the Plan who have attained age 21 and completed one month of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Personal Trust Company, FSB, serves as the Trustee of the Plan.

The Plan operates under a non-standardized pre-approved basic plan document sponsored by Sentinel Benefits Group, Inc.

Contributions

Contributions to the Plan are made by both the participants and the Company. Eligible employees may elect to defer either pre-tax or after-tax compensation as defined by the Plan, subject to the maximum amount allowable under federal income tax regulations. The Plan provides for an automatic election to have pre-tax contributions of 3% of compensation made for all participants upon first becoming eligible under the Plan. Participants may affirmatively elect a different percentage or elect not to make elective deferral contributions.

The Plan contains provisions to operate as a safe harbor plan, at the election of the Company. There were no safe harbor contributions made during 2024. Additionally, the Company may make a Company discretionary contribution to all eligible employees and the Company may also make an applicable qualified non-elective contribution (QNEC) to each non-highly compensated employee actively employed on the last day of the Plan year, who has completed 1,000 hours of service, as required under the Plan, in order to provide the top-heavy minimum contribution. Discretionary and QNEC contributions totaled \$672,534 during 2024.

Rollover contributions are subject to conditions stated in the Plan and in the appropriate sections of the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the contributions of the participant and the Company and an allocation of earnings or losses and administrative expenses of each fund based on the participant's relative account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary contributions and the Company's contributions, plus actual earnings or losses thereon. Therefore there are no forfeited nonvested accounts at December 31, 2024 and 2023.

Payment of Benefits

The Plan provides for withdrawals in the event of death, disability, hardship or termination. Distributions may be made in lump sums or installments. No annuities are allowed under the Plan. The Plan does not allow hardship distributions or in service distributions.

Terminated participant accounts with balances less than \$5,000 may be automatically distributed to an individual retirement account on the participant's behalf unless the participant elects otherwise.

Investment Options

All contributions to the Plan are invested in the various investment options offered by the Plan at the election of the participants. Each participant selects the fund(s) to which contributions will be allocated.

Notes Receivable from Participants

A participant may borrow the lesser of 50% of his or her vested account balance or \$50,000, with a minimum loan amount of \$1,000. Only one loan may be outstanding per participant at one time. Loans are repaid with interest through payroll deductions, normally within five years, unless for the purchase of a primary residence, in which case the maximum term is ten years. Notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus two percentage points.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, the Trustee, once notified by the Company of the termination date, will distribute to each participant his or her account balance on that date in accordance with the terms of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment options which are exposed to various risks, such as interest rate, market, liquidity and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at a measurement date. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Contributions from Plan participants and safe harbor contributions, QNEC and discretionary contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are carried at the unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Personal Trust Company, FSB, a qualified institution.

Fidelity Personal Trust Company, FSB, also certified the information included in the Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Funds: Valued at the net asset value (NAV) of shares held (based on quoted market prices) by the Plan at year end, which shares are traded in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Plan operates under a non-standardized pre-approved basic plan document sponsored by Sentinel Benefits Group, Inc. The non-standardized pre-approved plan has received an opinion letter from the IRS as to its qualified status dated November 30, 2020, stating that the Plan was designed in accordance with applicable IRS requirements. While the Plan has been amended since the receipt of the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

6. RELATED-PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Fidelity Personal Trust Company, FSB, the Trustee of the Plan. Administrative expenses charged to the Plan for the year ending December 31, 2024 was \$59,479 and include amounts paid for investment management and recordkeeping fees. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rule under ERISA. In addition, notes receivable from participants qualify as party-in-interest transactions.

7. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.
