## INDEPENDENT AUDITORS' REPORT

To the Trustees of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Samson Electric, Inc. Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### 1. Description of Plan

The following description of Samson Electric, Inc. Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was adopted by Samson Electric, Inc. (the "Company" and "Plan Sponsor") on January 1, 1996, and was restated effective January 1, 2022. The Plan is a defined contribution profit-sharing plan covering all eligible employees of the Company. Employees are eligible to participate in the Plan once they have completed one hour of service (for salary deferrals and prevailing wage deferrals), the first of the month following six months of service (for employer matching contributions) and on the first of January or July following one year of service (for employer discretionary profit-sharing contributions), and are not leased employees, non-resident aliens, or union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and certain provisions of the Internal Revenue Code ("IRC.")

#### **Plan Administration**

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Equitable Life Insurance Company ("Equitable") was the appointed custodian for the Plan for the years ended December 31, 2024 and 2023, and acted at the direction of the Plan's administrator.

#### **Contributions**

Each participant may elect to contribute up to 100% of their eligible compensation to the Plan, subject to the maximum allowed under the IRC (\$23,000 in 2024). Participants who have attained the age of 50 before the end of the Plan year are eligible to make additional catch-up contributions up to \$7,500 in 2024. The amount deferred can be pre-tax, after-tax Roth contribution, or a combination of both. Participants may also contribute amounts representing rollover distributions from other IRC qualified retirement plans.

The Plan also provides for prevailing wage contributions on behalf of each participant who performs services subject to the Service Contract Act, Davis-Bacon Act, or similar federal, state, or municipal prevailing wage statutes, or any other contract which is contractually subject to the provisions of any prevailing wage law. The contributions made are equal to the balance of the fringe benefits for each participant (after deducting the cost of cash differential payments for the participant) based on the hourly contribution rate for the participant's employment classification.

The Plan Sponsor contributes and allocates to each eligible participant matching contributions equal to 50% of the participant's elective deferrals which do not exceed 6% of the participant's eligible wages. Matching contributions are subject to certain limitations by the Plan. The Plan also provides for discretionary profit-sharing contributions that are determined annually by the Plan Sponsor. There were no profit-sharing contributions for the year ended December 31, 2024.

### 1. Description of Plan, continued

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, rollovers from other qualified plans Company matching contributions, as well as an allocation of the Company's profit-sharing contribution and Plan earnings or losses. Participants are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their 401(k) deferrals, rollover contributions, and prevailing wage contributions and the actual earnings thereon. Vesting of employer matching or discretionary contributions is based on years of service. A year of service is a calendar year in which the participant works at least 1,000 hours. Vesting of employer matching or discretionary contributions as well as all earnings on these contributions vest according to the following schedule:

Participants shall also become 100% vested in employer contributions upon attainment of normal retirement age (65 years), death, or permanent disability.

#### ***Payments of Benefits***

When participants leave the Company, upon retirement or for any other reason, those participants (or their beneficiaries) may receive the vested value of their account in a single lump-sum payment. The Plan also allows for in-service withdrawals upon a participant attaining the age of 59½, for a birth or adoption, or for a hardship. In addition, the Plan allows for withdrawals of any rollover contributions at any time.

Distributions under the Plan shall generally be made as soon as possible after the date of retirement, date of death, or termination of employment. Mandatory distributions of account balances under \$7,000 will be made as soon as administratively possible. In the event of a mandatory distribution greater than \$1,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan's administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan's administrator.

### 1. Description of Plan, continued

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct their contributions in percentage increments into a series of pooled separate accounts and a guaranteed investment contract offered by the Plan.

Participants may change their investment options at any time.

#### ***Forfeitures***

Forfeitures are the non-vested portions of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and may be used to pay administrative expenses of the Plan or to reduce future employer contributions to the Plan. Forfeitures totaled \$7,249 and \$12,962 as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeited funds in the amount of \$13,179 were used to reduce administrative fees of the Plan.

#### ***SECURE 2.0 Act***

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE 2.0 Act. SECURE 2.0 Act contains over 90 new retirement provisions, with varying effective dates through 2027. Since the provisions of SECURE 2.0 Act include both required and optional elements, applicable provisions will be evaluated and implemented in accordance with accompanying regulations and guidance, and the Plan will be amended as required. These changes had no material impact to the Plan's financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities, and changes in net assets available for benefits. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The investments of the Plan are reported at fair value, determined by closing prices for traded securities, net asset value ("NAV"), or at contract value. Net appreciation in fair value of investments for the current year is the calculated difference between the year-end estimated fair values and the purchase prices or, if more recent, the beginning of the year estimated fair values. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the accompanying financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### *Information Certified by the Custodian*

Equitable has prepared and certified as complete and accurate the Plan's schedule of investment assets, transactions, and net realized and unrealized gains and losses on investments certified, and interest and dividend income, which was used to prepare the accompanying financial statements and supplemental schedule.

### 3. Certified Information

The following information included in the accompanying financial statements was obtained from data that has been prepared and certified to as complete and accurate by the custodian, Equitable, as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

### 4. Fair Value Measurements

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has investments in various pooled separate accounts which invest in equity, fixed income, and target date funds. The objective of those investment vehicles invested in equity investments is to approximate the risk and return characterized by various indexes; to seek long term capital appreciation; provide diversified exposure representative of various segments of the United States ("U.S.") or foreign equity market; and/or to seek income. The objectives of the investment vehicles invested in fixed income is to provide investment results that approximate the overall performance of certain bond indices and/or to provide a predictable rate of return while preserving the safety of capital and minimizing market risk. The objective of the investment vehicles invested in target date funds is to provide various levels of asset allocations which become more conservative over time so participants can stay with the same fund before and after selected retirement dates. These investment vehicles are generally redeemable at NAV under agreements with the underlying investment vehicles. However, it is possible that these redemption rights may be restricted by these investment vehicles in the future in accordance with underlying agreements.

Due to the nature of the investments held by the investment vehicles, changes in market conditions and the economic environment may significantly impact the NAV of the investment vehicles, and consequently, the fair value of the Plan's interest in the investment vehicles. Furthermore, changes in the liquidity provisions of the funds may significantly impact the fair value of the Plan's interest in the investment vehicles.

### 5. Investment Contract

The Plan held guaranteed interest contracts with Equitable as of December 31, 2024 and 2023. Equitable reserves the right to adjust the fixed or stated rate of return prospectively during the term of the contract or agreement. A market value adjustment may apply to amounts withdrawn at the request of the contract holder, but at no point will the guaranteed rate fall below 1.00%. The underlying contract has no restrictions on the use of Plan assets and there are no valuation reserves recorded to adjust contract amounts.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (ii) changes to Plan's prohibition on competing investment options; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan's administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed interest contract at contract value was \$1,162,693 and \$1,142,397 as of December 31, 2024 and 2023, respectively.

### 6. Related-Party and Party-In-Interest Transactions

As of December 31, 2024 and 2023, Plan investment funds were managed by an entity affiliated with Equitable, the custodian of the Plan assets. These transactions qualify as party-in-interest. Fees paid by the Plan for investment management service were included as a reduction of the return earned on each investment.

Pioneer Pension Consulting, LLC ("Pioneer") has an administrative service contract with the Plan. Under this agreement, Pioneer provides assistance with the annual Plan administration. Fees for these administrative expenses are paid by the Plan.

There are no related-party transactions other than normal participation in the Plan by employee-officers.

### 7. Tax Status

The Plan uses a non-standardized pre-approved plan document sponsored by Pioneer Pension Consulting, LLC. Pioneer Pension Consulting, LLC received an opinion letter from the Internal Revenue Service ("IRS") dated July 30, 2021, which states that the non-standardized pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC; therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Plan Termination

The Company has established the Plan with the intention and expectation that the Plan will continue indefinitely. However, the Company reserves the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, Plan participants will become fully vested in their accounts, and distributions will be made to participants as described in the Plan agreement.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant's account balances and the amounts reported on the statement of net assets available for benefits.

As of December 31, 2024 and 2023, approximately 30% and 29%, respectively, of net assets were held within two investments offered by the Plan.

### 10. Subsequent Events

In accordance with accounting standards affecting disclosures of subsequent events, the Plan evaluated subsequent events for recognition and disclosure through October 7, 2025, the date which these financial statements were available to be issued.

Effective January 1, 2025, the Plan increased the catch-up limit to \$11,250 for employees aged 60-63. SECURE 2.0 Act of 2022 allows the Plan to make this change and operate in good faith prior to an actual Plan amendment.

Management concluded that, other than the above, no material subsequent events have occurred since December 31, 2024 that require recognition or disclosure in these financial statements.
