### Note 1 - Plan Description

The following description of Eaton 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees who are not covered by collective bargaining agreements and, through September 31, 2023, who have completed one year of service and reached the age of 18. Effective October 1, 2023, the Plan was amended to cover employees who have completed 60 days of service and reached the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

Eaton Metal Products Company (the "Company") is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement. The Plan offers participants a variety of investment options through mutual funds. Individual accounts are invested in the various investment options at the direction of the participant.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 85 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may change their elective deferred contributions monthly. Participants over 50 years old are eligible to make catch-up contributions to the Plan. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

During 2024, certain participant deferral contributions were not remitted by the Company in the time frame required by the Department of Labor. The Company remitted the contributions to the Plan in March 2024. The related lost earnings on the contributions were remitted to the Plan in September 2025.

The Plan provides for discretionary employer matching contributions determined by the Company annually (not to exceed 100 percent of each participant's first 6 percent of compensation, contributed as elective deferrals). The Company made a discretionary match contribution of 100 percent of elective deferrals up to 3 percent of participants' eligible compensation in the amount of \$182,213 for the year ended December 31, 2024.

The Company may elect, at its sole discretion, to make an additional profit-sharing contribution to the Plan. There were no profit-sharing contributions for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

### Note 1 - Plan Description (Continued)

#### *Vesting*

Participants are 100 percent vested in their pretax contributions and rollover contributions and allocated earnings and losses thereon. The Company's matching and profit-sharing contributions and the interest and earnings thereon vest on a graduated scale over five years, as detailed below:

A participant's account becomes 100 percent vested upon death, attaining normal retirement age, retirement due to disability, or if the Plan is terminated.

#### *Benefit Payments*

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. Immediate lump-sum distributions are made to terminated participants if the participant's vested balance is \$1,000 or less. If the balance is greater than \$1,000 but less than \$5,000, the vested amount will be rolled into a qualified IRA in the name of the participant unless the participant elects to receive or roll over the balance.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### *Forfeitures*

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

#### *Termination*

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value based on quoted market values.

See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### *Benefit Payments*

Benefits are recorded when paid.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Administrative Expenses*

Various administrative costs are paid by the Company.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Actual results may differ from those estimates.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including September 26, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

**Note 5 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures mutual funds at fair value on a recurring basis. The fair value of mutual funds is based primarily on Level 1 inputs as described above.
