For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the **C. William Hetzer, Inc. (Company) 401(k) Retirement Plan** (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a prototype non-standardized defined contribution profit sharing plan covering all employees who have one year of service (working at least 1,000 hours) and are age eighteen or older.

During 2014, the Board of Trustees amended the Plan document and adopted a prevailing wage contribution plan covering all employees who perform work for the Employer that is subject to prevailing wage laws. This contribution is 100% vested and excludes highly compensated employees.

The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

During 2016, the Board of Trustees amended the Plan document and adopted a revision for the allocation of earnings. The Board of Trustees also revised the plan to permit participant directed investments whereby participants may, subject to procedures established by the Administrator, and applied in a uniform and nondiscriminatory manner, may direct the Trustee, in writing (or in such other form which is acceptable to the Trustee), to invest their entire accounts in specific assets, specific funds, or other investments permitted under the Plan and the participant direction procedures.

Contributions: Each year, participants may contribute to the Plan a specific dollar amount as determined by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Company will make a discretionary matching contribution equal to a percentage of the base compensation that a participant contributes to the Plan. The Company may contribute a special discretionary contribution equal to a percentage of each participant's compensation and a discretionary amount in addition to the special contribution each year at the option of the Company's board of directors. In 2024, the Company's board of directors approved a discretionary matching contribution of an amount equal to 50 percent of the participant's contributions. During the year ended December 31, 2024, the Board of Directors approved a \$25,000 profit-sharing contributions. All contributions are subject to certain IRS limitations.

During the year ended December 31, 2024, the Company made prevailing wage contributions in the amount of \$337,662. Contributions to the prevailing wage plan are participant directed. Contributions are subject to certain IRS limitations.

Participant accounts: Each participant's account is credited with the participant's contribution, the Company's discretionary matching contributions (including prevailing wage contributions), as well as allocations of the Company's discretionary non-elective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the company's matching contributions, if any, are equal to a uniform percentage (to be determined each year by the Employer) of each such participant's elective deferrals. Allocations of the Company's discretionary non-elective contributions, if any, are based on the ratio of the participant's eligible compensation to the total eligible compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and prevailing wage contributions, plus actual earnings thereon. Participants are 100 percent vested in the Company's special discretionary contributions made to the Plan. Vesting in the Company's discretionary matching contribution portion of their accounts, plus actual earnings thereon are based on years of continuous service. A participant is 100 percent vested after six years of credited service. In addition, participants become automatically fully vested when they reach normal retirement age while employed, as defined by the Plan, or terminate employment due to total disability or death.

Payment of benefits: On termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or he or she may rollover all or a portion of the distribution to an Individual Retirement Account or another qualified employer plan.

Forfeited accounts: At December 31, 2024 there were \$4,691 in forfeited nonvested accounts. These funds were used to reduce employer contributions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting: The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Significant estimates include fair value determinations provided by the Plan Administrator.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Transaction expenses, such as distribution administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments use the net asset value per share as determined by investment managers under the so called "practical expedient". The practical expedient allows net asset value per share to represent fair value for reporting purposes when the criteria for using this method are met. These investment funds are held as units or interest in institutional funds or limited partnerships, which are stated at net asset value (NAV) or its equivalent. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the investment will be sold for an amount different than NAV.

Transfers between levels: For the years ended December 31, 2024 and 2023, there were no significant transfers between levels 1 and 2 and no transfers in or out of level 3.

5. ROLLOVER CONTRIBUTIONS

There were no participants' account rollovers into the Plan for the year ended December 31, 2024.

6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by the VOYA Retirement and Annuity Company, the custodians as defined by the Plan and Alerus Financial, N.A., the prior custodian of the Plan, therefore, these transactions qualify as party-in-interest transactions. Commissions and fees paid by the Plan for the investment management services amounted to \$46,595 for 2024. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

8. TAX STATUS

The Plan and related trust are relying upon the Internal Revenue Service (IRS) Advisory Letter that was issued by the IRS to the pre-approved prototype plan, which the Company's Plan is utilizing. Although the Plan has been amended since receiving this approval, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Code and Department of Labor. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was certified as complete and accurate by VOYA Retirement and Annuity Company, the custodians of the Plan.

10. SUBSEQUENT EVENTS

The Plan has evaluated events and transactions subsequent to December 31, 2024 through October 8, 2025, the date these financial statements were available to be issued. Based on the definitions and requirements of accounting principles generally accepted in the United States of America, management has not identified any events that have occurred subsequent to December 31, 2024 through October 8, 2025, that require recognition or disclosure in the financial statements.

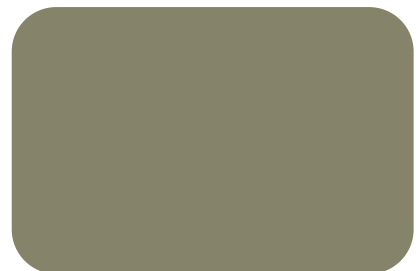
