## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
EG America Employee Savings Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of EG America Employee Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

**1. Description of Plan**

The following description of the EG America Employee Savings Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution profit sharing 401(k) savings plan, which constitutes a controlled group plan for the benefit of the employees of EG Retail (America) LLC (the Plan Sponsor or Plan Administrator) and the employees of certain other participating related companies (collectively, the Employer) who have attained 21 years of age if hired on or after January 1, 2024 and 18 years of age if hired prior to January 1, 2024, and have completed three months of service, as defined by Plan provisions. The participating related companies include Certified Oil Corporation; Cumberland Farms, Inc.; EG Shared Services (America) LLC; Fastrac EG, LLC; Fastrac Transportation EG, LLC; Junior Food Stores of West Florida, Inc. dba Tom Thumb; Kwik Shop, Inc.; Mini Mart, Inc. dba Loaf'n Jug; Minit Mart LLC; Quik Stop Markets, Inc.; TH Midwest, Inc.; and TH Minit Markets, LLC.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All investments are participant-directed.

The Plan Administrator has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Management Trust Company (Fidelity) is the appointed trustee of the Plan and acts at the direction of the Plan Administrator.

***Contributions***

Participants may elect to contribute up to 60% of their annual pretax compensation, as limited by the Internal Revenue Code (IRC). Participants who are eligible for participant catch-up contributions may elect to contribute up to 75% of their annual pretax compensation, as limited by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (Rollovers). Upon enrollment into the Plan, a participant may direct contributions among various investment vehicles with varying investment goals and risks. The Plan also provides for participant catch-up, Roth and Roth catch-up contributions.

The Plan offered an automatic enrollment feature through January 11, 2024. Participants were automatically enrolled in the Plan after meeting eligibility requirements and re-employed former participants were automatically re-enrolled after re-employment at a contribution percentage rate of 3% of eligible compensation, as defined by the Plan. This rate was automatically increased by 1% each January 1, up to a maximum of 10%. Effective January 12, 2024, participants must elect, either by telephone or the internet, to opt into the Plan.

Prior to January 1, 2024, the Plan provided for an Employer non-discretionary match of 100% of the first 3% of eligible participants' compensation contributed to the Plan and 50% of the next 2% of eligible participants' compensation contributed to the Plan. The Employer also matched 50% of the catch-up and/or Roth catch-up contributions; however, the non-discretionary Employer matching contribution on behalf of a participant with respect to any payroll period could not exceed 30% of such participant's eligible compensation with respect to such period.

The Plan was amended on January 1, 2024 to remove the Employer non-discretionary match provision and add a safe harbor non-elective matching contribution equal to 100% of the first 3% of eligible participants' compensation contributed to the Plan and 50% of the next 2% of eligible participants' compensation contributed to the Plan. To be eligible to receive safe harbor non-elective contributions, an Employee must have been employed for 12 months and have attained 21 years of age.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Employer's matching contribution, the participant's allocation of earnings/losses and any expenses incurred. Allocations are based on participant compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions. Effective January 1, 2024, participants are immediately vested in their new safe harbor contributions, plus the allocation of Plan earnings on those contributions. All Employer non-discretionary match contributions made prior to January 1, 2024, and the allocation of Plan earnings on those contributions, are subject to a 5-year vesting schedule, as follows: 25% after 2 years, 50% after 3 years, 75% after 4 years, and 100% after 5 years. Participants' prior service with certain companies acquired by the Employer is credited towards vesting. Participants are immediately vested in all accounts upon death, disability, attainment of retirement age, or early retirement age 55.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 (reduced by the highest loan balance during the last 12-month period) or 50% of their vested account balance. Terms range from 1 to 5 years, or up to 20 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest equal to the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

The Plan allows terminated participants with an outstanding loan to continue making payments after termination in accordance with the promissory note.

***Payment of Benefits***

The Plan allows for in-service distributions of the participant's vested accounts upon reaching the age of 59½ or due to hardship, as defined by the Plan. In-service withdrawals are also permitted for Rollover and Roth Rollover account balances at any time. Upon termination of employment for any reason, a participant or beneficiary will be entitled to the value in their vested account balance. If a participant's vested balance is equal to or less than \$1,000, the participant will receive an immediate cash-out of their vested account balance, and the non-vested portion shall be treated as a forfeiture. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$7,000 (increased from \$5,000 effective January 12, 2024), the amount will be rolled over to an individual retirement plan designated by the trustee, unless otherwise directed by the participant.

***Forfeitures***

A terminated participant forfeits the unvested portion of his or her account at the earlier of a full payout or incurring five consecutive one-year breaks in service. Forfeited non-vested accounts may be used to reduce Employer matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,522 and \$133,233, respectively. Forfeitures of \$3,651,745 were used to reduce Employer contributions during the year ended December 31, 2024.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan invests in the Fidelity Managed Income Portfolio (MIP) common collective trust fund. The Plan's interest in the MIP is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the common collective trust at year end.

The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan Document.

***Contributions***

Participant and Employer matching contributions are recorded weekly and bi-weekly, as applicable, when the Employer remits the contributions for investment into the Plan.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan held one mutual fund that accounted for 12% of total Plan investments at December 31, 2024.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Fund:* The Plan invests in the Fidelity Managed Income Portfolio (MIP) - Class 1 Fund, an investment vehicle that invests in income securities such as U.S. treasury bonds, government agency securities, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, asset-backed securities and derivative instruments, including futures, options and swaps.

This investment is valued at the NAV of units held by the Plan. The NAV, as provided by Fidelity, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan; however, there is up to a 12-month redemption for this investment at the Plan level.

As of December 31, 2024 and 2023, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

#### **4. Plan Termination**

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**5. Income Tax Status**

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Summary of Financial Data Certified by the Trustee**

The following is a summary of financial information and data certified by the trustee, Fidelity:

**8. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Fidelity, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to the trustee for investment management services and administrative fees totaling \$528,318 for the year ended December 31, 2024. The Plan also made payments of \$114,971 to an independent investment advisor during 2024. Participant notes receivable also qualify as party-in-interest transactions.

**9. Subsequent Events**

Effective January 1, 2025, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0, allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250. Additional SECURE Act 2.0 provisions may also apply based on plan design and future regulatory guidance.

Management has evaluated subsequent events through September 30, 2025, which is the date these financial statements were available to be issued.
