Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### NOTES TO FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF PLAN

The following description of TTG Imaging Solutions, LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a contributory defined contribution plan sponsored by TTG Imaging Solutions, LLC and its related entities, Cardiac Imaging Solutions, LLC, TTG Isotopes, LLC, Absolute Imaging Solutions, LLC, Digirad Health, LLC, and Southwestern Imaging Systems and Services, LP (collectively the "Company" and/or "Plan Sponsor") under the provisions of section 401(a) of the Internal Revenue Code ("IRC") for the benefit of eligible employees of the Company.

All employees, except those specifically excluded in the Plan document, who are 21 years of age, have completed one month of service as defined in the Plan document, are eligible to participate. As defined in the Plan document, employees are eligible to enter the Plan on the first day of the month coinciding with the service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2024, the Plan was amended to include employees of Digirad Health, LLC, whose plan transferred into the TTG Imaging Solutions, LLC. All funds are 100% vested and prior years of service is credited to the participant's account and were eligible 30 days following the close of the acquisition.

Contributions - Participants may contribute up to 100% of pretax and after-tax compensation, as defined in the Plan document, up to the annual limitation allowed by the Internal Revenue Code ("IRC"). The Plan includes an auto-enrollment provision whereby eligible employees of the Plan are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with an elective default deferral rate of 3% of pre-tax deferral of eligible compensation. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company matches a safe harbor contribution of the participants' contributions equal to 100% of the first 3% and 50% of the participant's contributions between 3% and 5% of the participant's eligible compensation, as defined in the Plan document. The Plan also provides for a discretionary nonelective employer contribution to be contributed to the participants' accounts at the discretion of the Company for eligible employees who have completed one year of service.

All participants who have attained age 50 before close of the Plan year are eligible to make additional elective deferrals in accordance with, and subject to the limitations of, IRC Section 414(v).

Participant Accounts - Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's matching and discretionary profit-sharing contributions, (b) Plan income and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions and safe harbor contributions plus actual earnings thereon. The Plan's vesting for QACA safe harbor contributions made prior to January 1, 2022, are 100% vested after a participant reaches two years of service. The Company's discretionary match and profit-sharing contributions portion plus earnings thereon is based on years of continuous service according to the following 6-year graded schedule. As of January 1, 2024, vesting requirements were amended to allow for participants to be 100% vested in employer nonelective contributions and any previous employer matching contributions. Any unvested match or any profit-sharing benefits will be fully vested if employed on January 1, 2024. Terminated employees as of December 31, 2023, will vest according to vesting schedule below.

Vesting includes service eligibility with Main Medical, Inc., ODI Diagnostics, LLC, Ultrasound Consultant Services, Inc., Medical Imaging Technologies, Inc., Osiris Medical, LLC, Cardiologic LLC, Northeast Electronics, Inc, Mtek Solutions LLC (Absolute Imaging Solutions), Molecular Imaging Specialists, LLC, Nuclear Imaging Services, LLC, TTG Isotopes, LLC (formerly Nuclear Imaging Isotopes, LLC and Lakeshore Isotopes, LLC), Southwest Imaging Systems & Service, Digirad Health, LLC, and any further entity that the Company acquires will be counted but only with respect to individuals who are employees of the acquired entity at the time of the acquisition.

Investment Options - Participants may invest their voluntary contributions, rollover contributions and the Company's contributions, plus actual earnings thereon into any of the investment options offered by the Plan. The participants may change their investment elections for new contributions and existing balances daily.

Effective January 2, 2024, the Plan changed its custodian from Reliance Trust Company to Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal"). During the transition period of changing the custodian, a "blackout" period was put into place. During the blackout period, the participants were temporarily unable to initiate a transfer of money from one investment option to another investment option, change their contribution deferral, obtain a distribution or in-service withdrawal from the Plan, request a loan, or make inquiries about their account. This blackout period was from December 20, 2023 to January 28, 2024. The participant's assets were transferred and mapped to Principal's investments that had similar investment strategies as Reliance Trust Company. After the mapping, as of January 28, 2024, participants were able to resume transferring money from one investment option to another investment option, change their deferral contribution, obtain a distribution or in-service withdrawal from the Plan, request a loan and make inquiries about their account. Participants may change their investment options daily.

Payment of Benefits - A participant who has attained age 59½, has incurred a hardship (as defined in the Plan document) or has become disabled may receive a distribution from the Plan. The Plan may also make a distribution upon termination of service or death.

Notes Receivable from Participants - The Plan document allows participants to borrow, subject to certain restrictions, against their vested account balances. A participant may not borrow less than \$1,000, nor may a participant borrow more than the lesser of \$50,000 or 50% of any participant's current vested interest in his/her account.

Notes are repayable over a specified period not to exceed five years. If, however, notes are to be used for the purchase of a participant's principal residence, the note is payable over a specified period not to exceed 10 years. Participants are allowed only one note at a time, unless one loan is a principal residence loan amortized over a period greater than 5 years. The note will bear interest at a fixed rate on the date the note is granted. Notes are secured by the vested balance in the participant's account and are repaid through payroll deduction.

Forfeited Accounts - Forfeitures are used to reduce future employer contributions of the Plan, in accordance with the Plan's provisions. For the year ended December 31, 2024 forfeitures were used to reduce employer contributions by \$61,198.

Plan Administration Expenses - Expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payments of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

## 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of additions and deductions in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investments - Investments are reported at fair value, except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investment contracts are measured at contract value. Contract value is the amount that participants would receive if they were to initiate permitted transactions under terms of the Plan.

Cash - The Plan considers investments with maturities of three months or less to be cash.

Effective December 29, 2023, the Plan liquidated its investments with Reliance Trust Company. The Plan then transferred the participants funds to Principal on January 2, 2024, which created unallocated, noninterest bearing cash at December 31, 2023.

Net Appreciation or Depreciation in the Fair Value of Investments - The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation or depreciation in the fair value of its investments, which consist of the realized gains and losses from sales of investments and the unrealized appreciation or depreciation on those investments.

Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date.

Notes Receivable from Participants - Notes receivable from participants is measured at their unpaid principal balance plus any accrued but unpaid interest. Defaulted loans are recorded as a deemed distribution based upon the terms of the Plan document.

Payments to Benefits - Benefits are recorded when paid.

### 3. CERTIFIED INFORMATION

Certain information related to cash and investments disclosed in the accompanying financial statements and ERISA required supplemental schedule held at December 31, 2024 and 2023. Notes receivable from participants disclosed in the accompanying financial statements were certified as of December 31, 2023. Net appreciation in fair value of investments was certified for the year ended December 31, 2024. Certifications obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company for 2024 and Reliance Trust Company for 2023, the custodians of the Plan.

### 4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) Topic 820, "Fair Value Measurements and Disclosures", establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.

- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024

The Plan's mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The common collective trusts are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common collective trusts, the issuer reserves the right to require a 30-day notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's pooled separate accounts are valued at the net asset value ("NAV") of units held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probably that the fund will sell the investment for an amount of different from the reported net asset value. Participant transactions (purchase and sales) may occur daily. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to require a 12 month notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**5. GROUP ANNUITY CONTRACT WITH PRINCIPAL LIFE INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net

assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the contract is \$263,019 at December 31, 2024. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

The guaranteed investment contract may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause as defined by the Principal. Upon termination by the Principal, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participant's contract values are not affected.

The average yield earned by the guaranteed investment contract was 4.85% at December 31, 2024.

#### 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTES TO FINANCIAL STATEMENTS

#### 7. TAX STATUS

The non-standardized pre-approved plan from which the Plan was drafted has received a favorable determination from the IRS dated May 27, 2021. The Plan has been amended since receiving its determination letter. The plan administrator believes that the Plan is designed to operate in accordance with all applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan is qualified and that the related trust is exempt from taxation under the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 8. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA at any time. In the event of Plan termination, participants will become fully vested and nonforfeitable and assets will be allocated to each participant based on his/her respective account balance after payment of all liquidation or termination expenses, pursuant to the directors of the plan administrator.

#### 9. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Custodian as defined in the Plan document. Transactions with the Custodian qualify as party-in-interest transactions. Any fees for investment management services are included in net appreciation (depreciation) in fair value of the investments.

#### 10. SUBSEQUENT EVENTS

The plan administrator has evaluated subsequent events in accordance with ASC Topic 855, Subsequent Events, through August 25, 2025, which is the date these financial statements were available to be issued. During their evaluation, the following subsequent events were identified.

Effective July 11, 2025, the following amendments have been made to the Plan:

An amendment was made to change the employer matching contribution to match 50% of the first 4% contributed by the employee for a maximum matching contribution of 2%. The Plan will no longer be a safe harbor plan.

An amendment was made to adjust the Plan's definition of eligible compensation.

TTG Imaging Solutions, LLC has changed its name to TTG Imaging Solutions, LLC DBA Catalyst MedTech.
