**Note 1 – Description of Plan**

The following description of ASNA Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by the Arctic Slope Native Association, Ltd. (Plan Sponsor) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan began October 1, 1993 and was subsequently amended and restated effective January 1, 2022 to include amendments required by the Hardship Distribution provisions of the Bipartisan Budget Act of 2018.

The Plan is administered by the Finance Committee, which consists of certain employees of the Plan Sponsor. John Hancock Life Insurance Company (U.S.A.) (John Hancock) and Variable Annuity Life Insurance Company (VALIC) are the custodians of the Plan.

SECURE Act of 2019, CARES Act of 2020 and SECURE 2.0 Act

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement Act (SECURE Act) was signed into law. It included mandated and optional provisions impacting defined contribution plans. On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into law. It included optional provisions impacting defined contribution plans. On December 29, 2022, the SECURE 2.0 Act was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE Act, CARES Act and SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required. The deadline for adopting plan amendments has been extended, most recently to no later than December 31, 2026.

Eligibility

Prior to January 1, 2022, all employees who were not covered by a collective bargaining agreement, unless specifically provided in the collective bargaining agreement, were eligible to participate in the Plan. With a plan amendment effective January 1, 2022, employees covered by a collective bargaining agreement, leased employees, employees who are contracted as "locums provider", and employees who are nonresident aliens who received no earned income from the Plan Sponsor, which constitutes income from sources within the United States, are not eligible to participate in the Plan.

All other employees are eligible to participate in the Plan. Employees considered eligible to participate in the Plan are admitted to the Plan on their date of hire.

**Note 1 – Description of Plan (Continued)**

Contributions

Participants may elect to contribute 401(k) or Roth contributions up to 100% of pretax or after-tax eligible compensation, as defined by the plan document, subject to certain limitations under the IRC. Eligible participants who have attained age 50 may elect an additional catch up contribution, subject to certain limitations under the IRC.

The Plan Sponsor made a safe harbor nonelective contribution of 3% of gross compensation as defined in the plan document in 2024. Profit sharing contributions may be made at the discretion of the Plan Sponsor. Profit sharing contributions, if any, are allocated to participant accounts based on the total eligible compensation paid to all participants. The Plan Sponsor contributed a discretionary amount equal to 5% of eligible compensation for all eligible employees in 2024.

Participant Accounts

Individual accounts are valued daily and maintained for each of the Plan's participants to reflect the participant's contributions, the Plan Sponsor's contributions, and the participant's share of the Plan's income and expenses. Participants may direct their account balance into any of the investment options allowed under the Plan. Participant accounts are valued daily and participants can change their deferral election percentages each payroll cycle.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans may not exceed five years. The notes bear interest at rates equal to 2% points above the prime rate and is fixed over the life of the note. Principal and interest are paid ratably through periodic payroll deductions.

Vesting

Participants receive full and immediate vesting in their safe harbor nonelective contributions. Participants who achieve normal retirement age, who are deceased, or disabled, provided they are employees at such time, are 100% vested in their accounts. Upon termination of employment, for any reason other than those described above, participants are vested in their account value for the profit sharing contributions based upon completed years of service. A participant is 20% vested in their account value for the profit sharing contributions per completed year of service and 100% vested after five years of completed service. A year of service is a plan year in which a participant works 1,000 hours or more.

Forfeitures

Forfeited nonvested accounts had a balance of \$317,306 and \$358,823 at December 31, 2024 and 2023, respectively, held in the insurance company general account. Forfeitures can be used to reduce administrative expenses or to reduce employer contributions. If a prior participant returns to service before five consecutive one year breaks in service, the participant must repay any amounts distributed that were Plan Sponsor funded in order to reinstate previously forfeited benefits, if any, Forfeitures totaling \$456,846 was used to offset employer contributions in 2024.

Benefit Payments

Amounts credited to an individual participant's account are distributed on termination of employment or when a participant dies or becomes disabled, as a lump sum amount equal to the vested value of their account. Distributions may be deferred until the participant reaches the age of 73 if the value of the distribution is not less than \$1,000. However, the plan agreement stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches the age of 73. Participants hired before January 1, 2017, may be entitled to receive installment or partial distributions.

Participants may be entitled to receive an in-service distribution limited to two per year.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability or an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Revenue sharing income represents contractually agreed amounts from John Hancock expense reduction credits received from funds held by the Plan and is reported as other income.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

Payments of Benefits

Benefits are recorded as distributions when paid.

Administrative Expenses

The Plan permits the payment of Plan expenses to be made from the Plan's assets. Certain transaction fees specifically related to a participant, such as loan set-up fees, are charged to the participant account. All other administrative expenses, such as the quarterly John Hancock administration and participant distribution fees, including auditing and recordkeeping expenses, are paid by the Company and excluded from these financial statements.

Subsequent Events

Management has evaluated subsequent events for disclosure in the financial statements through September 22, 2025, which is the date the financial statements were available to be issued.

**Note 3 – Information Certified by John Hancock and VALIC**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, as permitted under such election, the following information contained in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, was certified by John Hancock and VALIC to be complete and accurate:

- (a) Pooled separate accounts of insurance company, at fair value, and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- (b) Net appreciation in fair value of investments and interest on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024; and
- (c) All information included in Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to un-observable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include –

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts of insurance company.* Valued at their fair value which represents the Plan's proportionate share of the total fair value of the net assets of the underlying mutual funds. In determining the total fair value of the net assets of the investment funds, the issuer has valued investments at the quoted closing net asset value (NAV) per share as reported in active public markets.

In accordance with the fair value measurement guidance, investments in pooled separate accounts that are measured at fair value using the NAV per share (or its equivalent) practical expedient are not required to be classified in the fair value hierarchy. All of the investments held by the Plan at December 31, 2024 and 2023 are pooled separate accounts measured at fair value using the NAV practical expedient and, accordingly, are excluded from the fair value hierarchy.

- a) *Target Risk* –The objective of these portfolios is to provide a diversified mix of stock, bonds, and other investments to create a desired risk profile.
- b) *Aggressive Growth* - The objective of these portfolios is to provide aggressive growth of capital throughout the U.S. and global market.
- c) *Growth* - The objective of these portfolios is to provide growth of capital throughout the U.S., Europe, and the Pacific Basin Plan.
- d) *Other* - The objective of these portfolios is based on the underlying investments and varies between high, long-term total return to conservation of capital, current income and long-term growth of capital and income throughout the U.S. and global market.

**Note 5 –Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Plan’s volume submitter sponsor by an opinion letter dated July 30, 2021, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Pioneer Pension Consulting, LLC which has been adopted by the Plan, is acceptable pursuant to Section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 – Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of investments managed by John Hancock and VALIC, the custodians of the Plan. Therefore, investment transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants also qualify as exempt party-in-interest transactions.

**Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination all account balances become fully vested and all remaining assets in the affected participants' accounts shall be distributed to the participants and beneficiaries of the Plan in the order provided by ERISA.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. The Plan's exposure to a concentration of risk is dependent upon funds selected by participants. The following table shows details on investments that represent a concentration of greater than 10% of the Plan's investments in either year:
