INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
PSG/CIP 401(K) and Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of PSG/CIP 401(K) and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PSG/CIP 401(K) and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of PSG/CIP 401(K) and Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about PSG/CIP 401(K) and Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the PSG/CIP 401(K) and Retirement Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all nonunion employees of Professional Services Group, Inc. (Plan Sponsor) and its affiliated entity, Community Impact Programs, Inc. (CIP), (collectively, the Company) that are age 18 or older. Employees are allowed to defer into the Plan and receive an employer matching contribution after completing six months of service, however one year of service is required for participation in the profit-sharing portion of the Plan. The Plan was most recently restated effective January 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Sponsor is responsible for oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan. Effective June 1, 2023, Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

For each plan year, the Company may contribute a board of directors approved discretionary profit-sharing contribution and discretionary matching contribution to the Plan.

For 2024 and 2023, the approved matching formula was 50% of the first 6% of compensation contributed by participants, which is remitted to the Plan throughout the year along with participant contributions.

For 2024 and 2023, the approved profit-sharing contributions were \$240,663 and \$420,750, respectively. Employees who have completed one year of service and are employed on the last day of the plan year (unless due to death, disability, or retirement at normal retirement age of 65), receive an allocated share of the Company's contribution. Allocations of the Company's contribution are based upon each participant's eligible compensation and their group classification, as defined by the Plan. Profit-sharing contributions are deposited annually after the Plan's year end.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's matching contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service, or upon death or disability.

Notes Receivable from Participants

Participants may borrow from any of their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loan terms may be up to 5 years, unless used for the purchase of a principal residence where the term, effective January 1, 2023, may be up to 10 years. Prior to January 1, 2023, the term could be 15 years. No loan may have a term less than one year and only one outstanding loan is permitted. The loan interest rate is set at 2% above the prime rate, as defined. Principal and interest is paid ratably through regular payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or, effective January 1, 2023, partial lump sum distributions. Prior to January 1, 2023, annual installments over a period not to exceed the participant's life expectancy were permitted. In-service distributions are permitted for participants age 59½ or older who are fully vested, and hardship distributions are permitted under certain circumstances.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23,427 and \$24,896, respectively. These accounts are used to pay administrative expenses of the Plan or to reduce employer contributions. In 2024 and 2023, forfeitures of \$21,798 and \$25,430, respectively, were used to pay administrative expenses, and forfeitures of \$37,121 and \$0, respectively, were used to reduce employer contributions.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment adviser, trustee and custodian. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses was needed as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are reflected in net appreciation in fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

1. Quoted prices for similar assets or liabilities in active markets;
2. Quoted prices for identical or similar assets or liabilities in inactive markets;
3. Inputs other than quoted prices that are observable for the asset or liability;
4. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Demand Deposit Account: FDIC-insured omnibus demand deposit account for qualified retirement plans, providing preservation of capital, liquidity and income, and which pays interest at a variable rate tied to market rates.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – CERTIFICATIONS FROM TRUSTEE AND CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the Plan Administrator has obtained the following information included in the accompanying financial statements and supplemental schedules that was obtained from data that has been prepared and certified to as complete and accurate by Mid Atlantic Trust Company, the custodian of the Plan, as of as of and for the year ended December 31, 2024: investments, investment income, and notes receivable from participants. As of December 31, 2023, investments and notes receivable from participants were certified by Mid Atlantic Trust Company, and investment income for the year ended December 31, 2023 was certified by Mid Atlantic Trust Company from June 1, 2023 to December 31, 2023 and by Associated Trust Company. N.A., the former trustee, from January 1, 2023 to May 31, 2023. All Plan assets were held in trust pursuant to agreements between the Company and the trustee and custodian.

NOTE 5 – RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments in 2023 were managed by Associated Trust Company, N.A. Associated Trust Company, N.A. was the trustee of the Plan and an affiliate was recordkeeper for the Plan, and, therefore, these transactions qualify as party in interest transactions. Transactions in such investments qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

Associated Trust Company, N.A. and its affiliates provided certain administrative services to the Plan. Associated Trust Company, N.A. and its affiliates received revenue from certain mutual fund service providers for services Associated Trust Company, N.A. and its affiliates provided. This revenue was used to offset certain amounts owed to Associated Trust Company, N.A. and its affiliates for its administrative services to the Plan. Fees paid to Associated Trust Company, N.A. and its affiliates were \$38,541 during the year ended December 31, 2023.

July Business Services LLC provides certain administrative services to the Plan. July Business Services LLC receives revenue from certain mutual fund service providers for services July Business Services LLC provides. This revenue was used to offset certain amounts owed to July Business Services LLC for its administrative services to the Plan. Fees paid to July Business Services LLC were \$62,906 and \$18,325 for the year ended December 31, 2024 and 2023, respectively.

HTLF Retirement Plan Services provides fiduciary and investment advisory services to the Plan. Fees paid to HTLF Retirement Plan Services were \$42,230 and \$14,189 for the year ended December 31, 2024 and 2023, respectively.

Notes receivable from participants are also defined by ERISA as party-in-interest transactions.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer profit-sharing contributions.

NOTE 7 – TAX STATUS

The Plan adopted the non-standardized pre-approved profit sharing plan with CODA of July Business Services effective January 1, 2023. Prior to January 1, 2023, the Plan adopted the non-standardized pre-approved profit sharing plan with CODA of Associated Trust Company, N.A. Both of the non-standardized pre-approved profit sharing plans with CODA received opinion letters from the IRS dated June 30, 2020, that the plans were designed in accordance with applicable sections of the Internal Revenue Code (IRC) and were, therefore, not subject to income tax under present tax laws.. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – PROHIBITED TRANSACTIONS

During 2023, the Company failed to timely remit \$132,561 of participant contributions to the Plan pursuant to 29 CFR 2510.3-102 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Under the regulation, amounts paid by a Plan participant or withheld by an employer from a participant's wages for contribution to the Plan are Plan assets on the earliest date they can be reasonably segregated from the Company's general assets, but in no event later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the Company. As a result, the Company had engaged in nonexempt prohibited transactions under ERISA Section 406. The Company deposited lost earnings resulting from the delay in contributions in 2024.

NOTE 10 –SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 6, 2025, the date that the financial statements were available to be issued, and determined that there have been no events that have occurred that would require adjustments or disclosure in the financial statements other than the matter below.

Effective September 1, 2025, the Plan's service provider was changed to Fidelity Investments (Fidelity). In connection with this change, all plan assets were transferred to the custody of Fidelity.
