## Independent Auditors' Report

## 1. Description of Plan

The following description of The York Container Company Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering substantially all employees, as defined in the Plan document, of York Container Company (the "Company" or "Employer") who have completed 90 days of service (3 months effective January 1, 2025) with the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In May 2024, the Plan was amended to allow credit for service completed with the following employers: Standfast Group, LLC, Blackhawk Corrugated, LLC, Champion Container Corporation, and Skybox Packaging, LLC. In April 2025, the following plans were merged into the Plan: StandFast Group, LLC 401(k) Profit Sharing Plan; Champion Container 401(k) Plan; and SkyBox Packaging, LLC 401(k) Plan.

### **Contributions**

Each year, eligible employees may elect to contribute up to 100% of their eligible compensation on a pre-tax or Roth basis, subject to limitations established by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3% of eligible compensation on a pre-tax basis. The deferral rate will increase each year by 1% up to a maximum of 10% of a participant's eligible compensation.

The Company will make a matching contribution of 50% of an employee's elective deferrals up to 6% of a participant's eligible compensation. To be eligible for employer matching contributions, an employee must complete 1 year of service with 1,000 hours of service. For the year ended December 31, 2024, matching contributions were made in the amount of \$693,895. Effective January 1, 2025, the Plan was amended to change the matching contribution to a safe harbor matching contribution of 100% of the first 3% of an employee's eligible compensation contributed to the Plan and 50% of the next 2% of an employee's eligible compensation contributed to the Plan.

The Company may make a discretionary profit sharing contribution for eligible employees equal to a percentage of the employee's eligible compensation. To be eligible for profit sharing contributions, an employee must complete 1,000 hours during the Plan year and be employed as of the last day of the Plan year. Discretionary profit sharing contributions are allocated based on groups as defined in the Plan document. For the year ended December 31, 2024, discretionary profit sharing contributions were made in the amount of \$648,876.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer contributions, (b) Plan earnings (losses) thereon and (c) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. All investments are participant directed.

***Vesting***

A participant is 100% vested in their contributions and actual earnings thereon at all times. Participants are vested in matching contributions and discretionary profit sharing contributions and actual earnings thereon based on the schedule below:

Participants hired prior to May 1, 2012 are 100% vested in their employer matching contributions and discretionary matching contributions and actual earnings thereon at all times.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$90,679 and \$77,942. Forfeitures may be used to pay administrative expenses or reduce future employer contributions. During 2024, \$5,231 was used to pay administrative expenses and \$96,689 was used to reduce employer contributions.

***Revenue Credit Account***

The Plan and Fidelity Management Trust Company ("Fidelity") have entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for either payment of permitted Plan expenses or allocation back to eligible participants of the Plan on a pro rata basis based on the size of their account balances. In order for the Plan to receive credits as a result of this revenue sharing arrangement, the Plan created the Revenue Credit Account under the Plan.

***Revenue Credit Account***

The Revenue Credit Account is a non-participant directed account within the Plan that is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. At December 31, 2024 and 2023, the Revenue Credit Account balance was \$18,235 and \$12,906. During 2024, no revenue credits were used to offset administrative expenses or were allocated back to eligible participants.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. If a participant has a balance less than \$5,000, he or she shall receive a lump-sum amount equal to the value of the participant's vested interest in his or her account without his or her consent. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or after attaining age 59 ½, in accordance with provisions specified in the Plan document.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

**2. Summary of Significant Accounting Policies (continued)**

***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 8, 2025.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

**5. Common/Collective Trust**

Participants have the option to invest in a stable value fund called the Putnam Stable Value Fund (the "Fund"), which was established and is maintained by Putnam Fiduciary Trust Company. The Fund invests in guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions. The Fund also invests up to 75% of its assets in security-backed investment contracts, including separate account products of insurance companies. The Fund strives to maintain at least 5% of its assets in money market instruments, cash, cash equivalents, and stable value funds. The Fund is valued on a daily basis by Putnam Fiduciary Trust Company. Contributions and redemptions to the Fund may be made daily at the current net asset value and are considered as made immediately after the daily valuation. There were no unfunded commitments as of December 31, 2024 and 2023.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate that Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their full account balances.

**7. Income Tax Status**

The Plan's prototype plan document preparer has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has since been amended, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**8. Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan and therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Company, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

**9. Prohibited Transaction**

During the 2024 plan year, the Employer failed to remit to the Plan certain participant contributions amounting to \$185,254 within the period described by the Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Company is in the process of making the necessary corrections to satisfy both the Department of Labor and IRS guidance for the delinquent contributions.

**10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
