- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about ChildNet Youth and Family Services, Inc. 403(b) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of Plan

The following description of ChildNet Youth and Family Services, Inc. 403(b) Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a 403(b) tax-deferred annuity plan covering all eligible employees of ChildNet Youth and Family Services, Inc. (“ChildNet”) except for those who are nonresident aliens with no U.S. source of income, those classified or treated as independent contractors and those considered to be leased employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). ChildNet is the plan sponsor and serves as the plan administrator.

#### Contributions

Participants may elect to contribute a portion of their eligible compensation to the Plan each year. ChildNet, in its sole discretion, may decide to make a discretionary employer contribution, in accordance with formula(s), limit(s), and applicable time period(s) to be determined by ChildNet. Participants will be notified if ChildNet decides to make a discretionary employer contribution for any plan year (or part of a plan year) and the applicable amount of the discretionary employer contribution.

For the years ended December 31, 2024 and 2023, ChildNet made discretionary contributions of \$855,707 and \$779,819, respectively.

#### Participant’s Accounts

Each participant’s account is credited with the participant’s contribution, the allocation of ChildNet’s discretionary employer contribution, and plan earnings. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are fully vested, at all times and in all events, in their salary deferrals and discretionary employer contributions plus actual earnings thereon.

#### Payment of Benefits

In general, upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the fair value of the participant’s account balance or monthly, quarterly, or annual installments over a period of not more than his or her assumed life expectancy (or the participant’s beneficiary’s assumed life expectancy).

**1. Description of Plan, continued**

**Forfeitures**

A participant's non-vested balance is forfeited at the time of termination of employment. Forfeitures may be used to pay plan expenses or reduce any nonelective contribution. No forfeitures were used during 2024.

**2. Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Presentation**

The financial statements of the Plan are reported on the accrual basis of accounting.

**Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4).

**Payment of Benefits**

Benefits are recorded when paid.

**Fair Value Measurements**

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs – quoted prices in active markets for identical assets

Level 2 inputs – quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs – estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relate to the element.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**2. Significant Accounting Policies, continued**

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonably possible, given the level of risk associated with certain investment securities that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

**Reclassifications**

Certain amounts have been reclassified for the year ended December 31, 2023 to conform to the presentation for the year ended December 31, 2024.

**Subsequent Events**

Management has evaluated subsequent events through September 22, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

**3. Information Prepared and Certified by the Custodian**

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year-end (Level 1 inputs). Under the General Account, Participant account balances are credited daily with interest and don't fluctuate with market ups and downs. Participants have daily liquidity at full book value (principal and interest) for all participant-initiated events. A 90-day equity wash applies for transfers to competing funds. The General Account offers competitive interest crediting rates, protection from market volatility, and potential for improved earning power over other types of short-term investments. The General Account guarantees that the interest credited will never fall below the minimum as specified in the contract - at least 1.00% in most states. The General Account is fully portable, which means it can continue to be offered as an investment option based on the administrative capabilities of the new recordkeeper and underwriting approval by Lincoln. The guaranteed interest rate is announced in advance and is guaranteed for a six-month period.

**5. Plan Termination**

Although it has not expressed any intent to do so, ChildNet has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA.

**6. Related Party and Party-in-Interest Transactions**

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$3,850.

The Plan's investment options include funds managed by Fidelity or its affiliates. As custodian and recordkeeper, Fidelity's transactions qualify as exempt parties-in-interest transactions.

**7. Tax Status**

ChildNet's management believes the Plan is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
