## INDEPENDENT AUDITORS' REPORT

To the Trustee of  
Imperial Healthcare 401(K) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Imperial Healthcare 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 8, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 to October 8, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ABC Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 8, 2024 and December 31, 2023, and for the period January 1, 2024 to October 8, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Imperial Healthcare 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan terminated on October 31, 2024, and all assets were transferred to another qualified Plan. As of the termination date, all participants became 100% vested in any and all contributions made under the Plan. Our opinion is not modified with respect to that matter

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Imperial Healthcare 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE 1 - DESCRIPTION OF THE PLAN**

**GENERAL**

Imperial Healthcare 401(K) Plan ("the Plan") is a defined contribution plan covering the employees of Imperial Healthcare (the "Company"). The Plan is subject to applicable provisions of the Employee Retirement Income Security Act of 1974 amended ("ERISA"). A separate account is maintained for each participant. Participants should refer to the Plan document or summary plan description for a more complete description of the Plan's provisions.

On July 1, 2024, the Trustee of the Plan, as permitted by the Plan Document, made a decision to terminate the Imperial Healthcare 401 (k) Plan and to merge existing account balances into a successor plan, Veritas Retirement Plan. By October 8, 2024, assets of \$2,353,162, which included participant loans of \$62,112, were transferred into the Veritas Retirement Plan. In connection with the termination, all participants became fully vested in their employment contributions.

In addition, the Plan changed its custodial services from the Principal Trust Company to Empower Trust Company, LLC, and also changed their investment options effective October 2024.

**ELIGIBILITY**

Employees are eligible for participation in the Plan upon attaining age 21 and completing one year of service. Entry into the Plan is permitted on the first enrollment period after which the employee becomes eligible.

**PARTICIPANT AND EMPLOYER CONTRIBUTIONS**

The Plan provides for employee salary deferrals which are not to exceed the maximum allowable limits under section 401(k) of the Internal Revenue Code (\$23,000 for 2024). In addition, participants are permitted to make after tax Roth 401(k) contributions which are subject to the same pre-tax contribution limitations. Participants who will attain age 50 before the end of the Plan year may contribute an additional \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may decide to make a matching contribution or a non-elective contribution to the Plan, although the Company is not required to make these contributions. Contributions, if made, are subject to certain IRS limitations. Participant's contributions are recorded when withheld from participant's earnings.

**PARTICIPANTS' ACCOUNTS**

Each participant's account is credited with (i) participant's contributions, (ii) employer matching contributions (if any), and (iii) allocations of the Plan earnings based on their specific investments. Each participant's account is charged with an allocation of administrative expenses, if the employer does not pay such expenses, fees and charges. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

**VESTING**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service, and vests 20% after two years of service, and 20% for each year of service thereafter. A participant is 100% vested after six years of credited service, or if terminated due to death, disability, or attainment of age 65.

**FORFEITED ACCOUNTS**

Forfeited non-vested accounts can be used to pay Plan expenses and reduce future Company contributions. At October 8, 2024 and December 2023, there were no forfeited non-vested balances. This account will be used to pay future Plan expenses or reduce future discretionary Company match.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participants' account and bear interest at rates which are commensurate for similar types of loans as determined by the plan administrator. Generally, the term of the loan may not exceed five years (unless the loan proceeds will be used to purchase a principal residence). Principal and interest is paid ratably through monthly payroll deductions.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, or have the payment paid as a direct rollover to an IRA or to another employer's tax qualified plan. If the vested balance is greater than \$5,000, the participant may choose to receive installments, request a partial withdrawal, or defer payments until age 70 1/2.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit. Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded for the period January 1, 2024 to October 8, 2024 and for the year ended December 31, 2023, respectively.

**PAYMENTS OF BENEFITS**

Benefits paid to participants are recorded when paid.

**ADMINISTRATIVE AND OTHER EXPENSES**

Substantially all expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The 3 levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual funds** – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled separate accounts** – Valued at the accumulation unit value, which is based on the value of underlying assets of the account. The accumulation unit value is deemed equivalent to net asset value ("NAV"), which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. In accordance with Subtopic 820-10, investments measured at NAV per share (or is equivalent) are not classified in the fair value hierarchy

**Common Collective Trust** – Units of the fund are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the trustee. The NAV per unit is calculated as of the close of trading on the NYSE. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values.

**NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Principal Life Insurance Company and Principal Trust Company are the trustees for the plan. Administrative fees paid by the Plan to Principal Trust Company amounted to \$44,704 for the period January 1, 2024 to October 8, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, but are exempt from the prohibited transaction rules of ERISA.

The Third-Party Administrator was engaged by the Plan Sponsor to perform compliance testing, and prepare the annual information return. Fees for these services were paid from plan assets.

The Employer provides accounting and administrative services to the Plan for which no fees are charged.

**NOTE 6 – INCOME TAX STATUS**

On August 8, 2014, the Internal Revenue Service (“IRS”) stated in an opinion letter that the Prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 8, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

**NOTE 7 - CONCENTRATIONS**

The Plan holds certain investments that each represents 10% or more of the total net assets held by the Plan. As of October 8, 2024, the Plan held no such investments. As of December 31, 2023, the Plan held four such investments totaling \$1,585,069.

**NOTE 8 – TERMINATION**

The Plan was officially terminated in accordance with Plan Documents. The transfer of all assets was completed in compliance with Internal Revenue Service (IRS) and Department of Labor (DOL) regulations governing such transactions. As a result of the termination, the Plan no longer holds any assets or liabilities as of the termination date. The Plan Administrator took necessary steps to ensure all participants' accounts were properly transferred to the successor plan, and appropriate notices were provided to participants, as required by ERISA. The termination and transfer were executed with no material impact on the participants' accrued benefits.

The effective termination date was October 31, 2024.

**NOTE 9 - VOLUNTARY COMPLIANCE RESOLUTION**

During the period ended October 8, 2024, as reported in the current year Schedule of Delinquent Participant Contributions, the Plan reported a total of \$102,073 in late contributions during the period. The Plan is in the process of taking remedial actions under the Voluntary Compliance Program of the U.S. Department of Labor and is recalculating the amounts needed to correct the affected individual account balances. The amount of lost earnings has not been determined at the date of this report. Plan management believes that this matter will not have a material effect on the Plan's financials statements. Plan management identified this issue and upon discovery remitted the participant contributions into the Plan.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through September 17, 2025 the date the financial statements were available to be issued.
