INDEPENDENT AUDITORS' REPORT

To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hecny America, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hecny America, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the 2024 financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1 - Summary of Significant Plan Provisions

The following description of the Hecny America, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering all eligible employees of Hecny America, Inc. (the "Plan Sponsor"). Employees must have completed three months of employment to be eligible participants. The Plan was established by the Plan Sponsor on January 1, 2000, to provide retirement income for its employees, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA).

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security (CARES) Act was passed by Congress. The CARES Act contains several provisions that temporarily impacted 401(k) plans, including the waiver of required minimum distributions, a new hardship withdrawal option, increased loan limits, and a pause option for loan payments. The provisions of the CARES Act may be effective and operationalized immediately, prior to amending the Plan document. The Company has adopted the new increased amounts in withdrawals and loans, the pause on loan repayments and the temporary waiver required minimum distributions of the CARES Act.

Contributions

The Plan is a contributory plan whereby participants may contribute up to 100% of pre-tax annual compensation; not to exceed the dollar limit set by law of \$23,000 for 2024. Participants age 50 or older may elect to defer additional "catch up" amounts to the Plan up to \$7,500 for 2024. The Plan Sponsor may make discretionary matching contributions to the Plan, based on the pro rata relationship of the amounts deferred for the year. Matching contributions are made solely at the discretion of the Plan Sponsor. The Plan Sponsor elected to contribute 25% of employee contributions up to a maximum of \$2,000 per employee. Total matching contributions for the year ended December 31, 2024 were \$104,127.

Under provisions of the Plan, rollover contributions from a pension or profit sharing plan meeting the requirements of Internal Revenue Code Section 401(a) or any lump sum distribution received by a participant from a pension or profit sharing plan meeting the requirements of Internal Revenue Code Section 401(a) are allowed at the discretion of the Plan Sponsor.

Participant accounts

Each participant's individual account is credited with the participant's contribution and allocations of the Company's contribution and Plan investment earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service as follows:

Investment options

Upon enrollment in the Plan, a participant may direct contributions in any of the accounts offered under the Plan. Participants may change their investment selections at any time.

Notes receivable from participants

Participants may borrow from their fund accounts the lesser of \$50,000 or 50% of their vested account balance. Minimum loan amount is \$1,000 and is treated as notes receivable from participants. Each participant is permitted one outstanding loan at a time. All loans must have a definite repayment period which provides for payments to be made not less frequently than quarterly, and for the loan to be amortized on a level basis over a reasonable period of time, not to exceed 5 years (longer if used to purchase the participant's primary residence). The loans are secured by no more than 50% of the participant's account balance. Loans must bear interest at a rate commensurate with what a bank or other professional lender would charge for making a loan in a similar circumstance. Loans bear an interest rate at 1-2% above the prime rate. For the year ended December 31, 2024 and 2023, the prime rate was 7.50% and 8.50%, respectively. Principal and interest is paid ratably through payroll deductions.

Forfeitures

Forfeiture accounts are first used to reduce Plan expenses and then to reduce future employer contributions. In 2024, Plan expenses and employer contributions were reduced by \$12,515 from forfeited non-vested accounts. As of December 31, 2024 and 2023, there were no forfeitures available.

Payment of benefits

Upon termination of service due to retirement, death, or disability, a participant will receive as benefits either a lump sum amount equal to the value of the account, or installments over a period of not more than the assumed life expectancy of the participant. Benefit payments will be distributed in accordance with the participant's election.

Termination of the Plan

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. The Plan Administrator believes that the estimates used in preparing its financial statements are reasonable and prudent. Actual results could differ from these estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. However, contract value is the relevant measurement attribute for the Guaranteed Interest Account because contract value is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value equals principal balance plus accrued interest.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Except for loan origination fees associated with notes receivable from participants, all administrative expenses of maintaining the Plan are paid by the Company.

Note 3 - Information Certified by the Custodians

The Plan Sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan, and was not subjected to any audit procedures except for comparing such information with the related information included in the financial statements and supplemental schedule:

- a. Investments as of December 31, 2024 and 2023 and supplemental schedule.
- b. Custodian transactions, investment income, notes receivable from participants, and investment transactions for the year ended December 31, 2024.

Note 4 - Party-in-interest Transactions

Certain Plan investments are pooled separate accounts managed by Principal Life Insurance Company (Principal). Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in the accompanying statement of changes in net assets. The Plan Sponsor paid costs of Plan administration of approximately \$3,535, net of forfeitures, on behalf of the Plan as of December 31, 2024.

The Plan is also invested in notes receivables from participants. As a result, these investments and all transactions relating to these investments were with parties-in-interest. These transactions are exempt from being prohibited transactions under ERISA.

Note 5 - Tax Status

The Internal Revenue Service issued its latest determination letter on March 31, 2014, which stated that the Plan and its underlying custodian qualify under Sections 401(a) and 401(k) of the Internal Revenue Code and therefore are exempt from federal income taxes. The Plan has been amended since receiving the determination letter. However, in the opinion of the Plan Administrator, the Plan and the underlying custodian are currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and thus are tax-exempt as of the financial statement date.

Note 6 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled separate accounts: Reported daily based on the valuation method disclosed in the contract and valuation of property market value by an appraiser. Pooled separate accounts are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The Net Asset Value ("NAV") is based on the market value of these underlying investments but is not a publicly quoted price in an active market. Therefore, we believe that these investments have a "Readily Determinable Fair Value". The NAV is calculated in manner consistent with Generally Accepted Accounting Principles ("GAAP") for these types of investments.

Investments mutual funds: Valued at the daily closing price as reported by the fund. Investments held by the Plan are open-end investments that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The investments held by the Plan are deemed to be actively traded.

Guaranteed interest account: Valued at the price the Plan would receive if the account was terminated at the reporting date, which is contract value less an early withdrawal fee. Guaranteed interest contracts are reported at contract value which is the aggregation of contributions, plus interest, less withdrawal, if any. Fair value is considered contract value adjusted to take into account the current rates of interest available in the market place. The contract value did not differ materially from the fair value at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Redemption for all investments, if currently eligible, is daily.
