**NOTE 1 - DESCRIPTION OF PLAN**

The following description of S.P. Richards 401(k) Retirement Plan ("the Plan") provides only general information for the eligible employees of S.P. Richards Company (the "Company"). Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of the company who are not collectively bargained employees, nonresident aliens, or leased employees. Employees may enter the Plan on the first day after meeting the eligibility requirements of two months of service. Upon enrollment, a participant may direct contributions in various investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective September 1, 2023, the Plan was amended and restated to remove the 18 or older minimum age requirement for plan participation, allow Roth deferrals as a contribution type, include fringe benefits, reimbursements, and other allowances as eligible plan compensation, require participants to be employed on the last day of the year to receive an employer discretionary contribution, and to change the trustee from Ascensus Trust Company to Vanguard Fiduciary Trust Company.

Contributions: Participants may contribute up to fifty percent of their pre-tax annual compensation, as voluntary contributions in accordance with the provisions of Section 401(k) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective April 1, 2022, the Plan adopted an automatic enrollment feature whereby eligible participants will be automatically enrolled at a 3% salary deferral rate unless elected otherwise. There is a one percent automatic annual escalation of deferral rates for participants who are automatically enrolled up to a maximum deferral rate of 10%. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Company will also contribute 50% of the first 3% of participant salary deferrals as employer matching contributions. There were no employer discretionary contributions for the year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution, and an allocation of the employer's contribution and plan earnings, and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer's contributions portion of their accounts is based on years of continuous service. A participant is 100 percent vested after two years of credited service.

Forfeited Accounts: Forfeitures are retained in the Plan and may be used to reduce employer contributions. The amount of unallocated forfeitures as of December 31, 2024 and 2023 was \$136,068 and \$54,936, respectively. No forfeitures were used during 2024 to offset employer matching contributions.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates between 4.25% and 9.50%, which are commensurate with local prevailing rates charged at commercial institutions for similar loans at that time. Principal and interest are paid ratably through payroll deductions.

**NOTE 1 - DESCRIPTION OF PLAN** (Continued)

Payment of Benefits: Upon retirement, death, or disability, a participant or beneficiary may elect to receive either a lump sum amount, a direct rollover to an IRA or other qualified plan, or any combination thereof. Payments of benefits will be made as soon as administratively feasible, with participant consent required for balances greater than \$5,000. Participants may also make withdrawals prior to termination after attaining age 59 1/2. In-service hardship withdrawals are permitted as defined in the Plan.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses and certain participant-requested service fees are included in administrative expenses and charged directly to the participant's account.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits: Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 3 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds, a money market fund, and units of collective trust funds managed by Vanguard Fiduciary Trust Company (the "trustee") as of December 31, 2024 and 2023, therefore these are party-in-interest transactions, as are notes receivable from participants. Fees paid by the Plan or participants in the Plan to the trustee and recordkeeper qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 4 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

**NOTE 5 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 7 - INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved plan document which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the prototype basic plan document is designed in accordance with the applicable sections of Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter, however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## NOTE 8 - FAIR VALUE MEASUREMENTS

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that are accessible to the reporting entity at the measurement date.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals); and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable (i.e., supported by little or no market activity) and significant to the fair value measurement that reflect management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as quoted by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Fund:* The fair values of money market fund investments are determined by obtaining quoted prices on national recognized securities exchanges.

*Collective trust funds:* The fair value of participation units held in collective trusts is based on the NAV as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported NAV, with no advance notice requirement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
