Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Smith Trucking Company, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS
FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF PLAN:

The following description of the Smith Trucking Company, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, adopted effective January 1, 2022, is a defined contribution plan covering all employees of Smith Trucking Company, Inc. (the Company or the Employer), who have reached the age of 18 and completed three months of service as defined in the Plan document. Employees become participants of the Plan on the first day of the payroll coinciding with or next following the date on which such service requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Guideline, Inc. (Guideline) serves as the recordkeeper and plan administrator and manages the Plan's assets for the benefit of participants.

Contributions

Participants may make pre-tax and Roth deferrals of up to 100% of eligible compensation, as defined in the Plan document, subject to certain limitations of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute rollovers or amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes automatic enrollment under an Eligible Automatic Contribution Arrangement (EACA). The default deferral rate is 1%, and auto-escalation is not elected. Participants may opt out or change their rate at any time.

The Employer may make discretionary matching contributions which are computed each payroll period with no year-end true-up. The Employer determines the match formula and/or amount each year. Additionally, the Employer may contribute a nonelective match each year; no such match was made for the year ended December 31, 2024.

1. DESCRIPTION OF PLAN (CONTINUED):

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's discretionary matching contribution, the Employer's nonelective matching contribution, and an allocation of Plan earnings. Allocations of earnings are based upon the participant's earnings from participant directed investment account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions and rollover contributions, plus actual earnings thereon. Vesting in the Employer's discretionary matching and nonelective matching contributions, plus earnings thereon, is based on years of continuous service. A participant is credited 20% per year of active service starting with their second year of credited service and is 100% vested after six years of credited service. Participants become 100% vested upon death or total and permanent disability.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance (or as modified as allowed by the Plan document). A participant may have no more than one active loan outstanding at any time. Loan terms are not to exceed five years unless for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate plus 1% on the date the loan is requested. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant, or beneficiary in the case of death, may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Upon termination of employment, the Plan provides for a distribution of funds directly to the participant as soon as administratively feasible following severance of employment. Participants are allowed to make in-service withdrawals from their fully vested account balances upon reaching the age of 59 ½. Participants may make in-service withdrawals from their fully vested rollover account balance at any time. The Plan also permits hardship withdrawals, in accordance with provisions specified in the Plan document.

1. DESCRIPTION OF PLAN (CONTINUED):

Forfeited Accounts

Forfeited, nonvested accounts may be used to pay Plan expenses or reduce future Employer contributions. At December 31, 2024 and 2023, the balance in forfeited non-vested accounts was \$263 and \$-0-, respectively. In 2024, \$6,122 of forfeitures were used to decrease Employer matching contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year the participant contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of participant distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan's management has evaluated subsequent events for adjustment to or disclosure in the Plan's financial statements through October 7, 2025, the date the financial statements were available to be issued. No recordable or disclosable events occurred through this date.

3. FAIR VALUE MEASUREMENTS:

The fair value framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Guideline provides services as the recordkeeper of the Plan. Benefit Trust Company provides services as the custodian of the Plan. These services qualify, as defined by ERISA, as party-in-interest transactions. In addition, the Employer pays certain expenses for the Plan and provides certain accounting and administrative services for which no fees are charged. Therefore, the Employer qualifies as a party-in-interest.

The Plan issues notes to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

7. INCOME TAX STATUS:

The Internal Revenue Service (IRS) has informed the document sponsor by a letter dated September 26, 2024, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA adopted by the Plan was designed in accordance with applicable sections of the IRC. Although the document has been amended since the letter was issued, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC. Therefore, the plan administrator believes the Plan is qualified and is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. CONCENTRATIONS:

Three investments comprised 71% of net assets available for benefits as of December 31, 2024. One investment comprised 19% of net assets available for benefits as of December 31, 2023.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF PLAN:

The following description of the Smith Trucking Company, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, adopted effective January 1, 2022, is a defined contribution plan covering all employees of Smith Trucking Company, Inc. (the Company or the Employer), who have reached the age of 18 and completed three months of service as defined in the Plan document. Employees become participants of the Plan on the first day of the payroll coinciding with or next following the date on which such service requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Guideline, Inc. (Guideline) serves as the recordkeeper and plan administrator and manages the Plan's assets for the benefit of participants.

Contributions

Participants may make pre-tax and Roth deferrals of up to 100% of eligible compensation, as defined in the Plan document, subject to certain limitations of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute rollovers or amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes automatic enrollment under an Eligible Automatic Contribution Arrangement (EACA). The default deferral rate is 1%, and auto-escalation is not elected. Participants may opt out or change their rate at any time.

The Employer may make discretionary matching contributions which are computed each payroll period with no year-end true-up. The Employer determines the match formula and/or amount each year. Additionally, the Employer may contribute a nonelective match each year; no such match was made for the year ended December 31, 2024.

1. DESCRIPTION OF PLAN (CONTINUED):

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's discretionary matching contribution, the Employer's nonelective matching contribution, and an allocation of Plan earnings. Allocations of earnings are based upon the participant's earnings from participant directed investment account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions and rollover contributions, plus actual earnings thereon. Vesting in the Employer's discretionary matching and nonelective matching contributions, plus earnings thereon, is based on years of continuous service. A participant is credited 20% per year of active service starting with their second year of credited service and is 100% vested after six years of credited service. Participants become 100% vested upon death or total and permanent disability.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance (or as modified as allowed by the Plan document). A participant may have no more than one active loan outstanding at any time. Loan terms are not to exceed five years unless for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate plus 1% on the date the loan is requested. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant, or beneficiary in the case of death, may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Upon termination of employment, the Plan provides for a distribution of funds directly to the participant as soon as administratively feasible following severance of employment. Participants are allowed to make in-service withdrawals from their fully vested account balances upon reaching the age of 59 ½. Participants may make in-service withdrawals from their fully vested rollover account balance at any time. The Plan also permits hardship withdrawals, in accordance with provisions specified in the Plan document.

1. DESCRIPTION OF PLAN (CONTINUED):

Forfeited Accounts

Forfeited, nonvested accounts may be used to pay Plan expenses or reduce future Employer contributions. At December 31, 2024 and 2023, the balance in forfeited non-vested accounts was \$263 and \$-0-, respectively. In 2024, \$6,122 of forfeitures were used to decrease Employer matching contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year the participant contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of participant distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan's management has evaluated subsequent events for adjustment to or disclosure in the Plan's financial statements through October 7, 2025, the date the financial statements were available to be issued. No recordable or disclosable events occurred through this date.

3. FAIR VALUE MEASUREMENTS:

The fair value framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. CERTIFIED INVESTMENTS:

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator has elected that information certified by Benefit Trust Company, the custodian, not be subjected to any auditing procedures except for comparing such information to the information contained in the accompanying financial statements and supplemental schedule. 5. TRANSACTIONS WITH PARTIES-IN-INTEREST:

Guideline provides services as the recordkeeper of the Plan. Benefit Trust Company provides services as the custodian of the Plan. These services qualify, as defined by ERISA, as party-in-interest transactions. In addition, the Employer pays certain expenses for the Plan and provides certain accounting and administrative services for which no fees are charged. Therefore, the Employer qualifies as a party-in-interest.

The Plan issues notes to participants, which are secured by the balances in the participants’ accounts. These transactions qualify as party-in-interest transactions.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

7. INCOME TAX STATUS:

The Internal Revenue Service (IRS) has informed the document sponsor by a letter dated September 26, 2024, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA adopted by the Plan was designed in accordance with applicable sections of the IRC. Although the document has been amended since the letter was issued, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC. Therefore, the plan administrator believes the Plan is qualified and is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. CONCENTRATIONS:

Three investments comprised 71% of net assets available for benefits as of December 31, 2024. One investment comprised 19% of net assets available for benefits as of December 31, 2023.
