## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Projects Unlimited, Inc. 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Description of Plan

The following description of the Projects Unlimited, Inc. 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering employees of Projects Unlimited, Inc. (the Company, Employer or Plan sponsor). Employees who have completed three months of service and are at least 18 years of age are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Participant contributions:** Participants may contribute a percent of eligible compensation to the Plan on a pretax basis, up to the annual dollar limit set by the Internal Revenue Service (IRS). Participants are also eligible to designate some or all of their deferral contributions as after-tax contributions (Roth Elective Deferral Contributions).

The Plan provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make a catch-up contribution, subject to IRS limitations.

**Employer contributions:** The Plan allows for matching contributions to be made at the Employer's discretion. The current approved match is equal to 50% of employee deferrals up to a maximum of \$4,000. To be eligible to receive the discretionary matching contribution, participants must be employed as of the last day of the contribution period. The Plan also allows for additional discretionary contributions by the Employer. There was no additional discretionary contribution made by the Employer.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Employer contributions and actual earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** All contributions to the Plan are 100% vested.

**Payment of benefits:** On termination of service due to death, disability, retirement or termination of employment, a participant may receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or partial payments in cash at any time. Participants are allowed to take in-service distributions during employment if older than 59½ or for a hardship, as defined in the Plan document. The minimum hardship withdrawal is \$500.

The Plan allows for automatic payment of a participant's vested balance upon termination, provided that the vested balance is less than \$5,000.

**Rollovers:** The Plan accepts rollovers from a qualified retirement plan of a prior employer with approval from the Plan sponsor.

#### Note 2. Summary of Significant Accounting Policies

**Basis of presentation:** The accompanying financial statements have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board Accounting Standards Codification.

**Contributions:** Participant contributions are recognized when earned. Employer discretionary contributions are recognized on an annual basis.

**Payments of benefits:** Benefits are recorded when paid.

**Administrative expenses:** A significant portion of the Plan's administrative expenses are paid by the Plan sponsor.

**Investments:** The Plan's participant directed investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Capital gain distributions are included in interest and dividend income.

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 7, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified by Fidelity Management Trust Company, the Plan Trustee

The information related to investments that is included throughout the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to these plan assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 4 and the supplemental schedule related to the Plan's assets.

Fidelity Management Trust Company also certified to the completeness and accuracy of \$869,887 of net appreciation in fair value of investments and \$538,147 of interest and dividends related to investments for the year ended December 31, 2024.

#### Note 4. Fair Value Measurements

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair value. That framework provides a fair value that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this standard are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Money market fund:** Valued using amortized cost, which approximates fair value.

**Mutual funds:** Valued at the closing price reported on the active market on which the individual securities are traded.

**Common/collective trust fund:** Valued based on the net asset value (NAV) of units of the common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### Note 5. Party-in-Interest Transactions

Fidelity Management Trust Company (Fidelity) is the trustee and recordkeeper, as defined by the Plan; therefore, transactions with Fidelity qualify as party-in-interest transactions. Certain Plan investments are shares of mutual funds managed by Fidelity. Fees paid by the Plan for management services of these funds, as well as recordkeeping services provided by Fidelity, constitute as party-in-interest transactions.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 7. Income Tax Status**

The Plan has adopted a prototype plan designed by the trustee, Fidelity Management Trust Company. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

#### **Note 8. Risks and Uncertainties**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
