Note 1 - Plan Description

The following description of Los Angeles Dodgers 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Los Angeles Dodgers, LLC; The Los Angeles Dodgers Foundation; American Media Productions, LLC; Guggenheim Baseball Management, L.P.; and Elysian Park Ventures, LLC (collectively, the "Company"). Union employees, leased employees, nonresident alien employees, major league baseball players, and minor league baseball players are not eligible to participate. Participants must complete 500 hours of service in a six-month period, or 1,000 hours of service in a one-year period, to participate in the Plan. There are no age requirements to participate.

Contributions

The Plan provides for elective deferral contributions by participants in an amount that does not exceed the maximum amount allowed under the Internal Revenue Code or 90 percent of participant compensation. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2016 through 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2022, 2023, and 2024 and remitted related lost earnings to the Plan in 2024.

The Company may also contribute a discretionary matching contribution at the option of the plan trustees. In 2024, the discretionary employer match was 100 percent of salary deferrals up to 4 percent of salary.

The Company may also make annual discretionary contributions to the Plan, as approved by the Company's board of directors. There was no such contribution in 2024.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions, the discretionary employer match contribution, and rollover contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

The Company's discretionary contributions, if any, vest according to the following schedule:

Benefit Payments

Distributions are payable upon retirement, death, disability, in-service under various requirements, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their employee deferral accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future employer contributions payable to the Plan or to pay administrative expenses of the Plan or are reallocated to participants.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Security Benefit Life Insurance Company and UMB Bank, n.a. or their affiliates. Security Benefit Life Insurance Company and UMB Bank, n.a. are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Guggenheim Baseball Management, L.P. has a controlling interest in the plan sponsor. The unallocated contract is issued by Security Benefit Life Insurance Company, the assets of which are held in a separate account. The assets of the separate account are managed by Guggenheim Partners Investment Management, LLC under an investment management agreement between Security Benefit Life Insurance Company and Guggenheim Partners Investment Management, LLC.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except as noted below. The unallocated contract is not considered benefit responsive and is presented at fair value. The unallocated contract invests in the general assets of Security Benefit Life Insurance Company (Security Benefit); however, since there are no specific securities in Security Benefit's general account related to this contract and due to the contract terms, including the frequency of the interest rate reset intervals, contract value approximates fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company and are not recorded in the accompanying financial statements. These expenses would be paid by the Plan if not paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

UMB Bank, n.a. and Security Benefit Life Insurance Company hold the Plan's investments and participant notes receivable and execute all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Security Benefit Life Insurance Company and Security Financial Resources, Inc., on behalf of UMB Bank, n.a.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 5 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
