## Report of Independent Auditors

### **Basis for Opinion**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.


Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

#### **Supplemental Schedule Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) (modified cash basis) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. Description of the Plan**

The following description of the Waianae Coast Comprehensive Health Center Pension Trust Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan was established in 1980 by Waianae District Comprehensive Health and Hospital Board, Inc. and Subsidiaries (the “Plan Sponsor”). The Plan is a money purchase pension plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The plan document was amended and restated effective October 1, 2021 to include Elepaio Social Services as a participating employer of the Plan.

Empower Trust Company, LLC (“Empower Trust”), serves as the Plan’s trustee, while both Empower Trust and Empower Annuity Insurance Company of America (“Empower”) have custody of the Plan’s assets.

An employee of the Plan Sponsor (except for on-call physicians and physician assistants) is eligible for participation in the Plan upon completing at least 1,000 hours of service during 12 consecutive months of employment. Employees must be employed by the Plan Sponsor on the last day of the plan year and complete 1,000 hours of service to receive an allocation of employer contributions.

**Contributions**

The Plan Sponsor contributes an amount equal to 5% of compensation for the plan year, as defined in the plan agreement. Contributions by participants, except for rollovers, are not permitted.

**Investments**

Participants direct the investments of their accounts into various investment options offered by the Plan.

**Participant Accounts**

Individual accounts are maintained for each participant. Each participant’s account is credited with an allocation of the Plan Sponsor’s contributions and plan earnings, and charged with benefit payments and an allocation of expenses.

**Vesting**

Participant rollover contributions are always 100% vested. Vesting in the Plan Sponsor’s contributions, plus earnings, is based on years of vesting service as follows:

Participants are immediately vested in their account balances upon reaching the age of 65 (normal retirement age), the later of reaching the age of 55 or completing 10 years of service (early retirement age), or upon termination of employment due to death or disability.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of (1) \$50,000 or (2) 50% of their vested account balance. No more than one loan may be outstanding at any time unless a loan is determined to be in default. Beginning July 22, 2013, if a participant defaulted on a loan in the past, eligibility for a new loan is revoked. Loan terms are generally five years or less, but may be up to 15 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at 1% above the Prime Rate. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Upon termination of employment, death or disability, a participant or designated beneficiary may elect to receive a lump sum payment, installment payment, or annuity based on the value of the participant's vested account balance.

Participants who reach the age of 62 may elect to receive an in-service withdrawal.

#### **Administrative Expenses**

Administrative expenses of the Plan are paid by either the Plan or the Plan Sponsor, as provided in the plan agreement. Certain expenses related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### **Forfeitures**

Termination of employment for reasons other than normal retirement, early retirement, death or disability results in a forfeiture of the non-vested portion of a participant's account balance. Forfeited amounts are used to reduce the Plan Sponsor's contributions to the Plan in the year the forfeiture occurs.

For the year ended December 31, 2024, forfeitures used to reduce the Plan Sponsor's contribution to the Plan amounted to approximately \$88,000. At December 31, 2024 and 2023, forfeited non-vested accounts approximated \$96,000 and \$88,000, respectively.

#### **Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right to terminate the Plan at any time subject to the provisions set forth in ERISA. In the event that the Plan is terminated, all participants will become 100% vested in their accounts.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements are prepared on a modified cash basis of accounting, a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this method, additions to net assets available for benefits, except for certain investment transactions, are recognized when received rather than when earned, and deductions from net assets available for benefits are recognized when paid rather than when incurred.

#### Use of Estimates

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan utilizes various investment instruments that primarily include mutual funds and a group fixed deferred annuity contract. Investments are exposed to various risks such as interest rate risk, credit risk, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

#### Fair Value Measurements

For financial and nonfinancial assets and liabilities reported at fair value, the Plan defines fair value as the price that would be received to sell an asset or paid to transfer a liability in the principal or most advantageous market in an orderly transaction between market participants. The Plan measures fair value using observable and unobservable inputs based on the following hierarchy:

- **Level 1** – Quoted market prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs other than quoted market prices included within Level 1 that are observable for an asset or liability, either directly or indirectly.
- **Level 3** – Unobservable inputs for an asset or liability reflecting the Plan's own assumptions. Level 3 inputs should be used to measure fair value to the extent that observable Level 1 or Level 2 inputs are not available.

#### Investment Valuation

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value).

The fair value of mutual funds is based on quoted market prices, which represent the net asset value of units held by the Plan on the last trading day of the plan year, and is categorized as Level 1 in the fair value hierarchy.

Investments in the self-directed brokerage account consist of interest-bearing cash, cash equivalents, common stock, mutual funds, exchange-traded funds, and U.S. government securities. Interest-bearing cash and cash equivalents are comprised of a certificate of deposit and a government money market fund. Interest-bearing cash and cash equivalents are estimated based on a cost approach with cost approximating fair value. Common stock, mutual funds, and exchange-traded funds are based on quoted market prices on the last trading day of the plan year. Interest bearing cash, cash equivalents, common stock, mutual funds, and exchange-traded funds are categorized as Level 1 in the fair value hierarchy. The fair value of the U.S. government securities is estimated using an income approach based on estimated pricing models with inputs based on comparative investments and is generally categorized as Level 2 in the fair value hierarchy.

The Plan's investment in the group fixed deferred annuity contract qualifies as a fully benefit-responsive investment contract. Therefore, contract value is the relevant measurement attribute for the portion of net assets available for benefits attributable to the group fixed deferred annuity contract. Contract value represents contributions made under the contract, plus interest at the contract rate, less benefit payments and administrative expenses.

Contributions are allocated to the Key Guaranteed Portfolio Fund, a fixed account that is part of the general account of Empower. Participants may direct the withdrawal or transfer of all or a portion of their investments at contract value. Empower is contractually obligated to repay the principal and specified interest guaranteed to the Plan. Therefore, contract value is contingent on the creditworthiness of Empower. The interest crediting rate is reset on a quarterly basis based on a formula agreed upon with the issuer and will never be less than zero.

The Plan or Empower may terminate the group fixed deferred annuity contract with at least 60 days advance written notice to the other party. If the group fixed deferred annuity contract is terminated prior to Empower's recovery of any and all start-up costs incurred, such amounts as well as any and all other outstanding charges and fees, will be recouped as a contract termination charge. The Plan does not intend to terminate its group fixed deferred annuity contract.

The plan administrator continually monitors for the occurrence of certain events that would limit the ability of the Plan to transact at contract value with the issuer. Such events would include the following: (1) amendments to the plan agreement (including complete or partial plan termination or merger with another plan), (2) bankruptcy of the Plan Sponsor or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is probable.

#### **Income Recognition**

The Plan presents in the statement of changes in net assets available for benefits, the net appreciation in fair value of investments, which consists of realized gains and losses and unrealized appreciation or depreciation on those investments.

Purchases and sales of securities are recorded on a settlement date basis. Dividends and interest income are recorded as received.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when the loan is disbursed. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan is reclassified as a distribution based upon the terms of the plan document.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid. At December 31, 2024 and 2023, there were no participant elections to withdraw funds from the Plan that had not been paid.

**Income Taxes**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Subsequent Events**

Management has reviewed all events that have occurred from January 1, 2025 through September 26, 2025, the date that the financial statements were available for issuance, for proper accounting and disclosure in the financial statements.

**5. Federal Income Tax Status**

The Plan is relying upon an advisory letter issued by the Internal Revenue Service (“IRS”) to Empower Trust, under the IRS’s preapproved plan program that the Plan constituted a qualified trust under Section 401(a) of the Internal Revenue Code (“IRC”) and is therefore exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended and restated since receiving the advisory letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

**6. Reconciliation of Financial Statements to Form 5500**

In 2024 and 2023, certain notes receivable from participants became delinquent. The points in time in which delinquent notes receivable from participants are deemed to be distributions are different for financial reporting purposes and the IRC. As a result, net assets available for benefits at December 31, 2024 and 2023 and the increase in net assets available for benefits for the year ended December 31, 2024, as reported in the financial statements, differ from the Form 5500 due to these deemed distributions:
