Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1 - Plan Description

The following description of the RouteOne 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted effective March 1, 2003 by RouteOne, L.L.C. (the "Company") and restated effective July 1, 2022. The Plan is a defined contribution plan covering eligible participants, as defined in the plan document. Employees must not be a part of a union, a non-resident alien, or an intern employee. Employees are enrolled on the first day of the month following their eligibility being met (3 months service). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Trustee and Administration of the Plan

The trustee of the Plan is Fidelity Personal Trust Company, FSB (Fidelity or "Trustee"). The custodian of the Plan is Fidelity Institutional Wealth Services. The recordkeeper of the Plan is Sentinel Benefits & Financial Group. The administrator of the Plan is the Company. The Company has given the Trustee the authority to hold the assets of the Plan and to invest, control, and disburse all assets of the Plan in accordance with the plan document. The board of directors of the Company has appointed the Chief Executive Officer to, and the Chief Executive Officer has delegated to the Chief Financial Officer and Chief Legal and Privacy Officer to, control and manage the operation and administration of the Plan.

Contributions

The Plan provides for salary deferral contributions by participants in the form of pre- and post-tax dollars subject to maximum limitations established by the Internal Revenue Code (IRC). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless the individual elects not to participate in the Plan. For automatically enrolled participants, the Company will withhold 5 percent of eligible compensation for each payroll period, which auto escalates by 1 percent on the first day of each year, to a maximum of 15 percent, unless the participant elects not to auto escalate or if the participant elects a different rate of contribution.

The Plan provides for employer nonelective safe harbor contributions and employer discretionary contributions (new comparability profit sharing).

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are set 1 percentage point above the prime interest rate at the time of borrowing, determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions. Participants may have a maximum of two loans outstanding at one time, and loan terms may not exceed 5 years, unless it is for the purchase of a primary residence, in which case may not exceed 10 years.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings/losses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. The Company's nonelective and discretionary contributions are also vested immediately.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Upon attainment of age 59½, a participant may withdraw any of the funds contributed.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the Plan agreement.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Personal Trust Company or its affiliates. Fidelity Personal Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's HR Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and Trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held, during the year.

See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included as administrative expenses. Delinquent participant loans are reclassified as a distribution based upon the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Personal Trust Company holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan from Sentinel Benefits & Financial Group (the "Recordkeeper"), which is required to be restated every six years to maintain a tax qualified status. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, satisfies applicable provisions of the Internal Revenue Code. The Plan has not individually sought its own determination letter. Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value with the highest priority given to Level 1 and the lowest priority given to Level 3, as described below:

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the funds' underlying net assets less its liabilities. There are no redemption restrictions or unfunded commitments on these investments.

Mutual funds are valued based on quoted market prices reported in active markets.

Short-term investments seek to generate income consistent with the preservation of capital and liquidity. The investments are valued at carrying value, which approximates fair value.
