## **Independent Auditor's Report**

To the Plan Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Century Casino, Inc. 401(k) Savings & Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1 – Description of the Plan

The following description of the Century Casino, Inc. (the “Company”, “Plan Administrator”, or “Plan Sponsor”) 401(k) Savings & Retirement Plan (the “Plan”) provides only general information. Participants and all others should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan, which went into effect March 1, 1998, that is generally available to all employees of the Company and Participating Employers (collectively, the “Employer”) who have completed three months of service. The Plan excludes temporary employees, seasonal employees, J1 Visa Students, and Union Employees from Plumbers and Pipe Fitters Local 396 at Mountaineer. Under the SECURE Act of 2019, certain long-term part-time (“LTPT”) employees became eligible for participant contributions on January 1, 2024, after completing 500 hours of service for three consecutive years. Employees may enter the Plan on the first of the month coincident with or following the date they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

**Plan Amendment.** Effective January 1, 2024, the Plan's eligibility provisions were amended to exclude temporary employees, seasonal employees, J1 Visa Students, and Union Employees from Plumbers and Pipe Fitters Local 396 at Mountaineer.

**Contributions.** The following types of contributions are allowable under the Plan:

- Elective Deferral Contributions – Participants may contribute 1% - 90% of their eligible pre-tax compensation, as defined in the Plan document, each payroll period, subject to limitations. Participants may also contribute a percentage of their after tax compensation and designate it as a Roth deferral contribution. A participant’s total contribution cannot exceed \$23,000 (\$30,500 if 50 or older) in calendar year 2024. The Plan provides for an automatic contribution arrangement (“ACA”) such that an eligible employee without an affirmative election will be auto-enrolled into the Plan and have 3% of their compensation withheld as an elective deferral contribution. Such automatic contribution will be increased 1% annually on January 1 until a 12% deferral percentage is reached. Participants who are auto-enrolled under the ACA can elect a permissible withdrawal within 90 days of their first automatic deferral.
- Discretionary Employer Matching Contributions – The Employer may make matching amounts to eligible participants each payroll period. For the year ended December 31, 2024, the Employer matched 50% on the first 6% of the participant's compensation which was deferred as an elective deferral contribution.
- Discretionary Employer Nonelective Contributions – The Employer may make a discretionary Employer Nonelective contribution to eligible participants. This contribution is allocated to each eligible participant’s account in the ratio that each participant’s compensation bears to the compensation of all eligible participants.
- Rollover Contributions – Certain amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan’s investment funds at the direction of the participants.

### Note 1 – Description of the Plan (continued)

**Participant Accounts.** Each participant's account is increased with the participant's contributions, their share of Plan earnings and an allocation of the Employer's contribution (discretionary matching and discretionary nonelective) and is decreased by the participant's distributions and their share of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options.** Participants may direct their investments into various registered investment companies and common collective trusts.

**Vesting.** Participants are immediately 100% vested in their contributions and discretionary Employer nonelective contributions plus actual earnings thereon. With certain exceptions, vesting in the discretionary Employer matching contributions is based on periods of service and a five periods of service graded vesting schedule. A participant is 100% vested after five periods of service with 20% vesting occurring after the first period of service, and in 20% increments for each period of service thereafter. Employed participants also become 100% vested upon reaching normal retirement age of 65, death, becoming disabled, or upon Plan termination or partial Plan termination.

**Forfeitures.** When certain terminations of participation occur, the non-vested portion of a participant's account represents a forfeiture. Forfeitures can be used to reduce future Employer contributions or can be used to pay administrative expenses of the Plan. During 2024, forfeitures of \$146,928 were used to reduce Employer contributions. As of December 31, 2024 and 2023, unutilized forfeitures totaled \$44,157 and \$41,729, respectively.

**Plan Expense Account.** The Plan maintains a Plan Expense Account ("PEA") that is funded by revenue sharing from ADP, the Plan's service provider. The PEA is used to reduce administrative expenses of the Plan. During 2024, the PEA received \$173,385 in revenue sharing, all of which was used to reduce administrative expenses of the Plan. As of December 31, 2024 and 2023, the balance in the PEA totaled \$80 and \$61, respectively.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms range from 1 month up to a maximum of 5 years (30 years if used for the purchase of a principal residence). The loans are secured by the balance in the participant's account and bear a rate of interest equal to the Prime Rate plus 1% at the date the loan is granted. Principal and interest payments are paid ratably through payroll deductions.

**Payment of Benefits.** Benefits to participants or beneficiaries generally are payable as a lump sum, installments, or partial withdrawals equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Participants may also elect to rollover their vested account balance into an IRA or another qualified plan. Additionally, participants may request in-service withdrawals of their rollover contributions account, upon attainment of age 59½, for a qualified reservist distribution, for a deemed severance of employment, or upon incurring a financial hardship, as defined in the Plan Document, if certain criteria are met.

### Note 2 – Summary of Significant Accounting Policies

**Basis of Accounting and Use of Estimates.** The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions.** Participant contributions and the related Employer matching contribution are recognized in the period in which participant contributions are withheld from compensation.

**Benefits Payments.** Benefits are recorded when paid.

**Administrative Expenses and Revenue Sharing.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are recordkeeping charges, trustee, and other expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

The Plan receives revenue sharing from ADP, the Plan's service provider, which is used to reduce administrative expenses of the Plan. During 2024, total administrative expenses and revenue sharing netted to \$270,057, which consisted of \$443,442 in administrative fees and \$173,385 in revenue sharing.

### Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Registered investment companies ("RICs") are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end; and
- Common collective trusts are valued at the NAV of units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell their investments for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or a partial Plan termination, affected participants will become 100% vested in their accounts.

### Note 7 – Tax Status

The Plan Sponsor has adopted an ADP, LLC Non-Standardized Pre-Approved Profit Sharing Plan (“pre-approved plan”). The pre-approved plan received an opinion letter from the IRS on October 6, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the IRC. Although the pre-approved plan and Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 8 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

The Plan's trustee, Reliance Trust Company; the Plan's third-party administrator, ADP; the Plan's investment advisor; the Plan's auditors; the Employer; and Plan participants are all parties-in-interest to the Plan. Additionally, the Plan maintains notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

### Note 9 – Concentrations, Risks and Uncertainties

The Plan provides for various investment options in registered investment companies and common collective trusts. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there were three and four investments, respectively, which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

### Note 10 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.
