INDEPENDENT AUDITORS' REPORT

To Those Charged with Governance of the
Hermeus 401(k) & Profit Share Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Hermeus 401(k) & Profit Share Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to the Financial Statements As of December 31, 2024 and 2023 and For the Year Ended December 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Hermeus 401(k) & Profit Share Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which was established on January 1, 2023 by Hermeus Corporation (the Company) who serves as the Plan Sponsor. The Plan covers all employees of the Company, other than union employees, nonresident aliens, and residents of Puerto Rico, who are excluded from the Plan eligibility requirements. There is no age requirement to be eligible to participate in the Plan. An employee must complete one month of service to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions

Participants may contribute up to 90% of their gross compensation on a pre-tax or Roth basis, as defined by the Plan, not to exceed the maximum allowable contribution limit under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024.

The Plan has an automatic enrollment provision whereby an eligible employee will be automatically enrolled to contribute to the Plan 3% of their gross compensation on a pre-tax basis unless they elect not to contribute or elect a different deferral percentage. Automatic enrollment contributions are contributed to an appropriate target date fund, unless the participant elects a different fund within the Plan. This percentage increases annually on the date of enrollment for each participant in 1% increments, up to a maximum of 15%.

Participants are also permitted to make rollover contributions to the Plan.

Company Contributions

The Plan allows for a discretionary matching contribution to employees that is determined annually. All employees who are eligible to participate and make elective deferrals into the Plan and are employed by the Company on the last day of the Plan year are eligible to receive Company matching contributions. There were no discretionary matching contributions for the year ended December 31, 2024.

The Plan allows for a nonelective matching contribution to employees that is determined annually. All employees who are eligible to participate and make elective deferrals into the Plan and are employed by the Company on the last day of the Plan year are eligible to receive Company nonelective matching contributions. Nonelective matching contributions are calculated in the same ratio as each Participant's compensation bears to the total of such compensation of all participants. There were no nonelective matching contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contributions and Company contributions in accordance with the investment options selected by the participants. Plan earnings, gains, losses, administrative expenses are allocated to each participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$500 and only one note may be outstanding at any given time. The notes are collateralized by a participant's vested account balance. Note repayments are to be made through after-tax payroll deductions each pay period with interest based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes for reason of a primary residence purchase may permit a longer repayment term up to 30 years.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Company matching contributions and employer nonelective contributions vest in accordance with the following table:

Upon retirement, death, or disability, participants become 100% vested in their Company contributions.

Payment of Benefits

Upon termination of service due to death, disability, normal retirement age (age 65), or attainment of age 59 ½, a participant or his or her beneficiary, in the event of death, is entitled to a distribution of their vested account balance. Distributions from the Plan are payable in the form of a lump sum, substantially equal installments, or partial withdrawals with a minimum of \$500. Upon termination, if a participant's account balance is less than \$7,000, the Plan administrator may elect to automatically distribute the participant's account balance. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½. Distributions are subject to the applicable provisions of the Plan agreement. There was no net assets of the Plan allocated to the accounts of participants who had elected to withdraw from the Plan that had not received such distributions as of December 31, 2024.

Forfeitures

Forfeitures result from the non-vested portions of accounts of participants who terminate prior to being fully vested and are used to reduce future Company contributions to the Plan or pay administrative expenses. As of and for the year ended December 31, 2024, there were no forfeitures used or available to offset future Company contributions or pay administrative expenses.

Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid by the Trustee with assets of the Plan unless the Company, at its discretion, elects to pay them. During the year ended December 31, 2024, the Company paid a portion of direct expenses related to the Plan's operations. The Plan paid direct expenses totaling \$26,274 during the year ended December 31, 2024. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and changes therein at the date of the financial statements and reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that, in general, are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

Accounting Standards Codification, *Fair Value Measurement* (ASC 820), defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests in registered investment companies: Valued at the closing price reported on the active market on which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used on December 31, 2024.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes become due immediately upon termination of a participant's employment. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through September 17, 2025, the date the financial statements were available to be issued and determined that there were no material subsequent events that warranted disclosure.

3. INVESTMENTS

All investment information contained in the accompanying financial statements and supplemental schedule, including assets held as of December 31, 2024, and interest and dividend income and net realized and unrealized appreciation in the fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows participants to take loans against their vested account balances. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

6. INCOME TAX STATUS

The Plan adopted a pre-approved plan document, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, these provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits in progress for any open periods.
