Basis for Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Braun Corporation Profit Sharing and 401(k) Plan's ability to continue as a going concern for one year after the date of the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures related to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of Assets Held for Investment Purposes at End of Year as of the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that they agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other

additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of The Braun Corporation Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of The Braun Corporation (the Company) who have one year of service and are age twenty-one or older. As of January 2, 2010, for the pretax and match contributions, employees are eligible after 2 months of service. As of January 1, 2017, the plan is a safe harbor 401(k) plan. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA). Employees who have met the Plan's eligibility requirements will enter the Plan on the first day of each month.

Contributions: Five types of contributions are permitted under the Plan.

First, each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The maximum amount is \$23,000 and \$22,500 for the calendar years 2024 and 2023, respectively. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. The maximum amount for catch-up contributions is \$7,500 and \$7,500 for 2024 and 2023, respectively. The Plan includes an automatic deferral provision whereby 5 percent of compensation is automatically deducted and invested on behalf of participant unless the participant elects a different percentage including zero. The Plan allows after tax (Roth) deferrals by participants.

Second, the employer will make a matching contribution to each eligible participant equal to 100% employee deferral that does not exceed 5% of employee compensation. Matching contributions are made on a per payroll period basis with a "true up" at the end of the year. For the plan year ended December 2024 the match was 100% up to 5%.

Third, the employer may make a profit-sharing contribution to each eligible participant. The profit-sharing contribution is a discretionary amount to be determined each plan year. The employer made contributions of \$-0- for the plan year ended December 31, 2024.

Fourth and fifth, the Employer may elect to make Qualified Non-Elective Matching or Qualified Profit-Sharing Contributions on behalf of all participants who are non-highly compensated employees, to the extent necessary to satisfy the anti-discrimination tests of IRC Sections 401(k) or 401(m). No contributions of this type were made to the Plan for the plan year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocation of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Forfeitures: Upon a participant's termination and the payment of any vested amount, the portion of a participant's account balance which is not fully vested will be forfeited. Forfeitures can be applied to pay the recordkeeping administrative expenses of the Plan if so, directed by the Plan Administrator. Any amounts not used to pay administrative expenses will be applied to the employer's match or non-elective match. On December 31, 2024, forfeited non-vested accounts totaled \$24,334.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Plan participants' vesting is based upon years of vesting service. Participants are credited with a year of vesting service for each plan year during which they complete 1,000 or more hours of service. Participants are immediately vested in their contributions and the safe harbor match plus actual earnings thereon. Vesting in employer's match above the safe harbor is at a 4-year grade. While vesting in the employer nonelective contributions is a 6-year grade. The vesting schedule is as follows:

Distributions: A participant's account balance may be distributed prior to the earlier of the participant's retirement, death, disability, separation from service, attainment of age 59 ½, or, in the case of financial hardship. Distributions are allowed at any age for any reason provided the withdrawal may not include amounts allocated to the account within two years prior to the withdrawal, unless the participant has completed five years of participation in the plan.

A distribution may be made available on account of hardship only if the distribution is made on account of an immediate and heavy financial need. The following expenses will be deemed to be an immediate and heavy financial need:

Certain medical expenses incurred by the participant, the participant's spouse, or any dependents of the participant.

The purchase (excluding mortgage payments) of a principal residence for the participant.

The payment of tuition for the next semester or quarter of post-secondary education for the participant, his or her spouse, children, or dependents.

The need to prevent the eviction of the participant from his principal residence or foreclosure on the mortgage of the participant's principal residence.

Any other deemed immediate and heavy financial need promulgated by the Commissioner of Internal Revenue.

A distribution will not be treated as necessary to satisfy an immediate and financial need of an employee to the extent the amount of the distribution is not in excess of the amount required to relieve the financial need and provided that it cannot be satisfied from other sources.

Benefit Payment: The distribution methods include:

A lump-sum.

Periodic payments of substantially equal amounts for a specific number of years, but not in excess of the life expectancy of the participant and the participant's beneficiary.

Direct rollover of account balance to another qualified plan.

However, if a participant's vested account balance is \$5,000 or less, without regard to the portion of the account balance attributed to rollovers, the Plan administrator will direct the trustee to pay this account balance in the form of a lump sum to the participant.

Note Receivable from Participants: The Plan provides that participants may borrow funds against their account balances limited to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25%- 9.5%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Investment Options: Each participant may direct their contributions into any of the investment options available under the Plan.

Trustee: As of April 1, 2017, Reliance Trust Company is the Plan's Trustee and Custodian of the Plan's assets. Previous to that time Deutsche Trust Company was the Plan's Trustee and Custodian of the Plan's assets.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting, which is in accordance with generally accepted accounting principles in the United States of America.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition: Investments are stated at fair value. If available, quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the plan at year end. Participant loans are valued at amortized cost, which represents fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Net Appreciation (Depreciation) of Investments: In accordance with the policy of stating investments at fair market value, net unrealized appreciation or depreciation for the year is reflected in the statement of changes in net assets available for benefits.

Note Receivable from Participants: Note receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits: Benefits are recorded when paid.

NOTE 3 - INVESTMENTS - UNAUDITED INFORMATION

The Plan's investments were held in trust and administered by the Trustee. All investment information presented in accompanying financial statements and supplemental schedules, including investments held and net appreciation/depreciation in fair value of investments and interest and dividends, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

NOTE 5 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices available for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024, and 2023.

Mutual Funds are public investment securities valued using the Net Asset Value based on the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The net asset value is quoted in active markets.

NOTE 6 - RELATED PARTY TRANSACTIONS and PARTY IN INTEREST TRANSACTIONS

Certain professional fees for the administration of the Plan were paid by the Employer. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 - TAX STATUS

Effective August 1, 2022, the plan document was restated for recent law changes. The Plan sponsor adopted the restated version of the Standardized Prototype Plan Document. The Internal Revenue Service has determined and informed the prototype plan sponsor, by a letter dated October 16, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Plans that adopt prototype documents are not required to file for an individual determination letter. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan sponsor believes that the Plan continues to qualify and operate as designed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to tax examinations for years prior to 2019.

NOTE 9 - RISKS and UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - TERMINATED PARTICIPANTS

Included in net assets available for benefits are amounts allocated to individuals who have elected to withdraw from the Plan but have not been paid. On December 31, 2024, and 2023, there were no benefits payable to participants who are eligible to receive a distribution from the Plan, but who have not yet been paid.

NOTE 11 - SUBSEQUENT EVENTS

The Plan has evaluated events occurring after the statement of financial position through September 19, 2025, the date of the financial statements was available to be issued. Management is not aware of any subsequent events which would require recognition or disclosure in the accompanying financial statements.
