

NOTE 1 – DESCRIPTION OF PLAN

Camp Roofing, Ltd. 401(k) Profit Sharing Plan (the Plan) is a qualified retirement plan adopted by Camp Roofing, Ltd. (the Company), to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was originally effective on April 1, 2007 and has been amended and restated since the original adoption. The Plan was most recently amended effective March 1, 2024. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the legal plan document and trust agreement for a more complete description of the Plan's provisions.

Eligibility: All non-excluded employees of the Company who have attained age 21 and completed two months of service are eligible to participate in the Plan. The Plan's entry date is the first day of the month coinciding with or next following the date an employee satisfies the eligibility requirements.

Contributions: Participants may elect to reduce their compensation by a specific percentage (up to 90%) or dollar amount and have that amount contributed to the Plan on a pre-tax basis as a salary deferral, not to exceed the dollar limit set by law. Participants who are at least age 50 or will attain age 50 before the end of the calendar year may also make catch-up contributions to the Plan. Participants may revoke their salary deferral election at any time during the Plan year and may make any other modification as of each payroll period.

The Company may make a discretionary matching contribution equal to a uniform percentage of participants' salary deferrals. Each year, the Company will determine the amount of the discretionary percentage. Effective September 1, 2023, employer match contributions to all eligible participants shall be equal to 50% of the first 6% of the participant's eligible compensation.

The Company may also make a discretionary profit-sharing contribution to the Plan. In order to share in the profit-sharing contribution for the Plan year, a participant must satisfy certain conditions. For 2024, the Company elected to not make any profit-sharing contributions.

Participants are permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs, as a rollover contribution.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are always 100% vested in their salary deferral contributions, including catch-up contributions and rollover contributions. Vesting in employer contributions is based on years of service. Participants become 100% vested after four years of credited service.

Payment of Benefits: Upon termination of employment, normal retirement, disability, or death, a participant (or designated beneficiary) may elect to receive their vested interest in the Plan as a single lump-sum payment in cash, a direct rollover distribution, or a combination of both. If a participant's vested account balance does not exceed \$5,000, then a distribution will be made to the participant as soon as administratively feasible, in a single lump-sum payment. If a participant's vested account balance exceeds \$5,000, they must consent to any distribution before it may be made.

Participants who have attained age 59 ½ may receive an in-service distribution from certain accounts. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Forfeitures: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan as a forfeiture. The Company may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12 and \$11, respectively. During 2024, \$34,293 of forfeitures were used to offset employer matching contributions.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant account will become 100% vested. The Company will direct the distribution of participant accounts in a manner permitted by the Plan as soon as practicable.

Administration Expenses: The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan. There are certain other expenses that may be paid just from a participant's account. These are expenses that are specifically incurred by, or attributable to, a participant.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 6, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025, the name of the Plan's trustee was updated to ADP Retirement Trust Services, LLC.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks resulting from the effects of global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

NOTE 5 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated October 6, 2020 indicating that the pre-approved non-standardized plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original pre-approved non-standardized plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
