#### (1) Description of the Plan

The following description of the Access Bio 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

##### *a) General*

The Plan is a defined contribution plan covering all employees of Access Bio, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information certified by the Trustee, as complete and accurate, except for comparing the information certified by the Trustee to information included in the financial statements.

##### *b) Eligibility*

Employees are eligible to participate in the Plan upon completing three months of service and attainment of age 21.

##### *c) Contributions*

Eligible employees may elect to defer, not less than 1%, but up to 90% of employees’ compensation each year instead of receiving that amount in cash. However, employee total deferrals in any taxable year may not exceed a dollar limit by the Plan, and subject to Internal Revenue Code (the Code) limitations on deferral contributions of \$23,000 for 2024. Participants age 50 or older may elect to defer additional amounts to the Plan up to the legal annual maximum set by the IRS, which was \$7,500 in 2024. Catch-up contributions designated as pre-tax deferrals are eligible for employer matching contributions.

The Company makes a safe harbor matching contribution equal to 100% of deferrals that do not exceed 6% of employees’ compensation. This safe harbor matching contribution is subject to a vesting schedule.

The Company also may make discretionary profit-sharing contribution to the Plan. For the year ended December 31, 2024, no discretionary profit-sharing contributions were made by the Company.

##### *d) Participant Accounts*

Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions and the Company matching contributions, as well as allocations of the Plan’s earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings,

account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***e) Investments***

Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching contributions are automatically invested in the same funds as the participant contributions.

#### ***f) Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's safe harbor matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after two years of credited service. Participants are always 100% vested in their qualified safe harbor matching contributions if they are employed on or after their normal retirement age, 65, or if participants die or become disable.

#### ***g) Forfeited Accounts***

In the event a participant terminates employment prior to satisfying 100% vesting, the portion of employer contributions, which is not vested, is forfeited at that time. Forfeited contributions are used to reduce future employer contribution or to pay administrative expense under the Plan, which would otherwise be paid by the Company.

At December 31, 2024 and December 31, 2023, there were forfeited non-vested accounts of \$10 and \$10, respectively. \$30,655 of forfeitures were used to reduce employer contribution during the year ended December 31, 2024.

#### ***h) Payment of Benefits***

On termination of services due to death, disability, severance from employment, or retirement, a participant may elect to receive a distribution amount equal to the value of the participant's vested interest in his or her account. If the vested account balance is more than \$1,000, a participant may elect to receive a distribution in:

- A single lump-sum payment in cash
- Installments over a period of not more than his or her assumed life expectancy (or the assumed life expectancies of participant and participant's beneficiary)

In times of financial hardship, the funds in the participant's account are available for withdrawal if a condition is satisfied in terms of emergent medical care, principal for a residence, and educational fees. Such withdrawals are subject to tax as ordinary income.

#### ***i) Notes Receivable from Participants***

Participants may borrow from their fund accounts up to a maximum equal to \$50,000 or 50% of participant's vested interest in the plan and no less than \$1,000. The loans are secured by the balance in the participant's account and bear interest rate at 1% above prime rate (as specified in the Wall Street Journal), which is fixed at the time of the loan.

Loans are to be paid in no later than five years, except for loans made for the purchase of a principal residence in which case the term of the loan can be extended to thirty years.

#### (2) Summary of Significant Accounting Policies

##### *a) Basis of Accounting*

The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

##### *b) Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *c) Investment Valuation and Income Recognition*

The Plan’s investments are stated at fair value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end, which are based on quoted market values. Shares of common and collective funds are valued based on the value of the underlying assets of the fund as determined by the fund manager.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### *d) Net Appreciation (Depreciation) in Fair Value of Investments*

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

##### *e) Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

##### *f) Payment of Benefits*

Benefits are recorded when paid.

##### *g) Administrative Expenses*

The Plan’s expenses are paid by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets

available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

### (3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) Topic 820, “Fair Value Measurements and Disclosures”, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that requires assets and liabilities measured at fair value to be categorized into one of the three levels based on the priority of inputs used in the valuation. Assets and liabilities are classified in their entirety based on the lowest level of input significant to the fair value measurement. The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset’s and liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value pursuant to the fair value hierarchy:

*Mutual funds*: Valued at the net asset value (NAV) of shares held by the Plan at year end. The value is based on the quoted market prices of the underlying shares owned by the fund, minus its liabilities, then divided by the number of shares outstanding.

*Common/collective trusts*: Valued at the net asset value (NAV) per share/unit reported at the close of business every day. Shares/units in common/collective trusts can be redeemed daily on demand. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(4) Federal Income Tax Status**

The Company adopted a pre-approved plan document that has received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 06, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by US taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**(5) Related Party and Party-in-Interest Transactions**

ADP, Inc. serves as a recordkeeper. Fees paid by the Plan to ADP, Inc. for certain recordkeeping and administrative services for the year ended December 31, 2024, amounted to \$2,805.

#### (6) Concentrations of Credit Risks

The Plan's exposure to a concentration of credit risk is limited by diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are generally diversified into various financial instruments.

#### (7) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### (8) Information Certified by Trustee

The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Reliance Trust Company, the trustee of the Plan as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024. No auditing procedures were performed by the independent public accountants as permitted by 29CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by the trustee, except for comparing such information with the related information included in the financial statements and supplementary schedule.

The trustee holds the Plan's investment assets and execute investment transactions. The plan administrator obtained certifications from the trustee as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, that the information provided to the plan administrator by the trustee is complete and accurate.
