NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Guiding Light Autism Academy Inc 401(k) Profit Sharing ADP Plan #427063 (the “Plan”) provides only general information.

Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution retirement plan covering all eligible employees of Guiding Light Academy, Inc, the “Sponsor”. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA”).

Contributions

Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) fixed and matching contributions made by the Sponsor and (iii) rollovers from participants from another qualified plan.

Participants may elect to deposit up to 75% of their pretax annual compensation, as defined in the Plan document, up to a maximum contribution as prescribed by law. The maximum contribution for 2024 was \$23,000. Participants who have attained age 50 before the end of the Plan year eligible to make catch-up contributions of \$7,500. Participants direct the investment of their contributions and Sponsor contributions into various investment options offered by the Plan. The Plan offers various registered investment companies, an insurance company general account contract, and a pooled separate account as investment options for participants.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Sponsor’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Plan loans

Plan loans are issued as separate contracts by ADP Inc's Retirement Services System as contemplated under Internal Revenue Code ("IRC") Section 72(p)(5) and do not represent Plan assets. Loans are collateralized using a participant's ADP Inc's Retirement Services System account balance in an amount equal to 100% of the outstanding loan balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the less of \$50,000 or 50% of his or her ADP's Inc's Retirement Services System account balance, subject to Plan provisions. Loan terms range from one to five years in one-year increments (up to 10 years for the purchase of the participant's primary residence). Principal and interest are paid ratably by the participant to ADP Inc's Retirement Services System, and each payment reduces amounts collateralized by the borrowing participant's ADP Inc's Retirement Services System account balance. Plan loan balances outstanding from participants to ADP Inc's Retirement Services System were \$48,805 as of December 31, 2024.

Vesting

Participants with an hour or more of service on or after January 1, 2014 are immediately vested in their voluntary contributions, rollovers from other qualified plans, the Sponsor's fixed and matching contributions, plus actual earnings thereon.

Participant distributions

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or an alternate method of payment depending upon the participant's election as prescribed by the Plan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements were prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan’s investments in registered investment companies and pooled separate accounts are stated at fair value. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid to participants.

Administrative expenses

Expenses of the Plan, to the extent that the Sponsor does not pay such expenses, may be paid out of the assets of the Plan provided that such payment is consistent with ERISA. Administrative expenses of the Plan, such as accounting and legal fees, are paid by the Sponsor.

Subsequent events

In accordance with Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 855, Subsequent Events, the Plan’s management has evaluated subsequent events through October 6, 2025, the date on which these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

NOTE 3. EXCLUSION OF ASSETS

None – All assets were accounted for.

NOTE 4. FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurement, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy give the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

We have relied on the Plan administrator by ADP Inc’s Retirement Services System to be complete and accurate.

NOTE 5. INFORMATION CERTIFIED BY THE PLAN ADMINISTRATOR

The Plan administrator by ADP’s Inc’s Retirement Services System has certified the proper valuations for the Plan.

NOTE 6. INVESTMENT CONTRACT WITH ADP INC.

The Plan administrator by ADP Inc’s Retirement Services System is fully responsive for all investments of the plan.

NOTE 7. PARTY-IN-INTEREST TRANSACTIONS

Fees paid by the Plan for investment management services are included in the net appreciation (depreciation) in fair value of investments.

NOTE 8. TAX STATUS

Currently, 401(K) plans are not required to submit plans to the Internal Revenue Service (“IRS”) for determination. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) of the IRC and is exempt from federal income taxes under Section 501(a) of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
