A. DESCRIPTION OF PLAN

The following description of the Seres Engineering 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General The Plan was established effective April 1, 2010 and is subject to the provisions of Internal Revenue Code (the Code) section 401(k) and the Employee Retirement Income Security Act of 1974 (ERISA). In general, all employees of Seres Engineering & Services, LLC (the Sponsor) are eligible to participate in the Plan. Certain employees, such as nonresident aliens and Puerto Rico residents, are excluded from participation.

Contributions Eligible employees (Participants) may elect to make contributions up to the maximum amount allowed by the Code, including catch-up contributions. Participants may also contribute amounts distributed from other qualified plans (rollover contributions). The Plan Sponsor is required to make a safe harbor matching contribution of 100% of each participant's salary deferrals up to the first 4% of the participant's eligible compensation. Contributions are subject to certain limitations.

Participant Accounts Each Participant's account is credited with the Participant's contribution, allocations of the Sponsor's contribution, and plan earnings and charged with an allocation of administrative expenses. Allocations are based on Participant earnings or account balances. Participant benefits are limited to the Participant's vested account balance.

Vesting Participants are immediately vested in their contributions and sponsor safe harbor matching contributions plus actual earnings thereon. Participants become 100% vested in any Sponsor profit sharing contribution portion of their accounts plus actual earnings thereon after three years of credited service.

Notes Receivable from Participants Participants may borrow from their accounts up to the lesser of \$50,000 or one-half of their vested account balance. Participants may only have one outstanding note at any given time. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined appropriate by the plan administrator. The notes have a maximum term of five years, unless the note is used for the purchase or construction of a primary residence. Principal and interest are paid ratably through automatic payroll deductions.

Investment Options Plan contributions are invested, at the direction of the participant, in any of the funding vehicles offered by the Plan.

Benefit Payments On termination of service due to death, disability or retirement, a Participant may elect to receive a lump-sum amount equal to the value of the Participant's vested interest in his or her account or partial payment options as provided by the Plan. Hardship withdrawals, as defined in the Plan, are permitted from participant deferral contributions. In-service distributions are permitted for participants age 59.5 or older.

A. DESCRIPTION OF PLAN (Continued)

Forfeitures At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$3,051 and \$2,917, respectively. These accounts will be used to offset future Sponsor contributions.

Operating Expenses Certain expenses of maintaining the Plan are paid by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

B. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The Plan financial statements and supplemental schedules are presented using the accrual method of accounting.

Investment contracts held by a defined contribution plan are generally reported at fair value. However, an exception exists for reporting fully benefit-responsive investments which are reported at contract value because the amount a Participant would normally receive in a transfer or distribution is contract value. Contract value represents contributions made under the contracts plus earnings, less Participant withdrawals and administrative expenses.

Investment Valuation and Income Recognition Investments are reported at fair value, except for any fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Loans in default are recorded as benefit payments in accordance with the terms of the Plan document.

Use of Estimates The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits Benefits are recorded when paid.

C. FAIR VALUE MEASUREMENTS

Certain Plan investments are reported at fair value. ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Level 1 Fair Value Measurements The fair values of registered investment companies are based on the closing price reported on the active market where the individual securities are traded. The fair values of common investment trusts are based on net asset value (NAV), which are determinable, published, and serve as the basis for current transactions.

There have been no changes in the methodologies used to determine fair value during the years ended December 31, 2024 and 2023.

E. RELATED PARTY TRANSACTIONS AND TRANSFERS

Certain Plan investments are managed by Reliance Trust Company, a Plan trustee, or by entities related to Reliance Trust Company. Accordingly, these transactions qualify as party-in-interest transactions and are exempt from prohibited transactions rules.

F. PLAN TERMINATION

Although the Sponsor has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

G. TAX STATUS

The Plan has not obtained a determination letter from the Internal Revenue Service (the IRS) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the trustee by letter dated October 6, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. Therefore, the plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

I. SUBSEQUENT EVENTS

Effective January 1, 2025, management consented to the appointment of ADP Retirement Trust Services, LLC as the Plan's trustee upon resignation of Reliance Trust Company on December 31, 2024.

Management has evaluated subsequent events through October 2, 2025, the date which the financial statements were available to be issued.
