In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 11, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

1. Description of Plan

The following description of the Supreme Machined Products Company, Inc. 401(k) Plan (the Plan) is provided for general information purposes. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective July 1, 1993 by Supreme Machined Products Company, Inc. (the Company and Plan Sponsor). The Plan is a defined contribution plan covering substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Eligible employees can become participants in the 401(k) portion of the Plan on the first day of the month after completing six months of service and attainment of age 21. Participants also become eligible to receive discretionary matching contributions from the Company upon completion of six months of service and attainment of age 21.

Contributions

A participant may elect to contribute between 1% and 90% of eligible annual compensation (elective deferral contributions), as defined in the Plan, subject to the limits established by the Internal Revenue Code (IRC). Participants who have attained age 50 before end of the Plan year are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover).

The Company has elected to make safe harbor matching contributions equal to 100% of participant contributions that do not exceed 3% of compensation plus 50% of the next 2% of compensation. The Plan document allows for other discretionary employer contributions to be made to the Plan; however, no such discretionary employer contributions were made by the Company in 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's safe harbor and discretionary employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, and specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their voluntary contributions and Company safe harbor contributions, plus actual earnings thereon. Vesting in the discretionary employer contributions is based on years of continuous service, as follows:

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to (i) the lesser of \$50,000 or (ii) 50% of their vested account balance. Participants may only have two loans currently outstanding from the Plan. The loan will bear a reasonable interest rate, be adequately secured, and not exceed a period of five years (unless used for the purchase of a primary residence). Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon retirement or termination of service, the Plan allows for distributions in accordance with the appropriate provisions of the IRC and applicable state laws. Benefits may be paid upon separation from service due to death, retirement, or termination of employment. If the participant's vested account balance is greater than \$7,000, the participant may choose from the following forms of payment: (1) lump-sum payment (2) installments or (3) partial withdrawals of at least \$500. The Plan also allows for in-service withdrawals upon reaching age 59 ½, as well as for reasons of financial hardship.

Administrative Expenses

Certain transaction fees and administrative expenses are paid by the Plan and are based on reasonable and customary rates. Certain other expenses incurred in connection with the operation of the Plan are paid by the Company. Investment-related expenses are included in net appreciation in fair value of investments.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to pay Plan administrative expenses or to offset employer contributions. The balance in the forfeiture account at December 31, 2024 and 2023 totaled \$0, and no forfeitures were allocated to contributions during the years ended December 31, 2024 or 2023.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the participant's account and are included in administrative expense when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan holds various investment securities, in general, which are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

3. Certified Investment Information

All investment information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, were obtained or derived from

information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quotes prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for investments measured at fair value.

Mutual Funds - Mutual funds are valued based on quoted net asset values of the shares held by the Plan on the last business day of the Plan year.

Collective Trust Funds - The Plan invests in a stable value fund that is valued at NAV as a practical expedient based on the closing price for underlying securities. The NAV of each of the funds is reported by the fund managers as of the financial statement date based on recent transaction prices and represents the price at which the Plan would be able to initiate a transaction. The underlying assets consist primarily of a stable value fund, which invests primarily in synthetic guaranteed investment contracts and is considered fully benefit-responsive. There are no participant redemption restrictions for this investment; however, the funds held by the Plan provide for daily redemptions by the Plan at reported NAV requires a 60-day redemption notice period and have no unfunded commitments.

5. Parties-in-Interest

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were \$21,181 for the year ended December 31, 2024. Such fees were based on reasonable and customary rates.

In addition, the Plan maintains notes receivable from participants. Those party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

7. Tax Status

The pre-approved plan document sponsored by ADP, LLC obtained an opinion letter dated October 6, 2020, in which the Internal Revenue Service (IRS) stated that the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the IRC. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.
