## **Auditors' Communication with Those Charged with Governance**

### **The Plan Administrator Spencer Technologies, Inc. 401(k) and Profit Sharing Plan**

Re: Auditors' Communication with Those Charged with Governance

We have conducted an audit of the financial statements and supplemental schedules of Spencer Technologies, Inc. 401(k) and Profit Sharing Plan (the "Plan") subject to Employment Retirement Income Security Act of 1974 ("ERISA") Section 103(a)(3)(C) as of and for the year ended December 31, 2024, and have issued our report thereon dated September 23, 2025. Professional standards require that we provide you with information about our responsibilities under auditing standards generally accepted in the United States of America, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter to you dated April 30, 2025. This letter confirms our discussions and provides additional required communications related to our audit.

### **Our responsibility under professional standards**

Our responsibility is to form and express an opinion about whether the financial statements are presented fairly, in all material respects, in conformity with accounting principles generally accepted in the United States of America ("US GAAP") and to express an opinion about whether the supplemental schedule are fairly stated in all material respects in relation to the financial statements taken as a whole and are presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA").

However, as permitted by Section 103(a)(3)(C) of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note (3) to the financial statements. Because of the significance of the information that we did not audit, we are unable to, and have not, expressed an opinion on the financial statements and supplemental schedule taken as a whole. We did, however, audit the form and content of the information included in the financial statements and supplemental schedules, other than that derived from the information certified by the trustee, in accordance with auditing standards generally accepted in the United States of America and found them to be presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Our audit included obtaining an understanding of the Plan and its environment, including internal control, sufficient to assess the risks of material misstatement of the financial statements and to design the nature, timing, and extent of further audit procedures. However, as part of the scope limitation discussed above, we did not consider internal control relating to the information prepared and certified to by the trustee. Material misstatements may result from (1) errors, (2) fraudulent financial reporting, (3) misappropriation of assets, or (4) violations of laws or governmental regulations, including prohibited transactions with parties in interest or other violations of ERISA rules and regulations, that are attributable to the Plan or to acts by management or employees acting on behalf of the Plan. Our audit did not identify any significant findings requiring communication to you.

The financial statements and supplemental schedules are the responsibility of management. Those individuals charged with governance of the Plan are responsible for the oversight of the financial reporting process, and our audit does not relieve management and those charged with governance of their respective responsibilities.

## **Qualitative aspects of significant accounting practices**

### *Significant accounting policies*

Plan management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during the reporting period that had a significant impact on the financial statements. No matters have come to our attention that would require us to inform you about (1) the methods used to account for significant unusual transactions, and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

### *Significant accounting estimates*

Accounting estimates made by the Plan's management are an integral part of the financial statements and are based on Plan management's knowledge and experience about past and current events and assumptions about future events. Actual results could differ from those estimates.

Certain accounting estimates are particularly sensitive because of their significance to financial statements and their susceptibility to change. The Plan's management believes that the estimates used and assumptions made are adequate based on the information currently available. We evaluated the key factors and assumptions used to develop the estimates in determining that they are reasonable in relation to the financial statements as a whole.

### *Financial statement disclosures*

The financial statement disclosures are consistent and clear.

## **Going concern**

The auditor is required to communicate with those charged with governance events or conditions that, when considered in the aggregate; indicate a substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We concur with management's assessment that the Plan will continue as a going concern for one year from the auditors' report date.

## **Significant risks**

We have identified the following significant risks in connection with our audit:

- Management override of controls.
- Contributions received and receivable (revenue recognition).
- Employee contributions elected historically did not agree to payroll deductions.

## **Significant difficulties encountered during the audit**

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

## **Uncorrected and corrected misstatements**

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of the Plan's management.

We are required to communicate to you misstatements that remain uncorrected, including any related to prior periods, and the effect, if any, that they may have on the opinion in our report, and request their correction.

The audit did not identify uncorrected financial statement misstatements.

In addition, we are required to communicate to you all material, corrected misstatements that were brought to the attention of the Plan's management as a result of our audit procedures.

Our audit did not identify misstatements that were corrected by management.

## **Disagreements with Plan management**

For purposes of this letter, a disagreement with management is a matter, whether or not resolved to our satisfaction, concerning financial accounting, reporting, or auditing, which could be significant to the financial statements or the auditors' report. No such disagreements arose during the course of the audit.

## **Representations requested from Plan management**

We have requested certain written representations from the Plan's management in separate letters each dated September 23, 2025.

## **Consultations with other accountants by the Plan's management**

In some cases, the Plan's management may decide to consult with other accountants about auditing and accounting matters. The Plan's management has informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

## **Other matters discussed with Plan management**

We generally discuss with the Plan's management a variety of matters, including the application of accounting principles and auditing standards, business conditions affecting the Plan, and future plans and strategies that may affect the risks of material misstatement. None of the matters discussed and our responses thereto were a condition to our retention as auditors.

## **Auditor independence**

We affirm that PKF O'Connor Davies, LLP is independent with respect to the Plan in accordance with the AICPA's *Code of Professional Conduct* and DOL and ERISA Independence Rules.
