### Notes to Financial Statements December 31, 2024

#### Note 1 - Description of Plan

The following is a brief description of the PSB Insights, LLC (the "Plan") and is provided for general purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

##### **General**

The Plan was established on January 1, 2005 and was most recently amended on March 5, 2021. The Plan is a defined contribution plan established for the benefit of the employees of PSB Insights, LLC (the "Company" or the "Plan Sponsor"). The Plan qualifies under Section 401(k) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan covers all eligible employees, as defined, who have attained the age of 21. Participants may begin participating after the completion of at least six (6) months of eligibility service, as defined.

On April 1, 2024, the Plan's net assets were transferred from Fidelity Management Trust Company to ADP Retirement Trust Services, LLC. In connection with transfer of assets, the plans third-party administrator changed from an affiliate of Fidelity Management Trust Company to ADP Retirement Services, LLC.

##### **Participant contributions**

Each year, participants may contribute a percentage of their eligible compensation, as defined in the Plan Document, on a pre-tax and post-tax basis, subject to statutory limits of the IRC. Distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution.

##### **Company contributions**

The Company makes a safe harbor qualified match of 100% of the participant's contribution up to 3% of eligible compensation and 50% of the participant's contribution from 3% to 5% of eligible compensation, subject to statutory limits of the IRC. In addition, the Company may make a discretionary profit-sharing contribution for eligible employees. For the year ended December 31, 2024, the Company did not make a discretionary profit-sharing contribution.

##### **Participant accounts**

Individual accounts are maintained for each participant and include each participant's salary deferral and rollover contributions, plus an allocation of the Plan Sponsor contributions, plan earnings, and realized and unrealized gains and losses on investments, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their salary deferral contributions; rollover contributions, safe harbor qualified match contributions, qualified nonelective contributions, and plan earnings (losses) on such contributions.

**Notes receivable from participants**

Participants are limited to one loan under certain hardship situations at a time and may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount of the lesser of \$50,000 or 50% of vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. As of December 31, 2024, the interest rate charged on existing loans was between 6% and 9.5%. Principal and interest is paid ratably through payroll deductions.

**Payment of benefits**

On termination of service, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the vested interest in their account. The Plan allows for distributions upon termination of service, death, disability, or attainment of age 59-1/2, and other situations as detailed by the Plan Document. A participant may elect to receive a lump sum payment or may roll over the value of their account into another qualified plan.

**Forfeited accounts and unallocated assets**

Forfeited balances of terminated participants' nonvested accounts and unallocated assets are used to pay any administrative expense and to reduce future employer contributions, and then allocated to remaining participants. As of December 31, 2024 and 2023, forfeited accounts totaled \$15 and \$4,584, respectively.

**Investment options**

Participants may direct their contributions into several investment options offered by the Plan. In the event a participant fails to make an investment election with respect to all or any portion of their account subject to their investment direction, the Trustees shall invest all or such portion of their account in the investment fund designated by the Plan Administrator.

**Note 2 - Summary of accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded using the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Payment of benefits

Benefit payments are recorded when paid.

#### Expenses

The Company pays substantially all administrative expenses of the Plan. Certain investment management fees and other charges paid to the Trustees are offset against investment performance in net appreciation in fair value of investments and are not, therefore, separately reflected as administrative expenses.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Certain common collective trusts are valued at the NAV of the units held by the Plan. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Other certain common collective trusts are valued at the daily closing price as reported by the common collective trust. These common collective trusts held by the Plan are open-ended investments. These common collective trusts publish their daily net asset value ("NAV") and transact at that price. These common collective trusts held by the Plan are deemed to be actively traded.

Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**Note 4 - Related party and party-in-interest transactions**

Certain plan investments are shares of pooled separate accounts managed by Fidelity Management Trust Company, the former Trustee of the Plan. During 2024, the Plan changed trustees and the new Trustee is ADP Retirement Trust Services, LLC. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investments management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. During 2024, the Plan made direct payments to

Fidelity Management Trust Company and ADP Retirement Trust Services, LLC or their affiliates in the amounts of \$18,298 and \$21,268, respectively, which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### **Note 5 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participating employees will become 100% vested in their accounts.

#### **Note 6 - Tax status**

The Plan Sponsor adopted a Volume Submitter Profit Sharing Plan with a cash or deferred arrangement which received a favorable opinion letter from the Internal Revenue Service on October 6, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Risks and uncertainties**

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8 - Certified investments**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income/ (loss) and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company as of December 31, 2023 and for the period from January 1, 2024 through April 3, 2024 and by ADP Retirement Trust Services, LLC as of December 31, 2024 and for the period from April 1, 2024 through December 31, 2024. the trustees of the Plan.
