## INDEPENDENT AUDITORS' REPORT

To the Trustees of the  
Independent Living Profit Sharing Plan - Union  
Brooklyn, New York

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Independent Living Profit Sharing Plan - Union (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

This summary of significant accounting policies of the Independent Living Profit Sharing Plan - Union (the "Plan") is presented to assist in understanding the Plan's financial statements and supplemental information. These financial statements, supplemental information, and notes are representations of the Plan's management, who is responsible for the integrity and objectivity of the financial statements. These accounting policies have been consistently applied in the preparation of the financial statements and supplemental schedule.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition: The Plan's investments in mutual funds and common/collective trusts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. During the year ended December 31, 2024, the Plan's net appreciation was \$259,385.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are considered deemed distributions based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid to the Plan's participants.

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Events Occurring After the Report Date: The Plan Sponsor has evaluated events and transactions that occurred between January 1, 2025 and August 11, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. Any such disclosures have been reflected within the financial statements.

**NOTE 2 - DESCRIPTION OF THE PLAN**

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is sponsored and administered by Independent Living Association, Inc. and ILA Case Management Services, Inc. (collectively, "the Company" or "Plan Sponsor").

General: The Plan was established March 1, 2006. It is a defined contribution plan pursuant to Sections 401(a) and 501(a) of the Internal Revenue Code of 1986, as amended ("the Code"). It is available to all eligible employees, as stated in the Plan document, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Reliance Trust Company ("RTC") was the trustee and custodian of the Plan assets. The Plan Sponsor uses Automatic Data Processing ("ADP") for its administrative and recordkeeping services.

Eligibility: Employees are eligible to receive employer contributions immediately following the completion of both one year of service and 1,000 hours. Employees are eligible to make voluntary contributions upon hire.

Contributions: The Company contributes to the Plan on a bi-weekly basis a percentage of an employee's annual compensation, not to exceed the statutory limits, on a pre-tax basis. For the year ended December 31, 2024, the employer contribution rate was 2.25%. The Plan also allows for discretionary contributions designated by the Board of Directors based on a formula that takes into account each participant's age and years of service. There were no discretionary contributions made during the year ended December 31, 2024.

As of February 2013, participants of the Plan were permitted to contribute to the Plan beginning on the date of hire, an amount not to exceed statutory limits as prescribed by the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts: The Plan is a defined contribution plan under which separate individual accounts are established for each participant. Participants direct the investment of their contributions and their share of employer contributions into various investment options as offered by the Plan. Participants' accounts are credited with the participants' contributions and earnings, and the allocation of employer contributions and administrative expenses. As a participant-directed plan, each participant's investment choices determine his/her share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Upon enrollment in the Plan, participants may direct the record-keeper to invest contributions into various investment options managed by the trustee, its affiliates, and other large investment management companies. If a participant fails to designate an investment selection, funds are automatically invested into the qualified default investment alternative, which is based upon the participant's expected retirement date. Participants may change their investment option, transfer part or all past investments to other funds, and change their deferral percentages at any time.

Notes Receivable from Participants: Participants may borrow from their account balance up to five loans at any time provided; however, only one loan with an initial term greater than five years is outstanding for eligible participants at any time. Only loans for the purchase of a principle residence have a repayment term of 30 years. All other loans must be repaid within five years. Principal and interest are paid ratably through payroll deductions. The aggregate amount of all loans to eligible participants shall not exceed \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts and bear interest at the time of the loan calculated as prime rate of interest plus 1%. Outstanding loans at December 31, 2024 bore interest between 4.25% and 9.50%.

In 2022, the Plan Sponsor adopted the *Coronavirus Aid, Relief, and Economic Security Act* ("CARES Act") provisions for loan relief to 1) delay certain required loan repayments for one year and 2) increase loan limits to the lesser of \$100,000 or 100% of the participant's vested balance for coronavirus-related loans. The CARES Act provided for the increased loan limit for coronavirus-related loans issued from March 27, 2020 through September 22, 2020. The one-year suspension of loan repayments applied to qualified participants' loan payments due between March 27, 2020 and December 31, 2020. Following the suspension period, those loans were re-amortized over the remaining period of the loans, plus the suspension period.

Vesting: Participants are immediately fully vested in their contributions plus actual earnings thereon.

Vesting in discretionary employer contributions is determined in accordance with the following schedule:

Forfeitures: Forfeitures resulting from non-vested portions of participants accounts may be used to pay administrative expenses of the Plan or be used to reduce employer contributions.

Forfeitures by non-vested participants in the amount of \$17,139 during the year ended December 31, 2024 were used to offset employer contributions to the Plan. As of December 31, 2024 and 2023, there were \$1,256 and \$10 of forfeitures remaining, respectively.

Deemed Distributions: When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. A loan in default is considered a distribution from the Plan (deemed distribution) that would result in taxable income to the participant. Upon the occurrence of a qualifying event (as defined by the IRS and the Plan document), defaulted loans will be offset against the participant's account balance and removed from receivables. As of December 31, 2024 and 2023, there were \$133,904 and \$103,411 of outstanding loans representing defaulted loans (deemed distributions), respectively, for which the participant was taxed through an IRS Form 1099-R.

In-Service Withdrawals: In-service and hardship withdrawals are permitted by the Plan.

Payment of Benefits: Under the terms of the Plan, participants are eligible for normal retirement upon reaching age 65. Upon termination of service, disability, or death, distribution of benefits to participants will be made in one lump-sum payment in cash, unless a participant specifically elects to receive their benefits in an alternative form of payment, such as substantially equal installments, or partial withdrawal.

Plan Amendments: The Employer has the right under the Plan to amend the Plan at any time. The Plan was last amended in 2024 to exclude certain bonus payments from compensation eligible for employer profit sharing contributions.

The Plan has adopted mandatory and certain voluntary provisions of the SECURE 2.0 Act of 2022. Formal amendments to the Plan are due by the end of the year ending December 31, 2026.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed pursuant to the Plan document. Under the provisions of ERISA, if the Plan is terminated, the Plan Sponsor may be obligated to make termination payments to the Plan.

**NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE**

All investment information and notes receivable disclosed in the accompanying financial statements as of December 31, 2024 and 2023, and ERISA-required supplemental schedule, including net appreciation in fair value of investments, dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by RTC.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Accounting standards establish a framework for measuring fair value, providing a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and lowest priority to unobservable inputs (level 3 measurements). The three levels of the value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset and liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds (Registered Investment Companies): Mutual funds are valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV is based upon quoted market prices.

Common/Collective Trusts: Common/collective trusts are valued at the NAV of units held by the Plan at year-end. The NAV is determined by the trustee of the funds and is based upon the fair value of the underlying assets held by the funds. As of December 31, 2024 and 2023, the Invesco Stable Asset Fund is reported on the fair value hierarchy table as a level 2 investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - INCOME TAX STATUS**

The Plan Sponsor elected to adopt the record-keeper's prototype, non-standardized; profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the IRS dated October 6, 2020, which states that the Plan is designed in accordance with the applicable requirements of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated with and continues to qualify under the applicable requirements of the IRC, and that the Plan is exempt from federal income taxes.

U.S. GAAP requires the Plan Sponsor to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments were managed by the trustee and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

**NOTE 9 - TRANSFER OF NET ASSETS TO/FROM AFFILIATE PLANS**

On March 1, 2006, the Plan Sponsor established a related retirement plan for its employees who are not members of 1199 Service Employees International Union ("Union 1199 SEIU"). This related plan is similar in all material respects to the Plan. From time to time, employees of the Plan Sponsor will transfer from positions which are non-union in nature to union positions and vice versa. When such transfer occurs, the employees' plan assets are also transferred to their respective plans, since employees simultaneously cannot be members of both the union and non-union plans. Transfers from the union plan to the non-union plan totaled \$552 during the year ended December 31, 2024. Transfers from the non-union plan to the union plan totaled \$19,168 during the year ended December 31, 2024.
