1. DESCRIPTION OF PLAN

The following description of the Inclusion Services 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering all employees of Inclusion Services, LLC (the Company) that have at least three months of service and are twenty-one years of age or older. The Plan was adopted by the Company on January 1, 2015. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and amendments to this act as they occur.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are always 100% vested in their rollover contributions, qualified non-elective contributions, deferral contributions, and any earnings thereon. Participants' employer matching contributions and employer profit sharing contributions and any earnings thereon will be vested in accordance with the following schedule:

Less than 1	0%

Plan Administration

The Plan's assets are held by Reliance Trust Company (the "Trustee") as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The Company is the Plan sponsor and Plan administrator. The Plan administrator is responsible for carrying out the duties imposed under ERISA. Certain administrative and Trustee functions are performed by officers or employees of the Company. However, no such officer or employee received compensation from the Plan. While certain administrative expenses are paid by the Plan, other administrative expenses are paid directly by the Company which are immaterial in amount. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

1. DESCRIPTION OF PLAN (continued)

Contributions

Each year, participants may contribute up to a percentage of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company contributes an amount of matching contributions equal to 100 percent of each participant's contribution. This matching contribution may not exceed 5 percent of each participant's eligible earnings. A matching contribution in the amount of \$160,980 was made by the Company for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution or withdrawal and allocations of (a) the Company's profit sharing contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable - Participants

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the vested balance in the participant's account. The interest rate applied to all loans will be based on the prime interest rate in effect when the loan is approved. Principal and interest is paid through bi-weekly payroll deductions. The notes to the financial statements were modified to accommodate this change.

Payment of Benefits

On termination of service due to death, retirement or for any other reasons, the participant may elect to receive a lump-sum distribution equal to the vested portion of their account or they can receive an annuity over the life of the participant or beneficiary.

Distribution of benefits as a lump-sum distribution is mandatory if a participant's vested balance is less than \$5,000.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$45,206 and \$33,739, respectively. When applicable, these accounts can be used to reduce future employer contributions.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Account

The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable - Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded or required.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Stable asset funds are reported at contract value due to the fact that stable asset funds are fully-benefit responsive contracts. The financial statements have been adjusted to represent the contract value of the stable asset fund at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"> • quoted prices for similar assets or liabilities in active markets; • quoted prices for identical or similar assets or liabilities in inactive markets; • inputs other than quoted prices that are observable for the asset or liability; • Inputs that are derived principally from or corroborated by observable market data by correlation or other means. • If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments are reported at fair value (except for the fully benefit responsive investments recorded at contract value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value and consistent with other market

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used as of December 31, 2024.

Registered investment company funds (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective Trusts: Fair value of this investment contract, prior to contract termination, equals the contract value. Contract value is determined using a discounted cash flow valuation methodology where the interest rate for this portfolio investment contract is reset at least as frequently as annually. This contract is not fully benefit responsive and therefore is reported at fair value on the financial statements.

9. TAX STATUS

The Plan has adopted a Prototype Non-Standardized Profit Sharing Plan (“Prototype Plan”) preapproved by the Internal Revenue Service (“IRS”). The IRS reviewed the Prototype Plan document and opined in a letter dated July 8, 2014 that the Prototype Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan and related trust are designed in accordance with applicable sections of the IRC, the Plan has been amended and restated since receiving the opinion letter. The Plan administrator and Plan’s advisors believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods.

10. CONCENTRATION OF CREDIT RISK

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist principally of participant notes receivable. Credit risk is limited due to limitations on the maximum number of loans a participant may have outstanding at any one time, as well as the provision that each participant's total outstanding loan balance cannot exceed 50% of his or her vested account balance. The remaining vested account balance serves as collateral.

12. SUBSEQUENT EVENTS

Management has evaluated all events and transactions that occurred through October 3, 2025, the date these financial statements were available to be issued.
