1 Description of Plan

The following description of Global TBM Company Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan, which began January 1, 1993, is a defined contribution plan covering all employees of Robbins, a Global TBM Company (the “Company”) who meet the service requirements except for temporary employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2021, substantially all of the assets of The Robbins Company were purchased by Global TBM Company (“Global”), with Global assuming all benefits liability, including responsibility for this Plan. Effective February 1, 2021, the Plan’s name was changed to Global TBM Company Retirement Savings Plan from The Robbins Company 401(k) Retirement Savings Plan.

The Plan was amended and restated effective May 1, 2022 to bring the Plan into compliance with legislative and regulatory changes.

Eligibility:

All employees of the Company who are employed for two months are eligible to participate in the Plan except for temporary employees.

Upon meeting Plan eligibility requirements, eligible employees are automatically enrolled into the Plan, with 5% of their eligible compensation deferred into the Plan. Eligible employees may opt out of participation in the Plan.

Contributions:

Cash or Deferred Option [401(k)] - Participants may elect between 1% to 75% of their compensation to be contributed to the Plan by the Company.

Employer Contributions - The Company may make contributions to each eligible participant's account by matching a percentage of the Participant's elective deferral for the Plan year. The Company has made a Safe Harbor election so that the match is 100% of the first 5% of employee deferrals.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code as defined in the Plan agreement. The Plan is subject to annual compliance testing, and any participant amounts in excess of the limits are refunded to the participant and employer amounts are forfeited.

Rollover contributions from other plans are also accepted, providing certain specified conditions are met.

1 Description of Plan, Continued

Participants' Accounts:

401(k) Accounts - Each participant's account is credited with the participant's elective contributions, employer matching contributions, earnings, and losses thereon.

Vesting:

All participants are 100% vested in elective deferrals and employer matching contributions.

Notes Receivable from Participants:

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The minimum loan amount is \$500. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest are paid ratably through payroll deductions. Loans are measured at their unpaid principal balance plus any accrued interest.

Other Plan Provisions:

Normal retirement age is 65, however, a participant may elect early retirement on or after age 55.

Payment of Benefits:

Upon termination of service for any reason including retirement, death or total and permanent disability, a participant may receive a lump sum payment, installment payments, or a direct transfer amount equal to the value of his or her account. Installment payments are only available if the participants' vested account balance is greater than \$5,000 (excluding any rollover balance). Benefits are recorded when paid.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

2 Summary of Significant Accounting Policies

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

2 Summary of Significant Accounting Policies, Continued:

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

The fair value of the common collective trusts is based on the value of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

The Plan will generally pay the expenses incurred in administering the Plan, however, some of the Plan administration expenses may be paid by the Company.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Risks and Uncertainties:

The Plan's investments include investments in mutual funds and collective funds holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for plan benefits.

Subsequent Events:

Management evaluates subsequent events occurring subsequent to the date of the financial statements in determining and the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- * Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- * Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
 - * Quoted prices for similar assets or liabilities in active markets
 - * Quoted prices for identical or similar assets or liabilities in inactive markets
 - * Inputs other than quoted prices that are observable for the asset or liability
 - * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- * Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds is based on quoted market prices.

Common/Collective Trusts:

The fair value of the investments is based on a Net Asset Value per unit calculated on a daily basis and fall into the Level 2 category of the valuation hierarchy. Purchases and sales are transacted daily and there are no unfunded commitments. Withdrawals may require advanced notice under certain circumstances, otherwise there are no other restrictions.

6 Tax Status

On October 6, 2020, the Internal Revenue Service stated that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has since been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. Currently, an examination of the Plan for the 2022 year by the IRS is in progress.
