#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of GNS Healthcare, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. Description of Plan

The following description of GNS Healthcare, Inc. 401(k) Plan (the Plan) provides general information only. Plan participants should refer to the plan document for a more complete description of the Plan's provisions.

### *General*

The Plan is a defined contribution plan sponsored by GNS Healthcare, Inc. (the Plan Sponsor) and covers substantially all employees excluding part-time, temporary, and seasonal employees who have not completed one year of service (defined as 12 consecutive months during which an employee has completed at least 1,000 hours initially measured from the date of hire and then shifting to the plan year in subsequent years), union employees, non-resident aliens, interns, and co-operative employees. The Plan was originally established on July 1, 2007 and was most recently amended and restated effective July 31, 2022. The most significant change as a result of the restatement was to exclude co-operative employees from participating in the Plan. The Plan Administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA).

### *Setting Every Community Up for Retirement Enhancement (SECURE) Act and SECURE 2.0 Act*

The SECURE Act and the SECURE 2.0 Act had various provisions in effect during the year ended December 31, 2024. The most significant change required including long-term part-time (LTPT) employees who attained 500 or more hours of service in three consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. The Plan is required to be formally amended on or before December 31, 2025 for the SECURE Act and on or before December 31, 2026 for the SECURE 2.0 Act.

### *Contributions*

Each year, participants may contribute pre-tax and Roth contributions up to 90% percent of their eligible compensation, as defined. Participants are immediately eligible to participate in the Plan and enter the Plan on the first day of the month following their date of hire. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for employer safe harbor nonelective contributions to the Plan equal to 3% of eligible employee compensation for all eligible employees even if not contributing, excluding highly compensated employees. Employer safe harbor nonelective contributions totaled \$92,958 for the year ended December 31, 2024. Such amounts are generally funded subsequent to year-end and therefore are typically included as employer contributions receivable on the accompanying statements of net assets available for benefits. As of December 31, 2024 and 2023, employer contributions receivable consisted of employer safe harbor nonelective contributions of \$92,958 and \$86,530, respectively.

The Plan also provides for discretionary employer matching contributions and discretionary nonelective (profit-sharing) contributions for eligible participants who have completed three months of service. No such contributions were declared for the year ended December 31, 2024.

Employees are permitted to participate in all such contributions on the first day of the month coinciding with or subsequent to attaining the respective eligibility requirements.

### *Contributions...continued*

All contributions and compensation are subject to certain Internal Revenue Service (IRS) limitations.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, employer safe harbor nonelective contributions, discretionary employer matching and non-elective (profit-sharing) contributions, an allocation of the Plan's earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. The allocation of earnings or losses is based on each participant's respective account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Notes Receivable from Participants*

The Plan permits its participants to obtain loans against their account balances. A plan participant may borrow from his or her vested account a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000 reduced by the highest outstanding loan balance within the last twelve months or 50% of his or her vested account balance. With the exception of loans used to purchase a primary residence that are limited to a maximum of 30 years, loan terms are limited to a maximum of five years. Notes receivable from participants are secured by the vested balance in each participant's account and shall bear interest at the Wall Street Journal prime rate published on the 14<sup>th</sup> day of the month plus 1%. Principal and interest are paid ratably through regular payroll deductions for actively employed participants. A participant may prepay the entire outstanding balance of a loan, plus accrued interest, without penalty; however, any such prepayment must be prepayment in full. Extra payments or partial prepayments will not be permitted. Upon termination of employment, any remaining payments are immediately due unless directly rolled over to another employer's plan. Repayments may be suspended for 12 months for a bona fide leave of absence and for the entire time the borrower is on qualified military leave. The Plan Administrator shall consider a loan in default if any scheduled payment remains unpaid as of the last business day of the calendar quarter in which a loan is initially considered past due. Any unpaid balances at the time of default shall incur a 10% penalty if the participant is under the age of 59½. Certain other restrictions may apply to notes receivable from participants as defined in the plan document. As of December 31, 2024, the interest rates on the outstanding notes receivable from participants ranged from 9.25% to 9.50% and had various maturity dates through July 2029.

### *Vesting*

Participants are immediately vested in their voluntary contributions, rollover contributions, and employer safe harbor nonelective contributions plus actual earnings thereon. Participants become vested in discretionary employer matching and non-elective (profit-sharing) contributions starting after each respective participant's first year of credited service (plan years with hours worked in at least six months) and become fully vested after four years of credited service. Each participant who continues his or her employment until normal retirement age or terminates due to death or disability shall become immediately vested in all contribution types.

### *Forfeitures*

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,203 and \$3,545 respectively. These amounts can be used to reduce future employer contributions or pay the Plan's expenses. During the year ended December 31, 2024, \$7,501 of forfeited nonvested accounts were used to reduce employer contributions for the year ended December 31, 2023. Subsequent to December 31, 2024, \$3,403 of forfeited nonvested accounts were used to reduce employer contributions for the year ended December 31, 2024.

### *Payment of Benefits*

The participant's vested account may be distributed to the participant (or the participant's beneficiary in the event of the participant's death) at retirement, death, disability, or termination of employment in the form of cash, insurance contracts, or annuity contracts as lump-sum, partial withdrawals, or substantially equal payments. If a participant terminates service, the entire vested amount in his or her account may be distributed or rolled over into another qualified plan, as directed by the participant. Participants who are eligible for a hardship withdrawal or have attained age 59½ may elect to withdraw all or a portion of their accounts with a minimum of \$500. Distributions shall be made to an eligible participant as soon as reasonably practicable following the date the participant's application for distribution is received by the Plan Administrator, but in no event later than the participant's attainment of age 73. Distributions may be made from a participant's rollover account at any time. The Plan Administrator can elect to distribute funds out of the Plan when a participant terminates employment and has a vested balance in the Plan of less than \$1,000. Certain other restrictions may apply to benefit payments as defined in the plan document.

### *Investment Elections*

Each participant shall direct the investment of his or her account and shall select among various mutual funds and common collective trust funds. Each participant has the ability to change his or her investment allocations at any time.

## 2. Summary of Significant Accounting Policies

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan's financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles in the United States of America (GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to GAAP issued by the FASB in these notes are to the FASB Accounting Standards Codification (ASC).

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisers and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus any accrued, but unpaid interest. Interest from notes receivable from participants is recorded on an accrual basis. As of December 31, 2024 and 2023, accrued, but unpaid interest has been deemed insignificant to the Plan. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable from the participant to be a distribution, the notes receivable from participants balance is reduced and a benefit payment is recorded within the statement of changes in net assets available for benefits.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the applicable participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments. For the year ended December 31, 2024, the Plan Sponsor paid certain other administrative expenses incurred by the Plan.

### 3. Fair Value Measurements

The Plan discloses the fair value of investments in accordance with FASB ASC Topic No. 820, *Fair Value Measurements* (ASC 820). The framework under ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other mean; or
  - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds* – Mutual funds are valued at the daily closing price as reported by the applicable mutual fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission, which are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust funds* – The common collective trust funds are valued at the NAV of units of the applicable common collective trust fund. The NAV, as provided by Reliance Trust Company (Reliance), the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the applicable fund less its liabilities. This practical expedient is not used when it is determined to be probable that the applicable fund will sell the investment for an amount different than the reported NAV. Transactions of investments or withdrawals may occur on a daily basis and there are no redemption restrictions on these funds. There are no unfunded commitments as of December 31, 2024 and 2023.

### 4. Information Prepared and Certified by Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment and notes receivable from participants activity reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

### **5. Tax Status**

The Plan uses a prototype non-standardized plan document, sponsored by Reliance. The IRS has determined, by an opinion letter dated October 6, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. Plan Termination**

During the year ended December 31, 2024, the Plan Sponsor downsized its operations resulting in a partial plan termination. This affected 11 participants, 3 of whom have taken distributions of approximately \$25,000 from the Plan during the year ended December 31, 2024. Approximately \$718,000 remains payable to affected participants as of December 31, 2024. All participants affected by the partial plan termination became fully vested in their accounts prior to distributions being taken.

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.

### **7. Party-in-Interest Transactions**

The Plan issues loans to participants, which are secured by the balances in participant accounts, and constitute party-in-interest transactions as that term is defined in Section 3(14) of ERISA.

### **8. Risk and Uncertainties**

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Subsequent Events**

The Plan has evaluated subsequent events for potential disclosure or recognition through October 6, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the SECURE 2.0 Act expanded LTPT provisions to include employees who attained 500 or more hours of service in two consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. Further, participants from ages 60 to 63 will be allowed to contribute catch-up contributions equal to 150% of the standard limit.
