TO THE PLAN ADMINISTRATOR OF TULLY'S GOOD TIMES FAMILY INC. 401(K) PLAN

Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of **TULLY'S GOOD TIMES FAMILY INC. 401 (K) PLAN**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Tully's Good Times Family Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established January 1, 2010, covering all full-time employees of Tully's Good Times Family Inc. (the "Company") who have completed one (1) year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 90% of their annual compensation on a pretax or Roth basis, subject to Internal Revenue Service ("IRS") limitations. Participants over the age of 50 may contribute additional amounts as allowed by IRS regulations. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make a matching contribution based on the participants' elective deferrals in a percentage set by the Company each plan year. For 2024 and 2023, Company matches 50% up to 4% (total of 2%) of participant contributions.

Participant Accounts

Separate accounts are maintained for each participant. The custodian invests the contribution amounts, as instructed by the participants, in one or more of the separate investment funds offered under the Plan. Each participant's account is credited with (a) the amount of the participant's elected contributions; (b) the amount of the participant's Company matching and discretionary contributions, if any; (c) the amount of any attributable investment earnings and market appreciation or depreciation; and (d) charged with direct administrative expenses when applicable. The benefit to which a participant is entitled is the final market value of the participant's account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. For the Company's matching or discretionary contribution plus earnings thereon, the employee's vested percentage is subject to a six-year vesting schedule.

NOTE 1 – DESCRIPTION OF THE PLAN – Continued

Payment of Benefits

Upon termination or retirement, plan benefits are paid in a single lump sum. Terminated participants with vested account balances greater than \$5,000 may elect to defer payment of benefits until age 65. A financial hardship withdrawal provision is available, enabling a participant to withdraw an amount to cover an immediate and heavy financial need, in accordance with current Internal Revenue Service regulations.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$1,100 and \$1,500, respectively. Forfeitures can be utilized to reduce plan expenses or employer contributions. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$3,900 and \$2,300 were used to reduce the employer contribution, respectively.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

The accounting principles and practices which affect the more significant elements of the financial statements are:

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain includes plan's gains and losses on investments bought and sold as well as held during the year.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES – Continued

Administrative Expenses

Certain indirect expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net investment gain from investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure on contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in any combination of mutual funds. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Date of Management's Review

Plan management has evaluated subsequent events from December 31, 2024 through October 7, 2025, the date the financial statements were available to be issued. Management has determined that no such events have occurred.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 3 – FAIR VALUE

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under *FASB Accounting Standards Codification ("ASC") No. 820* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 3 – FAIR VALUE – Continued

Stable Value Common Collective Trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments at December 31, 2024 and 2023 consist of mutual funds held by Reliance Trust Company, the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions. ADP, Inc. acts as the record keeper for the Plan, and therefore, fees paid for these services are considered party-in-interest transactions. Fees paid by the plan for investment management services are included in administrative expenses.

NOTE 5 – INCOME TAX STATUS

The Employer has adopted the Automated Data Processing (“ADP”) Prototype 401(k) and Profit-Sharing Plan. The Plan obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service ruled that the prototype plan of ADP is acceptable under Section 401(a) of the Internal Revenue Code (“IRC”) and, therefore, is not subject to federal income tax under present law. Although the plan has been amended and restated since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – FINANCIAL INFORMATION CERTIFIED BY PLAN CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rule and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained certifications from Reliance Trust Company, custodian of the Plan, that all of the information provided by them is complete and accurate. Information included in the accompanying financial statements as of December 31, 2024 and 2023 pertaining to investments, dividend and interest income, net investment gain in fair value of investments, and all information in the supplemental schedule, is presented in reliance solely upon those certifications.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.
