We have performed audits of the financial statements of Finley Resources Inc. 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### **1. Description of the Plan**

The following description of the Finley Resources Inc. 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan whereby eligible employees of Finley Resources Inc. (“the Company”) are permitted to make contributions under section 401(k) of the Internal Revenue Code (the “Code”). The Plan was originally adopted on January 1, 2000 and is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently amended and restated effective May 1, 2023 to change the age requirement for eligibility.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee of Finley Resources Inc. 401(k) and the Plan Administrator are responsible for governance and operation of the Plan, respectively.

#### Eligibility

Prior to May 1, 2023, all non-excludable employees of the Company who had completed two consecutive months of service and had attained age 21 or older were eligible to participate in the Plan on the first day of the month coinciding with or the next following date they meet the eligibility requirements. Effective May 1, 2023, the Plan amended the age requirement for eligibility from age 21 to age 18.

#### Contributions

Participants may contribute up to 70% of eligible compensation, subject to certain maximum limitations imposed by the Internal Revenue Code (“the Code”), as defined in the Plan. Participants may elect to make pre-tax deferrals or Roth deferrals. Roth deferral contributions cannot be re-characterized as pre-tax deferral contributions once elected. The Plan includes a no-escalation, Automatic Deferral provision whereby the Company automatically withholds 2% of a participant’s eligible compensation each payroll period and remits the withheld amount to the participant’s account in the Plan as a pre-tax 401(k) deferral. The Automatic Deferral provision applies to all Participants without salary deferral agreements in effect as of the Automatic Deferral provision’s effective date.

Participants who have attained age 50 before the close of the plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions).

The Company makes a Safe Harbor matching contribution equal to 100% of a participant’s elective deferrals that do not exceed 6% percent of the participant’s eligible compensation contributed to the Plan. The employer determines the Safe Harbor match contribution for each payroll period separately and the match is calculated based on the ratio of Elective Deferrals to Compensation for the Plan Year with “true ups” made accordingly at year end. The Plan disregards a participant’s elective deferrals made prior to the effective date of the match contribution. Participants are immediately fully vested in their share of the Safe Harbor match contributions. During 2024, the Company’s Safe Harbor matching contributions to the Plan net of forfeitures totaled \$1,180,901.

The Company may also make flexible discretionary matching contributions to the Plan, equal to a certain percentage of a participant’s salary deferrals not to exceed 4% of the participant’s eligible compensation. During 2024, the Company did not make any discretionary matching contributions to the Plan.

The Company may also make discretionary profit-sharing contributions to participants still employed at the end of the Plan year except for employment termination due to death, disability, or attainment of normal retirement age. Profit sharing contributions are allocated annually on a pro rata basis based on a formula described in the Plan document. During 2024, the Company did not make any profit-sharing contributions to the Plan.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of: (a) the Company’s contributions and (b) Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant’s investment elections and earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

### Investment Options

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust as investment options for participants. Participants can make or change investment elections at any time.

### Vesting

Participants are always fully vested in their contributions plus actual earnings (losses) thereon. Participants are also immediately fully vested in their share of Company Safe Harbor matching contributions. Vesting in the Company's flexible discretionary match contributions and Company's profit-sharing contributions plus related earnings (losses) thereon is determined by the years of service based on the following vesting schedule:

### Notes Receivable from Participants

Participants may borrow from their accounts an amount not to exceed the lesser of: (a) one-half of the participant's vested account balance or (b) \$50,000 reduced by the participant's greatest outstanding loan balance during the 12 months preceding the date of the loan. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator at the time of loan origination. The loan must be entirely repaid within five years of the date the loan proceeds are received, unless the loan is to be used to acquire the principal residence of the participant, in which case the loan must be entirely repaid within a period not to exceed 30 years of the date the loan proceeds are received. Principal and interest are repaid ratably through payroll deductions.

### Payments of Benefits

Benefits under the Plan will generally be paid in cash, except for insurance contracts or annuity contracts. Distributions to participants with vested account balances less than \$5,000 are made in a single lump-sum payment equal to the value of the participant's vested interest in their account. In determining whether the vested account balance exceeds the \$5,000 threshold, "rollover" contributions (and any earnings allocable to "rollover" contributions) will not be considered. Participants with vested account balances in excess of \$5,000 may elect to receive distributions in the form of a single lump-sum payment, partial withdrawals, or installments over a period of not more than the assumed life expectancy of the beneficiary and/or participant. To comply with certain requirements of the SECURE Act and IRS regulations, the Plan requires participants to take their first required minimum distribution in the year they reach age 73.

Participants who are also active employees can request a hardship withdrawal up to their vested account balance, subject to certain conditions and restrictions. An active participant with a financial hardship may be able to withdraw all or any part of their vested account resulting from 401(k) elective deferral contributions provided the hardship distribution is for: (1) payment of medical expenses that would be tax deductible; (2) purchase of a primary home; (3) stop eviction from primary home, or stop foreclosure on such home; (4) payment of tuition, related educational fees, and room and board expenses for up to the next 12 months of post-secondary education of the participant, spouse, children, or dependents defined in the Plan; (5) burial or funeral expenses for a deceased parent, spouse, child, or dependents defined in the Plan; and (6) expenses to repair damage to primary home that would be tax deductible. To comply with certain requirements of the SECURE Act and IRS regulations, the Plan has waived certain aspects of the substantiation rule, and the six-month elective deferrals suspension rule for hardship distributions.

### Forfeitures

Forfeitures represent the portion of nonvested benefit payments remaining in the Plan for all terminated employees. Forfeitures may first be used to pay administrative expenses then to reduce employer matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$711 and \$690, respectively. During 2024, newly forfeited nonvested account balances net of gains and losses totaled \$44,315 and the Plan used \$44,294 to reduce employer matching contributions.

### **2. Summary of Significant Accounting Policies**

#### Date of Management's Review and Subsequent Events

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure through September 22, 2025, which is the date the financial statements were available to be issued.

#### Basis of Accounting

The financial statements of the Plan are presented on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with a basis of accounting other than GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Certain investments of the Plan are collective trust funds in a fully benefit-responsive investment contract reported at net asset value ("NAV") based on the fair value of the underlying investments of the trust as a practical expedient to estimate fair value in arriving at net assets available for benefits. In accordance with ASC 820-10, such investments are excluded from the presentation of the fair value disclosures for financial instruments, at Note 5. These investments are presented as collective trust funds, at net asset value in the accompanying financial statements and are further discussed in the disclosure of investment contract with Reliance Trust Company at Note 4.

Certain investments of the Plan are mutual funds reported at fair value based on observable market quotations. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. These investments are presented as mutual funds, at fair value in the accompanying financial statements and are further discussed in the disclosure of fair value measurements at Note 5.

The net appreciation in value of investments consists of the realized gains and losses from sales of investments and unrealized appreciation (depreciation) of investments. The net change in unrealized appreciation (depreciation) in the value of investments is determined by the change in value from the beginning of the year to the end of the year or change in value from date of the purchase to the end of the year.

Purchases and sales are recorded on a trade date basis. Interest income and dividends are recorded when received.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

The fair value disclosures for financial instruments are not required for participant loans. Also, participant loans continue to be considered as investments for Form 5500 reporting purposes.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Excess Contribution Refunds

The Plan records refunds of excess contributions when paid. Any excess contribution refunds are reported as corrective distributions on the accompanying statement of changes in net assets available for benefits. During 2024, the Plan had no corrective contributions to report.

### Administrative Expenses

Officers or employees of the Company perform certain administrative functions of the Plan. However, such officers and employees receive no compensation from the Plan. Administrative expenses of the Plan paid by the Company are excluded from these financial statements.

### **4. Investment Contract with Reliance Trust Company**

The Plan entered into a fully benefit-responsive investment contract with Reliance Trust Company, the Plan custodian and agent for the trustee (ADP, Inc.). The Federated Hermes Capital Preservation Fund (the "Fund") sponsored by Reliance Trust Company is a stable value fund in a collective investment trust fund that is managed by Federated Investors Trust Company. The Fund is comprised of a money market mutual fund, guaranteed investment contracts (traditional GICs), separate account guaranteed investment contracts (separate account GICs), and synthetic guaranteed investment contracts (synthetic GICs) which are intended to maintain a constant net asset value ("NAV") of \$10 per unit. Each of the separate account GICs and synthetic GICs have a wrap contract that provides a minimum guaranteed rate of return for the term of the contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the Fund, plus credited earnings, less participant withdrawals.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. However, the guaranteed investment contract is presented on the statements of net assets available for benefits at NAV based on the fair value of the underlying investments of the trust as a practical expedient to estimate fair value in arriving at net assets available for benefits. Fair value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses adjusted to fair value using a factor determined by Reliance Trust Company. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The NAV of the investment contract at December 31, 2024 and 2023 was \$738,611 and \$645,382, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Federated Investors Trust Company. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

**5. Fair Value Measurements**

ASC Topic 820, *Fair Value Measurements and Disclosures* establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three broad levels of the fair value hierarchy are as follows:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.
- Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1).
- Level 3 inputs consist of unobservable inputs and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs are not available. All Plan investments subject to fair value measurements disclosure under ASC Topic 820 required the use of Level 1 inputs for the periods presented.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

### 6. Related Party and Party-In-Interest Transactions

Certain plan investments are units of collective trust funds sponsored and managed by Reliance Trust Company. Reliance Trust Company is the Plan custodian and agent of the Plan trustee (“ADP, Inc.”) as defined by the Plan. Therefore, the transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in investment income, as they are paid through investment revenue sharing arrangements rather than direct payment arrangements.

Plan transactions and recordkeeping functions are also administered by ADP, Inc., the Plan trustee. Therefore, ADP, Inc. is a party-in-interest under ERISA and transactions with ADP, Inc. qualify as party-in-interest transactions. During 2024, the Plan paid \$8,586 in record keeping fees to ADP, Inc. These fees are presented as Administrative expenses on the accompanying statement of changes in net assets available for benefits.

ADP Broker-Dealer, Inc. is a party-in-interest under ERISA and transactions with ADP Broker-Dealer, Inc. qualify as party-in-interest transactions. ADP Broker-Dealer, Inc. receives indirect compensation from the investment product companies affiliated with the Plan Trustee. Indirect compensation paid to ADP Broker-Dealer, Inc. for brokerage services is included in net appreciation (depreciation) in fair value of investments within the Investment income caption on the accompanying statement of changes in net assets available for benefits, as they are paid through investment revenue sharing arrangements rather than direct payment arrangements.

Focus 401(k) Group is the Plan’s third-party investments adviser as defined by the Plan. Therefore, Focus 401(k) Group is a party-in-interest under ERISA and transactions with Focus 401(k) Group qualify as party-in-interest transactions. Investment advisory and management service fees of the Plan are paid by the Company and are therefore, not disclosed, not included, and not accrued on the accompanying financial statements.

Payne & Smith, LLC is the Plan’s independent public accountant (“IPA”) as defined by the Plan. Therefore, the IPA is a party-in-interest under ERISA and transactions with the IPA qualify as party-in-interest transactions. Fees incurred by the Plan for audit and nonattest services provided by the IPA are paid by the Company and are therefore, not disclosed, not included, and not accrued on the accompanying financial statements.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**8. Tax Status**

The Plan sponsor is an adopter of a pre-approved plan that received a favorable Internal Revenue Service (“IRS”) Opinion Letter dated October 6, 2020, in which the IRS stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended and restated since receiving the Opinion Letter, the Plan Administrator believes this Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax period in progress.

**9. Plan Termination**

While there is no intention to do so, the Company reserves the right to terminate the Plan. In the event of termination of the Plan, the participants become fully vested in their employer contribution balances, and the net assets of the Plan will be distributed to the participants of the Plan in accordance with the provisions of ERISA.
