Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ATW Companies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of ATW Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan, covering substantially all employees of ATW Companies, Inc., A.T. Wall Company, Parmatech Corporation, Judson A. Smith Company, and Parmatech 3D, Inc. (collectively referred to as the Companies) who have completed three consecutive months of service and are eighteen years of age or older. Employees of the Companies are eligible for participation in the Plan upon the completion of the age and service requirements on the first day of the following month. The plan sponsor is ATW Companies, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Automatic Enrollment

The Company has elected to utilize an automatic enrollment policy. Participants become automatically enrolled into the Plan, after meeting eligibility requirements, unless the eligible participant specifically opts out of the Plan. Participants are automatically enrolled in the Plan at 6% of their eligible compensation, as defined in the plan agreement.

Automatic Deferral Increase Provision

Unless participants affirmatively elect otherwise, participants with a deferral rate greater than or equal to 6% will have their deferral rate increased annually by 1%, as a pre-tax deferral contribution, until a deferral rate of 10% is reached.

Contributions

Each year, participants may contribute up to 80% of pretax annual compensation, as defined in the plan agreement, not to exceed the dollar limitations imposed by the Internal Revenue Service (IRS). The Plan also allows participants to make elective Roth (after tax) deferrals, limited to the maximum allowed IRS contribution limit less any pre-tax contributions made. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common/collective trust as investment options for participants. The Company contributes 50% of the participant's contribution up to the greater of 6% of compensation or \$4,000. There are no employer matching contributions on participants' catch-up contributions.

The Company may elect to make discretionary profit-sharing contributions in an amount determined annually by management. The discretionary profit-sharing contribution is allocated to eligible participants based on an integrated allocation formula as defined in the plan agreement. The Company did not elect to make a profit-sharing contribution during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts is based on years of continuous service. Vesting occurs in 20% increments each year commencing upon completion of one year of service. A participant is 100% vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have no more than one outstanding loan from the Plan at any time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. As of December 31, 2024, interest rates on notes receivable from participants ranged from 4.25% to 10.50%. Principal and interest is paid ratably through either payroll deductions for current employees, a minimum of quarterly installments for non-employees (participants on leave of absence from employment) or a lump-sum payment from any participant at any time. Upon termination from the Companies, all outstanding principal and interest is due immediately.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant, or their beneficiary, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic installments. In addition, the participant shall be entitled to receive any discretionary Company contributions made to the Plan on their behalf for the plan year in which retirement, death or disability occurred. For

termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Upon termination, if a participant's vested account balance does not exceed \$7,000 and the participant does not elect to take a distribution, the plan administrator may make a lump-sum distribution to a direct rollover individual retirement account.

Early Withdrawals

Prior to termination of employment, disability or death, participants may make in-service distributions from their accounts upon attainment of age 59½ in an amount up to 100% of the vested portion of their account attributable to all contributions, or in the event of a serious financial hardship, up to 100% of the vested portion of their account attributable to their salary deferral contributions, as defined in the plan agreement.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$32,000 and \$7,000, respectively. These accounts will be used to reduce future administrative expenses or employer contributions. Also, during the year ended December 31, 2024, employer contributions were reduced by approximately \$64,000 from forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies utilize information provided by

Reliance Trust Company, the Trustee of the Plan. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based upon the terms of the plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. The Plan receives plan servicing credits from various funds the Plan is invested in. Such credits are used to reduce administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. TRANSACTIONS WITH PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor (DOL) Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. For the year ended December 31, 2024, the Companies paid certain administrative expenses. Certain employees and officers of the Companies, who are participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

6. TAX STATUS

The Plan has adopted a prototype plan sponsored by ADP Retirement Services (ADP). ADP has received an opinion letter issued by the National Office of the IRS dated October 6, 2020 that the Plan is qualified under IRS Section 401. The Plan may request its own determination letter from the appropriate District Director of the IRS. The Company has not, to date, made such a request. The Plan has also been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). Therefore, a provision for income taxes has not been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and DOL; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value

of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. PLAN FINANCIAL INFORMATION CERTIFIED BY TRUSTEE

Effective January 1, 2025, the Companies appointed ADP Retirement Trust Services, LLC as the Plan's trustee, at which time Reliance Trust company resigned as the Plan's trustee.
