Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Their report dated October 10, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States or America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Associated Materials LLC 401(k) Retirement Plan (the “Plan”) provides general information only. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

Description

The Plan is a defined contribution plan covering all employees of Associated Materials LLC (“AMI,” the “Employer,” and “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974, as amended (“ERISA”).

Eligibility

All employees of the Plan Sponsor are eligible to participate once they attain the age of 18 and complete three months of service. Any interim or temporary Chief Executive Officer, temporary or seasonal employee, or employee covered under a collective bargaining agreement which provides for retirement benefits that have been the subject of a good faith bargaining (except as specified below) are excluded from the Plan. An employee may begin to participate the first day of the month following the date on which such requirements are satisfied. Should any interim or temporary Chief Executive Officer or seasonal or temporary employee actually complete a year of service, then such employee will no longer be excluded. All union employees are eligible to participate except union employees employed at the Woodbridge, New Jersey location hired before March 1, 2006.

Contributions

Participants can elect to contribute up to 80% of their pre-tax compensation as limited by the Internal Revenue Service (“IRS”). Contributions are made to the Plan and then allocated to the individual participants’ accounts. The Plan includes a qualified automatic contribution arrangement (“QACA”). The initial deferral rate under the QACA is 3% and for employees participating in this feature, their deferral rate will increase at the beginning of each year by 1% until the max of 15% has been reached. Participants are able to opt out of the auto enroll or auto increase feature.

The Plan has a QACA safe harbor matching contribution in an amount equal to 100% of eligible compensation on the first 1% of elective deferral plus 50% of eligible compensation on the next 2% through 6% for their elected deferral. Eligible Woodbridge Union Employees and Premium Union Employees are excluded from the QACA safe harbor matching contributions. In accordance to their respective collective bargaining agreements, Woodbridge Union Employees receive a match in an amount equal to 100% of the first 4% of eligible compensation deferred. Premium Union Employees are not entitled to a matching contribution unless they were (1) hired or rehired after November 4, 2013 or (2) were employed on November 4, 2013 and irrevocably elected to cease benefit accruals after December 31, 2013 in the Premium Building Products Company Hourly Employees Pension Plan. For Premium Union Employees are eligible for match the match amount is equal to 100% for the first 4% of eligible compensation deferred. The Employer may also make a discretionary matching contribution. The Plan was amended effective January 1, 2021, to reinstate the safe harbor matching contribution that had previously been suspended by an amendment effective May 1, 2020.

Notes Receivable from Participants

The Plan allows participants to apply for and obtain loans against their participant's accounts. Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance, with a minimum loan amount of \$500. A participant may only have one loan outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at Prime plus one percent at the time of the note. Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Payments of principal and interest are paid through payroll deductions and credited to the participant's account. Interest rates on loans outstanding ranged from 4.00% to 9.50% and loan terms that range from 1 to 30 years as of December 31, 2024.

Delinquent loans are reclassified as distributions based-upon terms in the Plan document. Interest income is recorded on accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Notes are in default when payments are not made by the end of the calendar quarter following the quarter in which the payment was due, or the participant makes or furnishes any false representation or statement to the Plan. In the event of default, the entire outstanding note balance, consisting of the missed payments, remaining principal, and all accrued but unpaid interest, will remain as the participant's obligation. Participants have the opportunity to repay the loan or to resume current status by paying all missed payments. If distribution is or becomes available under the Plan, the participants vested balance will be offset by the outstanding loan balance and deemed a distribution as permitted by law.

Vesting and Forfeitures

Employees are 100% vested in their elective deferral accounts at all times. All eligible participants will be 100% vested in employer contributions after two years of service. QACA safe harbor contributions are fully vested after two years of service. Forfeitures relating to matching contributions are added to the employer matching contributions and allocated as an additional matching contribution or may be applied toward Plan expenses. The amount of forfeited by participants who terminate employment prior to becoming fully vested may be used to reduce subsequent employer contributions or pay administrative expenses. For the year ended December 31, 2024, employer contributions were reduced by \$514,157 from forfeited non-vested accounts. At December 31, 2024 and 2023, unused forfeitures totaled \$81,959 and \$90,056, respectively.

Investment Options

Participants direct the investment of all elective and company contributions into various investment options offered by the Plan.

Participant Accounts

A separate account is maintained for each participant in the Plan, inclusive of contributions, investments, investment gains and losses, withdrawals, transfers and both investment and administrative fees. Each participant's account is re-valued daily.

A participant may elect to invest contributions and transfers in any combination of the funds. Participants can change their investment direction or transfer funds directly through the Plan Administrator or via ADP ("Custodian") online website.

All dividends, interest and other proceeds received with regard to any fund will be reinvested automatically in the same fund.

Participant vested amounts are payable upon retirement, death, or other termination of employment. Distributions may be made in the form of a direct rollover, lump-sum cash distribution or periodic payments over the participant's lifetime. Distributions are to begin as soon as administratively feasible.

Payment of Benefits

A participant or his or her beneficiary may receive a lump sum payment or periodic payments of his or her vested account balance upon retirement, disability, termination, or death prior to retirement. Participants may also withdraw amounts from their accounts under certain defined conditions.

Participants may not request or receive an in-service distribution of the Employer match contribution made under the QACA until the participant reaches the age of 59 ½ but may request such a distribution following termination or death. Benefit payments are recorded when paid.

Hardship Withdrawal of Funds

A participant may withdraw an amount from his or her elective deferral account or rollover account to make a down payment on a principal residence, to pay post-secondary education expenses for a member of the participant's household, or to pay other expenses that create a hardship. The participant must have an immediate and heavy financial need that cannot otherwise be met. Participants making withdrawals cannot make contributions to the Plan for six months following the hardship withdrawal. The withdrawal must be requested in writing by the participants, and it is subject to approval by the Plan Sponsor.

Administrative Expenses

The Plan pays expenses incurred in the administration of the Plan from the Plan's assets, unless paid by the Plan Sponsor. Expenses paid to the Custodian are accounted for as a reduction in investment earnings.

Termination Provisions

Although the Plan Sponsor has not expressed any intent to terminate the Plan, they reserve the right to do so at any time. In the event of termination, the accounts of the participants will be distributed in a manner determined by the Plan Administrator and in accordance with the provisions of the Plan. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported

amounts of assets and liabilities at the date of the financial statements and reported amounts of revenue and expenses during the reporting period. Actual results could differ from these estimates.

Fair Value Measurements

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Investment Valuation

The Plan's Registered Investment Companies are stated at fair value at December 31, 2024. Gains and losses on investments that were purchased, sold or held during the year are included in net appreciation in fair value of investments. Purchases and sales of securities are reported on a trade date basis. Dividend income is recorded on the ex-dividend date. In accordance with the policy of stating investments at market value, net appreciation or depreciation (including gains and losses on assets sold during the year and unrealized gains and losses on assets held) for the year is reflected in the statements of changes in net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

NOTE 4 – INVESTMENTS

The Plan's investments are participant-directed accounts that are held by the Custodian.

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

Assets measured at fair value on a recurring basis as of December 31, 2024 and 2023 are as follows:

- Registered Investment Companies: The Plan's investments in registered investment companies are valued at quoted market price, which represent the net asset value ("NAV") of shares held by the Plan at year-end.
- Collective Trust Funds: The Plan holds an investment in the Putnam Stable Value Fund ("Stable Value Fund"), a fund that invests in fully benefit-responsive investments (indirect FBRIC). The fair value of the Stable Value Fund is based on the NAV of the unit value of the fund which is based on the fair value of the underlying investments. The NAV, as provided by Reliance Trust Company ("Trustee"), is used as a practical expedient to estimate fair value for the fund. This NAV represents the fund's fair value since this is the amount at which the Plan transacts with the fund. The Stable Value Fund attempts to maintain a stable price per unit of \$1. The Stable Value Fund primarily invests in traditional guaranteed investment certificates, insurance separate accounts, and money market instruments. The Stable Value Fund's value represents invested principal plus accrued interest earned thereon.

All of the contracts that the Stable Value Fund purchases are benefit-responsive at contract value for all plan permitted, participant-directed transactions. Additionally, the Stable Value Fund negotiates contracts with certain employer-initiated transaction provisions including percentage allowances for targeted layoffs, bankruptcy resulting in employee job loss, reorganizations, spin-offs, and plan terminations. The only event or circumstances that would allow issuers to immediately terminate a fully benefit-responsive wrap contract with the Stable Value Fund at an amount different from contract value would be if they were provided with willingly fraudulent information about the Stable Value Fund by the Trustee.

The Plan also holds an investment in GGT Euro Pacific Growth, MFS Mid Cap Value Fund, Loomis Sayles Core Plus Fixed Income C Fund, and John Hancock Disciplined VALP. The fair value of these funds is based on the NAV of the unit value of the fund of which is based on the fair value of the underlying investments. The NAV, as provided by Reliance Trust Company ("Trustee"), is used as a practical expedient to estimate fair value for the fund. This NAV represents the fund's fair value since this is the amount at which the Plan transacts with the funds.

NOTE 5 – TAX STATUS OF THE PLAN

The IRS has issued an opinion letter dated July 16, 2014, stating that the prototype plan used by the Plan was designed in accordance with applicable sections of the Code. The Plan has been amended since the opinion letter was issued. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers and employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Notes receivable from participants qualify as party-in-interest transactions.

NOTE 7 – RISKS AND UNCERTAINTIES

Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit.
