Report of Independent Auditor

Scope and nature of the ERISA Section 103(a)(3)(c) audit

We have performed audits of the accompanying financial statements of ShopLC Global, Inc. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and December 31, 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024, and December 31, 2023, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024, and December 31, 2023, and for the years ended December 31, 2024, and December 31, 2023, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s responsibilities for the audit of the financial statements section —

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America

(GAAS). Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1: DESCRIPTION OF PLAN

The following description of the ShopLC Global, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement or summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established and effective on February 1, 2000. On April 20, 2011, the age and years of service requirements described below for eligibility purposes were waived for all employees of ShopLC Global, Inc. (“the Company/ Plan Administrator”). On February 6, 2017, the Plan was amended to so that employees may be eligible after one month of service and can enter the Plan on the first day of each month. The Plan provides for a qualified cash or deferred arrangement described in Section 401(k) of the Internal Revenue Code (the “Code”).

Investments and investment options

Upon enrollment in the Plan, a participant may direct employee and safe harbor contributions in any combination of investment options. The investment options consist of thirty mutual funds and one stable value common trust fund. Participants may change their investment options at their discretion.

Contributions

Participants may contribute a percentage of their annual compensation, up to 60%, with the contributions and earnings thereupon being nontaxable until withdrawn from the Plan. Participants may also rollover amounts representing distributions from other qualified plans.

Effective May 01, 2023, the Plan was amended to permit after-tax voluntary employee contributions up to 60% of Compensation and to allow In-Plan Roth rollover contributions as per the IRR (In-Plan Roth Rollover contribution) and IRT (In-Plan Roth Rollover transfer) provisions.

Effective January 01, 2022, the Plan was amended to provide employer match safe harbor contributions. The Company will contribute an amount equal to the sum of 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation.

The Company also has the option to make contributions towards the Plan participants accounts at its discretion subject to limitations under the Internal Revenue Code (“IRC”).

Participant accounts

Each participant’s account is credited with the participant’s deferral contribution, the Company’s safe harbor contribution, and earnings of the participant’s individual account. Allocations are based on participant compensation as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting

Participants are immediately 100% vested in their deferral contributions, after-tax voluntary employee contributions, and safe harbor contributions. The Company's discretionary matching contribution becomes vested based on the participants' number of years of service with the Company according to the following schedule for the year ended December 31, 2024, and December 31, 2023:

Benefit payments

Upon separation of service, due to death, disability, or retirement, a participant will receive their benefits as a lump-sum amount equal to the value of the participant's vested interest. Participants can request a distribution from the Plan of their vested interest in the Plan before termination if they satisfy financial hardship criteria. Effective December 01, 2023, hardship withdrawals may not be taken to pay for foreign medical bills. Participants will receive their benefits as a lump-sum amount equal to the value of the participant's vested interest.

Forfeitures

The Company may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. Forfeitures of terminated employees' non-vested accounts totalled \$NIL during the year ended December 31, 2024, and \$NIL during the year ended December 31, 2023. As of December 31, 2024, and December 31, 2023, unvested forfeited accounts totalled \$26,673 and \$7,241, respectively. During the years ended December 31, 2024, and December 31, 2023, \$6,662 and \$NIL, respectively, were utilized to pay administrative expenses.

Notes receivable from participants

Participants may borrow from their deferral contributions fund account from a minimum of \$500 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local borrowing rates. Current interest rates range from 4.25% to 9.50%. Loan repayments are made ratably through payroll deductions over a period not to exceed five years unless the loans were used to purchase a primary residence, in which case the loan terms may exceed five years.

Administration

Administrative costs and expenses, including legal, annual per participant fee, minimum combined annual recordkeeping and trustee fee, package nondiscrimination testing, compensation testing, and return of excess contributions, are paid out of the Plan unless paid directly by the Company.

Termination

The Company expects to continue the Plan indefinitely, but by resolution of its Board of Directors, reserves the right to terminate the Plan. If the Plan were terminated, the accrued benefit accounts for each participant would

become fully vested and non-forfeitable. Such accrued benefit accounts will be held under the Plan to be distributed as provided in the Plan upon death, retirement, or termination.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting and present the net assets available for benefits and changes in those net assets.

Use of estimates in financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant's loan to be in default, the loan balance is reduced, and the delinquent participant's note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment valuation and income recognition

The Plan's investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of credit risk

The Plan's participants are employed in the retail jewellery, beauty, fashion accessories, and home decor industries located in the Austin, Texas, metropolitan area. All of the Plan's safe harbor contributions and contributions receivable are from two contributing employers located within the Austin metropolitan area. The two contributing companies are STS Jewels, Inc. and ShopLC Global, Inc.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near

term, and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

NOTE 5: FAIR VALUE MEASUREMENTS

The Plan follows the provisions of FASB Accounting Standards Codification ("FASB ASC 820") Fair Value Measurements, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted market prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024, and December 31, 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year-end.

Common/collective trusts: Units held in common/collective trusts ("CCT") are valued using the NAV practical expedient of the CCT as reported by the issuer of the CCT. The NAV practical expedient is based on the fair value of the underlying assets owned by CCT, minus its liabilities, and then divided by the number of units outstanding. The CCT may be redeemed at NAV daily without restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7: INCOME TAX STATUS

For the years ended December 31, 2024, and December 31, 2023, ShopLC Global, Inc. (“the Company/ Plan Sponsor”) entered into a non-standardized arrangement with ADP, LLC, Non-Standardized Pre-Approved Profit-Sharing Plan Money Purchase (“CODA”). ADP, LLC has received an opinion letter from the Internal Revenue Service (“IRS”) dated October 06, 2020, which stated that the form of the non-standardized pre-approved profit-sharing plan and related trust was designed in accordance with applicable sections of the IRC. It is the opinion of the Plan trustee and the Plan’s attorney that the Plan is in compliance with all applicable laws and regulations.

U.S. generally accepted accounting principles require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, and December 31, 2023, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8: PARTY-IN-INTEREST TRANSACTIONS

The Company serves as the Plan administrator. The Plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations

regarding questions that may affect eligibility for benefits. For the years ended December 31, 2024, and December 31, 2023, the Plan administrator engaged ADP Retirement Services (“ADP”) as a third-party plan administrator to assist in the administration of the Plan.

For the years ended December 31, 2024, and December 31, 2023, Reliance Trust Company served as trustee of the Plan pursuant to the Plan agreement. The trustee received all contributions made under the Plan and held Plan assets.

The Plan trustee manages certain Plan investments; therefore, these transactions qualify as party-in-interest transactions. Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses of the Plan are paid by the Company on behalf of the Plan. These qualify as an exempt party-in-interest transaction. Party-in-interest transactions also include loans made to participants.

NOTE 9: BENEFIT PAYMENTS

As of December 31, 2024, and December 31, 2023, no benefit payment requests were processed at the end of the period and were distributed in the subsequent period.

NOTE 10: SUBSEQUENT EVENTS

The Plan evaluated all events and transactions that occurred after December 31, 2024, through the date the financial statements were available to be issued. Based on the evaluation, the Plan states that effective January 01, 2025, the Plan has appointed ADP Retirement Trust Services, LLC (“ADP Trust”) as the Plan’s Trustee upon the resignation of Reliance Trust Company on December 31, 2024.
