### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Crimson Midstream Services, LLC 401(K) Profit Sharing Plan, (the Plan) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Crimson Midstream Services, LLC 401(K) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan covers substantially all employees of Crimson Midstream Services, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's Sponsor and serves as the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan as well as determining and reviewing the appropriateness of the Plan's investment offerings.

The Plan is a defined contribution plan under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan became effective on January 1, 2017 and was restated on July 1, 2022. The Company contracted with Reliance Trust Company (Reliance), an agent of ADP Retirement Services, to serve as the Custodian and Trustee of the Plan's assets. Effective January 1, 2025, the Company contracted with ADP Retirement Trust Services, LLC (ADP Trust), an agent of ADP Retirement Services, to serve as the Custodian and Trustee of the Plan's assets. The Company contracted with Automatic Data Processing (ADP) to serve as the Plan's recordkeeper.

**Eligibility**

Generally, an employee is eligible to participate in the Plan upon attaining age 21 and completion of 3 consecutive months of service. Plan entry dates are on the date on which the employee satisfies the eligibility requirements.

**Participant Contributions**

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 4% with an annual rate increase of 1% not to exceed 10% of compensation, unless the participant affirmatively elects otherwise.

Participants that affirmatively elect otherwise may contribute up to 90% of their annual compensation as pre-tax, and/or after-tax Roth contributions, as defined in the Plan up to the maximum allowed by the IRS limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum allowed by IRS limitations. Participants may also contribute amounts representing rollover distributions from other qualified plans.

**Employer Contributions**

The Company makes non-elective safe harbor matching contributions equal to 100% of employee deferrals that do not exceed 5% of employee eligible annual compensation cumulatively.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings or losses and administrative expenses are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investments**

Participants direct the investment of all assets attributable to their account. Each participant designates the percentage of any one or more of their accounts that is to be invested in each of several authorized investment funds designated by the Plan Administrator.

### **Notes Receivable from Participants**

The Plan allows participants to borrow against their vested account balances. Loans may not be made for less than \$1,000 and may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at Prime plus 1% for the duration of the loan. Principal and interest is paid ratably through payroll deductions not to exceed five years unless the loan proceeds are used to acquire a principal residence. A participant may only have one outstanding loan at any time.

### **Payment of Benefits**

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum distribution, annuity, direct rollover to an individual retirement account (IRA) or to another employer's tax qualified plan. Active participants may withdraw part of their account in a single sum in the event of undue financial hardship or attainment of age of 59½. If a terminated participant's account balance is \$5,000 or less, the Plan may distribute the account balance to an IRA without prior approval of the participant.

### **Vesting and Forfeitures**

Participants are immediately 100% vested in their contributions plus actual earnings thereon and Safe Harbor matching contributions. Non-vested forfeited account balances at December 31, 2024 and 2023 were \$64 and \$54, respectively. During the year ended December 31, 2024, no forfeitures were used by the Company.

### **Administrative Expenses**

Fees related to the administration of loans or distributions are deducted from the related participant's account and are included in administrative expenses. Certain expenses of the Plan are paid by the Company and excluded from these financial statements. Other expenses of the Plan are deducted on a pro rata basis from participant accounts and are included in these financial statements.

Certain investment management fees and other charges paid to the Custodian and Trustee are offset against fund performance in the net appreciation section of the Statement of Changes in Net Assets Available for Benefits and are not, therefore, separately reflected as investment expenses.

**Plan Termination Provision**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants become fully vested in their accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (GAAP). Employee and employer contributions are recognized in the year that contributions were due.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policy utilizing information provided by the Plan Trustee/Custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as a distribution

based upon the terms of the Plan document. Interest income is recorded on the accrual basis. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded.

**NOTE 3 - FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily closing price and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*The Reliance Trust Company Stable Value Fund*, Collective Investment Trust, Series 25053 (the “Fund”) is a collective investment trust where units of each share class of the Fund are valued daily at net asset value (“NAV”) as of the close of trading on the New York Stock Exchange. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding. Investment income earned is reinvested in the Fund and included in the determination of unit values.

The Contracts are presented at fair value. Since the Contracts are fully benefit-responsive, an adjustment from fair value to contract value is presented in the Statement of Net Assets. The fair value of the Contracts is determined by MetLife based on quoted market prices of the underlying investments. The contract value represents contributions plus interest, less participant-initiated withdrawals.

The Contracts are fully benefit-responsive, and participant-directed withdrawals are paid at contract value. Employer- or plan sponsor-initiated withdrawals, or withdrawals due to plan termination, may be subject to market value adjustments if the fair value of the Contracts is less than the contract value.

The Fund’s investments are measured at fair value using Level 2 inputs (observable market data) for the Contracts and Level 3 inputs (unobservable inputs) for the wrapper contracts. The fair value to contract value ratio as of December 31, 2024, was 87.99%.

**NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN AND TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the Custodian and Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments, contribution receivables and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, interest, expenses and interest income on notes receivable from participants reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments and notes receivable from participants are managed by Reliance Trust Company. Reliance Trust Company is the Custodian and Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Plan administrative service providers and investment advisor fees are paid by the Plan and are therefore considered exempt party in-interest transactions.

**NOTE 6 - TAX STATUS**

The IRS has informed the Plan sponsor by a letter dated October 6, 2020 for the prototype plan adopted by the Plan, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant's account balances and the amounts reported in the accompanying financial statements.
