NOTE A - DESCRIPTION OF THE PLAN

The following description of the Hansgrohe, Inc. Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General.* The Plan is a defined contribution plan covering all eligible employees of Hansgrohe, Inc. (the “Company” and Plan “Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions.* Each year, participants may contribute the maximum percentage allowable not to exceed the limits set by applicable law, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows for Roth elective deferrals. Roth elective deferrals are included in the participant’s gross income and at the time deferred are irrevocably designated as Roth elective deferrals by the participant. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The employer has elected to contribute to the Plan by matching half of the employee deferral up to a maximum of six percent. The maximum employer matching contribution will be three percent of the employees’ salary or wages.

*Participant Accounts.* Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Investments* – Participants direct the investment of their contributions into various investment options offered by the Plan. Company contributions are invested in the same investment options as the participant’s contribution elections.

*Vesting.* Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer discretionary contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant must complete 4 years of service to receive 100% of the employer discretionary account.

*Payment of Benefits.* On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service due to other reasons and the vested balance is greater than \$1,000 but less than \$5,000, and the participant has not requested a distribution, the entire vested balance of the participant’s account shall be paid as a direct rollover to an individual retirement account designated by the Plan Administrator. If the vested balance is greater than \$5,000, the participant has the option not to receive a distribution, and therefore, distributions will not be made until requested by the participant. The Plan allows for in-service withdrawals when a participant turns age 59 ½ as well as withdrawals in the event of financial hardship under certain conditions. At age 70 ½, 72 or 73 (depending on when a participant was born) and separated from service, a portion of the balance will be required to be distributed each year.

*Administrative Expenses.* Administrative expenses of the Plan are shared by the Plan and Plan sponsor.

*Forfeited Accounts.* Participants who leave the Plan may forfeit certain amounts. Forfeitures of employer contributions will occur based on unvested amounts and are used by the plan to reduce future employer contributions. During the year ended December 31, 2024 the Company used \$48,649 in forfeitures to reduce the employer match contribution amount. Unapplied forfeitures totaled approximately \$4,702 and \$4,555 at December 31, 2024 and 2023, respectively.

*Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates range from 5.25% to 10.50%. Principal and interest is paid ratably through bi-weekly payroll deductions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting.* The financial statements of the Plan are prepared under the accrual method of accounting generally accepted in the United States of America.

*Investment Valuation and Income Recognition.* The Plan holds investments in mutual funds and in a common/collective trust. The Plan's investments are stated at fair value with the exception of the fully benefit-responsive investment contract, which is carried at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as during the year.

*Use of Estimates.* The preparation of financial statements in conformity with accounting principles generally accepted in the United State of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Payment of Benefits.* Benefits are recorded when paid.

*Administrative Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE C – FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability in the principal market for the asset or liability in an orderly transaction between market participants on the measurement date. U.S. GAAP establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. U.S. GAAP prescribes three levels of inputs that may be used to measure fair value:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices of identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE D – INVESTMENT REPORTED AT CONTRACT VALUE

The Plan holds an investment in a fully benefit-responsive stable value fund. The stable value fund is a common/collective trust measured at contract value. The common/collective trust is a comingled pool which allows only participant-directed qualified defined contribution plans to invest in the fund. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's constant net asset value (NAV) of \$1 per unit. Distribution to the Fund's unit holders are declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable net asset value of \$1 per unit; although there is no guarantee that the Fund will be able to maintain this value.

The trust invests in underlying assets typically fixed income securities or bond funds and money market funds to provide daily liquidity. The trust also invests in wrap contracts issued by insurance companies and other financial institutions for a fee. The common/collective trust is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer of the wrap contract guarantees a minimum rate of return and provides full benefit responsiveness, provided that all terms of the wrap contract have been met.

There were no reserves against the wrap contracts' carrying values due to credit risks of the issuers. The crediting interest rates for the wrap contracts are based upon a formula agreed upon with the issuer, with the requirement that interest rates may not be less than zero percent. Certain events limit the ability of the Plan to transact at contract value with the wrap issuer. However, the Plan's management is not aware of the occurrence or likely occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants. The issuer may terminate a wrap contract at any time. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. The average yield earned was 3.05% for 2024.

NOTE E – TAX STATUS

Effective March 23, 2022, the Plan was amended and restated by adopting a volume submitter profit sharing plan with a 401(k) feature through Automatic Data Processing Company. The volume submitter plan has received a favorable opinion letter dated October 6, 2020 stating that the form of the plan is acceptable under section 401 of the Internal Revenue Code. The plan has been amended since receiving the opinion letter. However, the plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F – PLAN TERMINATION

The Company has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.
