## INDEPENDENT AUDITORS' REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Chinn Enterprises, Inc. Profit Sharing and 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from qualified institutions as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities section of our report. We are required to be independent Chinn Enterprises, Inc. Profit Sharing and 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. **1. PLAN DESCRIPTION:**

The following description of the Chinn Enterprises, Inc. (the “Company”) Profit Sharing and 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General –

The Plan is a defined contribution plan covering all non-union participants of the Company who have completed one year of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan custodian and trustee change –

Effective June 1, 2023, ADP Retirement Services, the current custodian, and Reliance Trust Company, the current trustee, replaced Empower Annuity Insurance Company of America, the former custodian, and Empower Trust Company, LLC, the former trustee. The Plan was amended and restated effective May 1, 2023, to adopt the Automatic Data Processing Non-Standardized Defined Contribution Plan.

Contributions –

Participants can elect to make pre-tax contributions to the Plan by means of a salary deferral agreement of an amount not to exceed limits determined by the Internal Revenue Service (“IRS”). If an employee fails to make an election within 90 days of their initial participation date, they will be deemed to have elected to defer 5% of their compensation, until such election is modified or revoked.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company provides matching contributions equal to 50% of the first 3% of eligible compensation that a participant contributes and 25% of the next 2% of eligible compensation that a participant contributes to the Plan. Effective October 8, 2020, the Plan was amended to suspend matching contributions. Additional discretionary profit-sharing amounts may be contributed by the Company at the discretion of the Board of Directors. Contributions are subject to certain limitations. The Company made discretionary matching contributions to the Plan amounting to \$66,026 and \$4,000 for the years ended December 31, 2024 and 2023, respectively.

Roth 401(k) Contributions –

The Plan allows for Roth Elective Deferrals that are includible in participant’s gross income at the time deferred and have been irrevocably designated as Roth Elective Deferrals by the participant.

**1. PLAN DESCRIPTION: (Continued)**

Participant Accounts –

Each participant's account is credited with the participant's contributions, the Company's matching contribution and allocations of the Company's discretionary profit-sharing contribution, if any, administrative expenses and investment earnings. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account, as defined.

Vesting –

Participants are immediately vested in their pre-tax contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary profit-sharing contribution plus earnings thereon is based on years of continuous service. A participant vests 20% for each year of service and is 100% vested after five years of continuous service. Full vesting also occurs at age 65 or upon death or disability.

Investment Options –

Upon enrollment in the Plan, participants may direct investment of their account balances into a variety of investment options as more fully described in the plan literature. Participants may change their investment options on a daily basis.

Notes Receivable from Participants –

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at a time. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear a reasonable rate of interest based on the prevailing interest rates charged by persons in the business of lending money for similar loans at the time of loan origination. The interest rate on current loans range from 3.25% to 9.50%. Principal and interest are paid through payroll deductions.

Forfeitures –

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$14,956 and \$8,296, respectively. Forfeitures are used to reduce future Company contributions or pay plan expenses. During 2024, there were \$11,716 in forfeitures used to reduce Company contributions. During 2023, there were no forfeitures used to pay plan expenses or reduce Company contributions.

**1. PLAN DESCRIPTION: (Continued)**

Coronavirus Aid, Relief, and Economic Security Act –

The Plan has adopted certain provisions of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") that was signed into law on March 27, 2020, related to coronavirus-related distributions, suspended participant loan payments and increased loan limits, and waiver of required minimum distributions that were due during 2020. The Plan intends to formally execute the required plan amendments for these provisions by the last day of the plan year beginning on or after January 1, 2025.

Payment of Benefits –

On termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the vested value of the participant's account, installment payments or an annuity. The method of payment is subject to certain conditions and elections, as defined.

**2. SIGNIFICANT ACCOUNTING POLICIES:**

Basis of Accounting –

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition –

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for direct investments in fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to direct investments in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**2. SIGNIFICANT ACCOUNTING POLICIES:** (Continued)

Notes Receivable from Participants –

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the plan document.

Payment of Benefits –

Benefits are recorded when paid.

Operating Expenses –

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and therefore excluded from their financial statements. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account. Record keeping, administrative and investment advisory fees are paid by the Plan and included in administrative expenses and allocated to all participants' accounts.

Accounting Estimates –

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein. Actual results may differ from those estimates.

Credit Losses –

Financial assets measured at amortized cost are presented at the net amount expected to be collected and the measurement of credit losses and any expected increases in expected credit losses are recognized in earnings. The estimate of expected credit losses involves judgement and is based on an assessment over the life of the financial instrument taking into consideration current market conditions and reasonable and supportable forecasts of expected future economic conditions. The Plan determined the allowance for credit losses on financial assets measured at amortized cost was de minimis as of December 31, 2024 and 2023, therefore, no allowance for credit losses has been recorded related to those assets.

The information prepared by or derived from information provided by Reliance Trust Company, ADP Retirement Services, and Empower Annuity Insurance Company of America was furnished to the Plan Administrator.

The Plan Administrator has obtained a certification from Reliance Trust Company and Empower Trust Company, LLC that information provided to the Plan Administrator by Reliance Trust Company and Empower Trust Company, LLC related to the following assets and related income is complete and accurate based on their books and records. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets and income.

**4. INVESTMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodologies include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

**4. INVESTMENTS:** (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of Registered Investment Companies –

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units of Common/Collective Trust –

Valued based on the NAV of units of the common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Changes in Fair Value Levels –**

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. There were no transfers between levels and there were no purchases of Level 3 investments during the years ended December 31, 2024 and 2023.

**5. FORMER PARTICIPANT BALANCES:**

At December 31, 2024 and 2023, net assets available for benefits include \$1,715,100 and \$1,634,034, respectively, of vested balances relating to individuals who are no longer active participants in the Plan.

**6. GUARANTEED INTEREST ACCOUNTS WITH INSURANCE COMPANY:**

The Plan had entered into a fully benefit-responsive investment contract with Great-West Life & Annuity Insurance Company. The fully benefit-responsive guaranteed investment contract provided preservation of principal, maintains a stable interest rate, and provided daily liquidity at contract value for participant withdrawals and transfers in accordance with the provisions of the Plan. The fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. During the year ended December 31, 2024, the Plan disposed of guaranteed investment contract with Great-West Life & Annuity Insurance Company, receiving total proceeds of \$111,973.

The guaranteed rates of interest for 2024 and 2023 were 2.60% and 2.55%, respectively. For purposes of crediting interest to participants, the rates for 2024 and 2023 were 2.60% and 2.55%, respectively.

As described in Note 2, because the guaranteed investment contracts were fully benefit-responsive, contract value was the relevant measurement attributable for that portion of the net assets available for the benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

Certain events might limit the ability of the Plan or the participant to transact at contract value with the issuer, as defined in the contract. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date unless agreed upon by both parties.

**7. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

**8. RELATED PARTY AND PARTY-IN-INTEREST:**

Certain employees of the Company provide administrative services to the Plan. These employees do not receive any compensation from the Plan for their services. Certain other administrative fees are paid by the Company.

Reliance Trust Company is the Plan's trustee effective June 1, 2023 and, therefore qualified as a party-in-interest. Certain Plan assets are managed by Reliance Trust Company and its affiliates.

**8. RELATED PARTY AND PARTY-IN-INTEREST: (Continued)**

ADP Retirement Services is the Plan's recordkeeper effective June 1, 2023 and, therefore, qualifies as a party-in-interest.

Empower Trust Company, LLC was the Plan's trustee through May 31, 2023 and, therefore, qualifies as a party-in-interest.

Empower Annuity Insurance Company of America was the Plan's recordkeeper through May 31, 2023 and, therefore, qualifies as a party-in-interest.

Merrill Lynch Pierce Fenner & Smith is also a party-in-interest as it provided advisory services for the Plan during 2024. Merrill Lynch Pierce Fenner & Smith received fees for its Plan advisory services, which were paid by the Plan for the year ended December 31, 2024.

**9. TAX STATUS OF THE PLAN:**

Prior to May 1, 2023, the Plan had adopted a non-standardized form of a prototype plan sponsored by Empower Trust Company, LLC. The prototype plan provider had received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code ("IRC").

Effective May 1, 2023, the Plan adopted the non-standardized form of a prototype plan sponsored by Automatic Data Processing. The IRS issued an opinion letter dated October 6, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original prototype document, the Plan administrator and tax counsel believes that the Plan as currently designed is being operated in compliance with the applicable requirements of the IRC. The Plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021. If applicable, the Plan would recognize penalties and interest on uncertain tax positions as a deduction from net assets.

**10. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
