Note 1—Plan description

The following is a description of the Intega, Inc. 401(k) Plan (the “Plan”) and provides only general information of the major Plan provisions. Participants should refer to the Plan document for more complete information.

General – The Plan was established by Intega, Inc. (“Intega”) as a defined-contribution plan effective January 1, 2021. The Plan is a multi-employer plan and permits the employees of Intega, Construction Sciences, LLC; PPI Quality & Engineering, LLC; and T2 UES Inc. (collectively, the “Company” or “Plan Sponsor”) to participate in the Plan. The Plan is subject to the provisions of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”).

Transfers – The Plan was amended during 2024 to include the merge and transfer of Applied Professional Services, Inc. Assets totaling \$1,290,619 were transferred to the Plan.

Participation – All employees of the Company who are least 21 years of age and are not represented by a collective bargaining agreement or a nonresident alien are eligible to participate in the Plan. The Plan provides for entry dates immediately upon satisfying the eligibility requirements.

Contributions – Eligible participants may contribute up to 90% of their annual compensation to the Plan, subject to the maximum limitations of the Internal Revenue Code (“IRC”). Participant contributions may be either on a pre-tax or after-tax basis, up to certain prescribed limits. The participants’ basic annual contributions cannot exceed \$23,000, and an additional \$7,500 for catch-up contributions for participants who are 50 or older. In addition, the Plan accepts rollovers from other tax-qualified plans. The Company may contribute qualified nonelective-matching contributions and other Company matching contributions at its discretion. The Company matched 50% of contributions up to 3% of a participant’s eligible compensation. During the year ended December 31, 2024, the Company made discretionary matching contributions of approximately \$902,000.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s contributions and (b) investment earnings or losses and charged with benefit payments and transaction fees related to notes receivable from participants and distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their employee contributions and rollovers, plus or minus any earnings or losses thereon. Vesting of employer-matching contributions, plus or minus actual earnings or losses thereon, is based on years of credited service. A participant is 100% vested after five years of credited service as follows:

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than two loans outstanding at any given time. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the loan was used to acquire a principal residence, in which case the repayment period may exceed five years. Notes are secured by the vested balances in participants' accounts. The interest rate on loans outstanding as of December 31, 2024 ranged between 4.25% to 9.50%. Notes receivable from participants are recorded at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are deemed distributions based upon the terms of the Plan document.

Payment of Benefits – Distribution of a participant's vested account balance to the participant or his or her beneficiary may commence upon the earlier of retirement, death, disability, or separation from service. Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the vested interest in his or her account in a single lump-sum payment or direct rollover. Distributions are subject to the applicable provisions of the Plan.

The Plan allows, in certain hardship situations as defined in the Plan Agreement, participants to withdraw amounts from their account balances while actively employed. A participant experiencing financial hardship may, with sufficient evidence, withdraw a portion of their account attributable to employee contributions and rollover contributions. The amount of the withdrawal may not be greater than the immediate financial need. These hardship withdrawals are subject to IRC restrictions and penalties.

Forfeitures – Any nonvested portion of employer-matching contributions credited to the accounts of participants who withdraw from the Plan are forfeited and used for either payment of eligible administrative expenses or to reduce employer-matching contributions. There were no forfeiture balances outstanding as of December 31, 2024 or 2023. The Company used approximately \$31,000 of forfeitures to reduce discretionary employer matching contributions during the year ended December 31, 2024.

Administration – The Plan is administered by the Company. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses are paid either directly by the Plan or by the account of the participant.

Note 2—Summary of significant accounting policies

Basis of Presentation – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Accounting Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Contribution Receivable – The amounts of participant-related contributions that have been deducted from the participant's payroll as of the end of the year but have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Company are reflected as Company contributions receivable in the Plan's financial statements.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value, except for its fully benefit-responsive investment contract, which is valued at contract value (see Note 5). Net depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan offers a self-directed brokerage account investment option that allows for participants to direct their investments to any publicly traded mutual fund.

Benefits Paid to Participants – Benefits are recorded when processed and paid by the Plan.

Note 3—Information provided and certified by the qualified institution (unaudited)

The Plan management has elected the method of compliance as permitted by 29 CFR 2520.103-8 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity Management Trust Company (the “qualified institution”) as of December 31, 2024 and 2023, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and was not subjected to any auditing procedures performed by the independent public accountant:

- Investments, at fair value, fully benefit-responsive investment, at contract value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest and dividends from investments, interest income on notes receivable from participants, and transfers into the Plan as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

Note 4—Fair value of investments

Fair Value Measurement – The methods used to measure fair value of the Plan’s investments may produce amounts that may not be indicative of net realizable value or may not be reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 4—Fair value of investments (continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Collective Investment Trust Funds – These investments are investment vehicles valued using NAV provided by the administrator of the fund, as a practical expedient. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is excluded from the valuation hierarchy consistent with U.S. GAAP.

Money Market Fund – These investments are valued at closing price reported on the active market on which the individual securities are traded and are classified within Level 1 of the valuation hierarchy.

Self-Directed Brokerage Accounts – The self-directed brokerage accounts are valued based on quoted market prices and are classified within Level 1 of the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5—Guaranteed investment contract with insurance company

During 2024 and 2023, the Plan held an interest in the New York Life Anchor Account, a stable value fund (“SVF”) that is a pooled account with New York Life Insurance Company (“New York Life”), made available to participating plans through a group annuity contract. Contributions to the SVF are directed to a New York Life pooled separate account that invests primarily in a diversified portfolio of high-quality, fixed income securities, which are owned by New York Life. The SVF is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer, New York Life, is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The SVF is a fully benefit-responsive investment contract and is reported at contract value in the statements of net assets available for benefits. The statement of changes in net assets available for benefits is also prepared on a contract value basis. Benefit responsiveness is defined as the extent to which a contract’s terms and the Plan permit or require participant-initiated withdrawals at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. New York Life reports the contract value to the Trustee to include in the certification over the schedule of assets held. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Note 5—Guaranteed investment contract with insurance company (continued)

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer of the SVF. Such events include but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification. The Plan administrator is not aware of the occurrence or probable occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants.

The crediting interest rate for the SVF is reset daily by the issuer but cannot be less than zero. The crediting interest rate is based upon a formula and is a function of timing of the cash flow activity, overall interest rates, the reinvestment of maturing proceeds, and the impact of credit losses and impairments.

Note 7—Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

Note 8—Income tax status

The Internal Revenue Service (“IRS”) has determined and informed the Plan administrator by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and, has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9—Party-in-interest transactions

Certain Plan investments are shares or units of investments managed by Fidelity Management Trust Company and, therefore, these transactions qualify as parties-in-interest transactions for which a statutory exemption exists. In addition, notes receivable from participants is considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. While these transactions qualify as party-in-interest activity, they are expressly exempted from prohibited transaction rules (ERISA, Title 1, and Section 401(b)).

Note 10—Risks and uncertainties

The Plan provides for various investment options in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Note 11—Subsequent events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued. During this period, four amendments effecting the 2025 Plan were adopted, the most recent of which became effective on May 1, 2025. These amendments include:

Related Employers: The Plan was amended to include only the following entities as Related Employers: ASI, LLC; Applied Professional Services, Inc.; Kiwa Group North America LLC; NQA; PPI Quality & Engineering, LLC; T2 UES Inc.; and Unitek.

Discretionary Formula: The Plan’s allocation method was amended to treat each “eligible” Participant as their own allocation group. The Nonelective Employer Contribution will first be allocated at the Employer’s discretion among employee groups, and then among the “eligible” Participants.
