### **Notes to Financial Statements**

#### **NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### ***Basis of Presentation***

The accompanying financial statements of Ripple Junction Design Co., Inc. 401(k) Profit Sharing Plan (the "Plan") have been prepared on the accrual basis using accounting principles generally accepted in the United States of America.

##### ***Receivables***

Receivables represent contributions due to the Plan as of December 31, 2024 and 2023.

##### ***Investment Valuation***

Investments are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held in the Plan at year end. Participant loans are valued at carrying value, which approximates market value.

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Investment transactions are accounted for on the trade-date basis (the date the order to buy or sell is executed). Dividends are recorded on the ex-dividend date. The cost of investments sold is computed on an average cost basis for all realized gains and losses.

##### ***Related Party Transactions***

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

##### ***Estimates***

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Management believes that the estimates utilized in preparing its financial statements are reasonable and prudent.

##### ***Benefit Payments***

Benefit payments are recorded when paid.

##### ***Expenses***

Certain Plan expenses are paid by the Plan Sponsor, and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

##### ***Subsequent Events***

The Plan has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available to be issued and have determined that there are no subsequent events that require disclosure under applicable generally accepted accounting principles for subsequent events.

#### **NOTE 2 PLAN DESCRIPTION**

The following description of the Ripple Junction Design Co., 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan available to all employees, with the exception of part-time, temporary, and seasonal employees, of Ripple Junction Design Co., Inc. (the "Company") on the first day of calendar month following employment and have attained the age of 18, provided that you are an Eligible Employee on that date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### ***Contributions***

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. However, such contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). Section 414(v) of the Internal Revenue Code of 1986 as amended allows a maximum catch-up contribution of \$7,500. Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year.

The Plan allows for the Company to make discretionary matching contributions. During 2024, the Company made matching contributions equal to 150 percent of the first 1 percent and 50 percent of the next 5 percent of eligible compensation that a participant contributed to the plan. The amount of matching contributions made by the Company were \$337,970 for 2024.

Participants may make voluntary contributions to the Plan on an after-tax basis. Contributions are included in the participant's gross income. The combined amounts contributed pre-tax and after-tax are subject to certain stipulated maximums.

The Plan has adopted provisions to allow for automatic enrollment into the Plan. When new participants become eligible to participate in the Plan, deferrals will be made on their behalf at 6%, unless the participant elects a different deferral percentage not to participate in the Plan.

##### ***Rollover Contributions***

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

### Notes to Financial Statements (Continued)

#### NOTE 2 PLAN DESCRIPTION (CONTINUED)

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions, plan earnings and forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### *Vesting*

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Qualified safe harbor contributions plus actual earnings thereon vest after 2 years. For other employer contributions a participant vests ratably beginning after two years of service with 100 percent vesting being attained after six years.

##### *Forfeitures*

As of December 31, 2024 and 2023, forfeited unallocated nonvested accounts totaled \$2 and \$2,391, respectively. During December 31, 2024, the Plan used \$33,662 to reduce plan expenses.

##### *Payment of Benefits*

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed as a lump sum cash payment.

In service distributions are permissible from the Plan for participants who have attained the age of 59 1/2.

In conditions of "financial hardship", as defined, a participant may apply to the Plan administrator for approval to withdraw that portion of their 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts up to a maximum of \$50,000 or fifty percent of their account balance, whichever is less. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Notes receivable terms range from one to five years or beyond five years, as agreed upon by the participant and the notes receivable administrator, for the purchase of a primary residence.

#### NOTE 3 TAX STATUS

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan qualifies under the applicable provisions of the Internal Revenue Code and therefore, is exempt from federal income taxes. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

#### NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### NOTE 5 INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The following information provided by Charles Schwab Bank, as of December 31, 2024 and 2023 and for the years then ended was certified by them to be complete and accurate with respect to the following:

- b) The amount of investment income (loss) for the year ended December 31, 2024.
- c) Investment balances on Schedule H, Line 4i – Schedule of Assets (Held at End of Year) for the Year Ended December 31, 2024.

#### NOTE 6 FAIR VALUE MEASUREMENTS

Applicable Generally Accepted Accounting Principles (GAAP) accounting for Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the applicable GAAP accounting for Fair Value Measurements and Disclosures are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. (Mutual funds, common stocks, corporate bonds, US government securities, etc.)

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

*Mutual funds:* Value at the net asset value ("NAV") of shares held by the Plan at year end.

*Money market funds:* Value at the closing prices as reported by the fund. The money market fund held by the Plan is an open-ended mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily NAV and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
