## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tradesmen International, LLC 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Tradesmen International, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering employees of Tradesmen International, LLC (the Company or Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Effective January 1, 2022, the Company adopted the Empower Trust Company, LLC Basic Plan Document #01 (the Prototype Plan). Plan assets remained with Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, F.S.B. ("Prudential") until October 2023, at which time Empower Trust Company, LLC and Empower Annuity Insurance Company ("Empower") became the Plan's Trustees and Plan assets were transferred to the Empower platform. The Plan's administrator is responsible for all matters including, but not limited to, oversight of the Plan, eligibility, rights to benefits, interpreting Plan documents, maintaining participants' accounts, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Eligibility

Under the terms of the Plan, all employees (except ineligible classes as defined by the Plan document) who are at least 21 years of age and have completed 6 months of service are eligible to participate in the Plan. An eligible employee may elect to participate immediately following satisfaction of all eligibility requirements. There are no age or service requirements for employees receiving prevailing wage contributions.

Contributions

Participants may elect to have from 1% to 80% of compensation contributed to the Plan by the Company as a payroll reduction contribution, up to the maximum dollar amount allowed by law. Participant contributions are on a pre-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan from other qualified retirement sources. Contributions are subject to certain limitations.

The Company matches 50% of each dollar contributed, up to 6% of the participant's eligible compensation. The Company contributed \$781,609 and \$770,111 in matching contributions for the years ended December 31, 2024 and 2023, respectively.

The Company has the option to make discretionary Company contributions and qualified non-elective contributions (QNEC) to the Plan. Participants who had completed 1,000 hours of service during the plan year and were employed by the Company on the last day of the plan year are eligible to receive discretionary Company contributions and QNEC. There were no discretionary Company contributions or QNEC made by the Company during the years ended December 31, 2024 and 2023.

The Company makes prevailing wage contributions related to wages pertaining to eligible jobs. The Company contributed \$585,965 and \$336,530 in prevailing wage contributions for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contributions, an allocation of discretionary Company contributions and QNEC (if any), prevailing wage contributions, and Plan earnings; and charged with an allocation of administrative expenses. Discretionary Company contributions and QNEC are allocated prorata based on compensation of participants. Prevailing wage contributions are allocated based on contract compensation to participants covered by the contract. Allocations of earnings and expenses are based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, participants may direct contributions to their accounts into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions and any prevailing wage contributions, plus actual earnings thereon. Vesting in the remainder of participant accounts for employees hired prior to March 1, 2018, is based on years of continuous service according to the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years but less than 3	20%
3 years or more	100%

Vesting in the remainder of participant accounts for employees hired on or after March 1, 2018, is based on years of continuous service; participants are 100% vested after 3 years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts up to 50% of their vested account balance, a minimum of \$1,000 up to a maximum of \$50,000. Note receivable terms range from 1 to 5 years, or up to a maximum of 15 years for the purchase of a principal residence. The notes receivable are secured by the balance in the participant's vested account and bear interest at the prime rate plus 1% at the time the notes receivable are made. Principal and interest are paid at least quarterly through coupon/direct billing.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation of service, a participant may elect to receive annual installments over a specific period, or a lump-sum amount equal to the value of his or her vested account. Participants who have attained age 65 may take in-service distributions from their fully vested accounts. If an employee has \$5,000 or less in his or her account, disregarding rollover contributions, the entire balance of the participant's vested account must be distributed immediately from the Plan.

Forfeited Accounts

Forfeitures are created when participants terminate employment prior to becoming entitled to full benefits. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,943 and \$10,532, respectively. Forfeitures can be used to reduce Company match and discretionary or prevailing wage contributions, or to pay expenses. In 2024 and 2023, Company matching contributions were reduced by \$115,297 and \$157,879, respectively, from forfeited non vested accounts.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared on the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by its investment advisors and trustees. See Note 4 for a discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in a fund that holds a group annuity contract. This fund meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value, as reported to the Plan by the Trustees represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or (depreciation) includes the Plan's gains and losses on the investments purchased and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are classified as distributions based upon the terms of the Plan document. In management's opinion, all notes receivable are fully collectible; accordingly, no allowance for credit losses was recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

Administrative expenses are paid by the Plan or the Company, at the discretion of the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to participant accounts.

Subsequent Events

The Plan evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEES

Information certified by the Trustees was prepared by Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, F.S.B. for the period prior to October 2023, and Empower Trust Company, LLC / Empower Annuity Insurance Company effective October 2023. Information certified by the Trustees includes investments and notes receivable from participants included in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, and investment income items and interest on notes receivable from participants included in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

NOTE 4 - FAIR VALUE MEASUREMENTS

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in inactive markets. Level 2 inputs include those other than quoted prices that are observable for the asset or liability and that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies* - Valued at the closing price reported on an active market on which the individual securities are traded.

*Pooled separate accounts* - The fair value of the underlying assets are used to determine the net asset value (NAV) of the funds. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

NOTE 5 - GROUP ANNUITY CONTRACT

The Plan is invested in the Guaranteed Income Fund (the Contract), a fully benefit-responsive investment contract through Empower Annuity Insurance Company (formerly Prudential Retirement Insurance and Annuity Company) (the Issuer). There are no events that could limit the ability of the Plan to transact at contract value. There are not any events that could allow the Issuer to terminate the contract and which require the Plan to settle at an amount different than contract value.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their account balances.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments at December 31, 2024 and 2023 are invested in funds managed by the Trustees, and therefore, these transactions qualify as party-in-interest transactions. The Plan also makes loans to Plan participants who are also considered to be parties-in-interest.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - TAX STATUS OF THE PLAN

The Plan is qualified under applicable provisions of the Internal Revenue Code (IRC) and is not subject to federal and state income taxes. Effective January 1, 2022, the Company adopted the Empower Trust Company, LLC Basic Plan Document #01 (the Prototype Plan). The Prototype Plan obtained a favorable opinion letter dated September 16, 2022, in which the Internal Revenue Service (IRS) stated that the Prototype Plan, as then designed, was acceptable under section 401 of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. As of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax year pending or in progress.
