### **Report on the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Responsibilities of Management for the Financial Statements***

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures related to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain other internal control-related matters that we identified during the audit.

***Supplemental Schedule Required by ERISA***

The supplemental schedule of schedule of assets held at end of year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023**

#### **(1) Description of the Plan**

The following description of the Fall River Health Services 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

Effective April 15, 2025, the Plan changed their third-party administrator and custodian. As a result, all Plan assets were transferred from Nationwide Trust Company, FSB, to Principal Trust Company.

#### **Nature of Business of Plan Sponsor**

Fall River Health Services provides hospital, nursing home, and clinic services to patients in southwestern South Dakota.

#### **General**

The Plan is a defined contribution 403(b) plan established for the benefit of the employees of Fall River Health Services (the Organization). The Plan and the trust of which it is a part are intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

All employees of the Organization are eligible to participate in the Plan. Participants who have attained the age of 21, worked 1,000 hours during the 12 month Plan year, and are employed on the last day of the Plan year are eligible to receive a match.

Effective April 1, 2025, the Plan was amended to allow participants who have completed a 30 day period of service during the 12 month Plan year and are employed on the last day of the Plan year, to be eligible to receive a matching contribution.

#### **Contributions**

Participants may contribute up to 100 percent of their pretax annual compensation, as defined in the Plan, and subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute (rollover) amounts representing distributions from other qualified defined benefit or contribution plans. The Plan provides for matching contributions made by the Organization up to 50 percent of the first 6 percent of each participant's contribution to the Plan. Additional amounts may be contributed at the option of the Organization's Board of Directors. There were no additional discretionary contributions made for the years ended December 31, 2024 and 2023.

The Plan allows Roth elective deferrals. Contributions to Roth accounts are made on an after-tax basis and contributions to a Roth account are included in the participant's gross contributions. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participant's Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

Effective April 1, 2025, the Plan instituted automatic enrollment in which the Plan Sponsor automatically withholds six percent of the eligible participant's compensation upon becoming eligible to participate unless otherwise elected by the participant. Contributions are automatically invested in the appropriate target date fund unless the participant elects other investment options. The Plan increases the participant's automatic enrollment by one percentage per year up to a maximum of 20 percent of compensation.

#### **(1) Description of the Plan**

##### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or take distributions of less than their entire vested account balance. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Vested benefits less than \$1,000 are distributed as soon as administratively feasible after the participant's termination of employment. Vested benefits greater than \$1,000 but less than \$5,000 are rolled over to an individual retirement account.

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participants' accounts attributable to the Organization's matching and discretionary contributions become 25 percent vested after one year of credited service as defined and continue to vest at the rate of 25 percent for each successive year of service until 100 percent vested after four years of service.

##### **Participant Investment Options**

Participants direct their account balance to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time throughout the year. Participants may elect to discontinue contributions at any time.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Organization's contribution and Plan earnings or losses and charged with a portion of Plan expenses.

##### **Forfeitures**

Non-vested account balances are forfeited, unless participants return to employment and contribute the distribution received at termination within a specified time. Forfeited, non-vested account balances were \$5,577 and \$1,462 at December 31, 2024 and 2023, respectively. Forfeitures used to reduce employer contributions was \$1,464 during the year ended December 31, 2024.

##### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus two percent established at the time the loan is made. Principal and interest are paid ratably through payroll deductions.

##### **Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Trustee fees and other administrative expenses are paid by the Organization. If not paid by the Organization, the administrative expenses become the responsibility of the Plan.

#### **(2) Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

#### **(2) Summary of Significant Accounting Policies**

##### **Valuation of Investments and Income Recognition**

The Plan's investments are stated at fair value on a recurring basis as determined by the Trustee (Notes 3 and 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date.

##### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Risks and Uncertainties**

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

##### **Net Change in Fair Market Value of Investments**

The net appreciation (depreciation) in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year and the unrealized gains and losses in securities held at the end of the year.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Subsequent Events**

The Organization has evaluated subsequent events through October 7, 2025, the date which financial statements were available for issue.

#### **(3) Information Certified by Trustee**

The Plan is administered by the Organization. Nationwide Trust Company, FSB, is the Plan's Trustee for both of the years ended December 31, 2024 and 2023. The Plan assets invested in mutual funds are in common funds held and managed by the Trustee.

The Plan's investments are held by the Trustee, who performs all accounting functions associated with the Plan's investments. The fair value of investments at December 31, 2024 and 2023 is determined by the Trustee (Note 7).

In accordance with Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the Plan Administrator has received certification from the Trustee as to the accuracy and completeness of certain financial information of the Plan as of and for the years ended December 31, 2024 and 2023. Information contained in the following has been certified by the Trustee:

Statements of Net Assets Available for Benefits (except for Employer Contribution Receivable)  
Statement of Changes in Net Assets Available for Benefits (except for Contributions, Benefits Paid to Participants, and Expenses)  
Supplemental Schedule of Assets Held at End of Year

The Plan invests in a mutual funds with underlying assets consisting of any combination of stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is possible that the value of the Plan's investments, both in total and in individual participant accounts, has changed significantly since December 31, 2024.

#### **(4) Income Tax Status**

The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Department of Labor or IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(5) Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

#### **(6) Participant Withdrawals**

Vested, undistributed account balances of separated Plan participants totaled approximately \$2,740,000 and \$2,681,000 at December 31, 2024 and 2023, respectively.

**(7) Recurring Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level One: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level Two: inputs include
  1. quoted prices for similar assets or liabilities in active markets;
  2. quoted prices for identical or similar assets or liabilities in inactive markets;
  3. inputs other than quoted prices that are observable for the asset or liability;
  4. inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level Three: inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables present the assets carried at fair value as of December 31, 2024 and 2023, in the accompanying Statements of Net Assets Available for Benefits by fair value hierarchy, as described above. All are measured on a recurring basis.

**(8) Related Party Transactions**

Certain Plan investments are shares of mutual funds managed by Nationwide Trust Company, the Trustee of the Plan. The Plan allows participants to take out loans against their account balances.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
