INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Management

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hyde Park Restaurant Systems, Inc. 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors'

Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note B to the financial statements, which describes the basis of accounting. The financial statements were prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of the Hyde Park Restaurant Systems, Inc. 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General*

The Plan is a defined contribution plan that was initially adopted by the management of Hyde Park Restaurant Systems, Inc. (the "Company" and the "Plan Administrator") on January 1, 2010, and was amended and restated effective January 1, 2023, to provide benefits to eligible employees of the Company. Participation is available to all employees of the Company who have completed one year of service and have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

2. *Contributions*

Participants may elect to contribute up to 20% of their eligible compensation to the Plan on a pre-tax or Roth basis. Maximum contributions are subject to certain limitations which are established by the Internal Revenue Code ("IRC"). Participants who turn age 50 before the end of the plan year can also make catch-up contributions. Participants may also rollover distributions from other qualified retirement plans.

The Company can make a discretionary matching contribution to the Plan equal to 25% of the participant's eligible compensation up to a 4% maximum. The Company calculates and contributes the matching contributions on a quarterly basis. Matching contributions are invested in the same manner as participants' elective deferrals. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Company can also make a discretionary profit-sharing contribution though none was made for the year ended December 31, 2024.

3. *Vesting*

Participants are immediately vested in elective deferrals and earnings thereon. Vesting in the Company's contributions is based on a 5-year graded schedule. Participants who die or become disabled become 100% vested in their accounts.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

4. *Participant accounts*

Each participant's account is increased by the participant's voluntary deferral, the Company's matching contributions, profit-sharing contributions, and investment earnings. Each participant's account is reduced by investment losses, participant withdrawals, and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which each participant is entitled is the benefit that can be provided from that participant's vested account.

Plan participants are permitted to determine the investments within their account based on a combination of permitted investment options. The Company has the sole discretion to determine or change the number and nature of investment options in the Plan.

5. *Forfeitures*

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances of terminated participants' non-vested accounts may be used to reduce employer contributions or to pay administrative expenses of the Plan, as determined by the Company. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,109 and \$1,922, respectively. During 2024, \$15,694 of forfeitures were used to offset plan expenses.

6. *Benefits paid to participants*

Upon termination of service due to separation of employment, death, disability, retirement, or any other reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account balance.

NOTE B - BASIS OF ACCOUNTING

The financial statements are prepared on the modified cash basis of accounting. Contributions are recognized when received, and Plan expenses are recognized when paid. Additionally, securities investments are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with the accounting principles generally accepted in the United States of America.

NOTE C - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies consistently applied in preparation of the accompanying financial statements follows:

1. *Investment valuation and income recognition*

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment adviser. See Note C(2) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. *Fair value measurements*

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 Quoted market prices in active markets for identical assets and liabilities.
- Level 2 Observable market-based inputs or unobservable inputs that are corroborated by market data.
- Level 3 Unobservable inputs in which little or no market data exists

Investments – The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily price and to transact at that price. These funds are deemed to be actively traded and are classified as Level 1.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE C - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

2. *Fair value measurements (Continued)*

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. *Benefits paid to participants*

Benefits paid to participants are recorded when paid.

4. *Administrative expenses*

Administrative fees are paid by the Company or the Plan at the discretion of the Company. Certain transactions and account maintenance fees are charged to the affected participants. Revenue credit payments are made from excess revenue generated by the Plan through fund revenue or fees that are made available to the Plan. The Company monitors the payments received by the Plan service providers to ensure that they are used properly for qualifying Plan administrative and operating expenses. \$7,645 in revenue credits was used in 2024 to reduce administrative expenses.

5. *Use of estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE D - INCOME TAX STATUS

The Company adopted the Newport Group, Inc. Defined Contribution Pre-Approved Plan which has obtained an opinion letter from the IRS dated June 30, 2020. The IRS determined that the volume submitter document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Company believes the Plan is qualified and the related trust is tax-exempt.

Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE E - UNAUDITED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Administrator received certifications from the Ascensus Trust Company and Newport Trust Company (the "Trustees"), acknowledging the completeness and accuracy of all investments reflected in the statements of net assets available for benefits (modified cash basis) at December 31, 2024 and 2023, the supplemental schedule (modified cash basis) at December 31, 2024, the related investment activity reflected in the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

NOTE F – PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company and Newport Trust Company are the trustees of the plan and provide certain other services to the Plan in addition to receiving administrative fees from the Plan; therefore, these qualify as party-in-interest transactions.

NOTE G - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. The Plan's investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

NOTE H - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE I - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through date of the Independent Auditors' Report, which is the date the financial statements were available to be issued.
