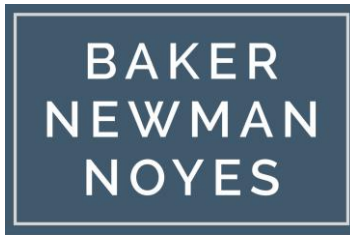

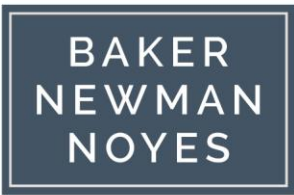

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge and belief.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the MaineHealth Legacy 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan sponsored by MaineHealth Services (formerly MaineHealth). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan covers employees of MaineHealth. The Plan serves as an umbrella plan for the existing MaineHealth member organizations' 403(b) plans which could not be consolidated into the MaineHealth 403(b) Retirement Plan.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

Contributions

Effective January 1, 2017, the Plan was frozen and no new salary deferred contributions are allowed.

Participants elect to have their accounts invested in various managed funds included in the Plan which have different investment objectives.

Participant Accounts

Each participant's account is credited with the participant's Plan earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their account balances.

Payment of Benefits

Participants are entitled to a distribution of their vested benefits upon attaining age 59 1/2 or upon separation from service. The Plan also provides for distributions upon death or disability.

Notes Receivable From Participants

Participants could borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms ranged from one to five years or up to fifteen years for the purchase of a primary residence. The loans were secured by the balance in the participant's account with an interest rate of prime plus 1% at the date the loan was issued. Under the terms of the Plan, effective June 15, 2017, new loans are not allowed. Existing loans will be repaid under previously established terms.

1. **Description of the Plan (Continued)**

Plan Termination

MaineHealth Services reserves the right to amend or terminate at any time any provision of the Plan or the Plan in its entirety, subject to the provisions of ERISA. Upon termination of the Plan, the trustees, once notified by MaineHealth Services of the termination date, will distribute to each participant his or her account balance on that date in accordance with the terms of the Plan.

Administrative Expenses

The Plan sponsor is responsible for certain administrative costs of the Plan.

2. **Summary of Significant Accounting Policies**

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investments

Investments in money market and mutual funds are reported at fair value at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The group annuity fixed contracts are based upon contract value at December 31, 2024 and 2023. See Note 4 for discussion on contract value.

Investments in pooled separate accounts are stated at fair value at December 31, 2024 and 2023, as determined by the Plan's trustees, based upon the net asset value or capital account reported by the underlying funds.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest.

Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

2. **Summary of Significant Accounting Policies (Continued)**

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Transfers Into Plan

During 2023, approximately \$361,000 was transferred into the Plan from MaineHealth Care at Home.

Benefits

Benefits are recorded when paid.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by the Plan Administrator to determine whether such events should be recognized or disclosed in the financial statements. The Plan Administrator has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

3. **Information Certified by Trustees**

All Plan asset information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participant, and net appreciation in fair value of investments, interest and dividends, investment transactions and interest income on notes receivable from participants was certified by Lincoln National Life Insurance Company (Lincoln), Fidelity Management Trust Company (Fidelity), Mutual of America Life Insurance Company (MALIC), The Variable Annuity Life Insurance Company (VALIC), Voya Retirement Insurance and Annuity Company (Voya), and Transamerica Financial Life Insurance Company Inc. (Transamerica), the trustees of the Plan, as of and for the years ended December 31, 2024 and 2023. Accordingly, as permitted under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the trustees, except for comparing such information certified by the trustees to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has determined that the trustees meet the requirements of qualified institutions as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Investments – Contract Value

The Plan maintains group annuity contracts with Lincoln, Transamerica, VALIC and Voya. Account balances are credited with a guaranteed rate of return. Once invested, the participant may be limited under certain circumstances on certain transfers or withdrawals from the investment. In accordance with the provisions of accounting for *Fully Benefit-Responsive Investment Contracts*, the contracts are considered to be fully benefit-responsive by the Plan Administrator; accordingly, the contracts are stated at contract value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses).

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan owns a promise to pay interest at crediting rates that are announced in advance and guaranteed for a specific period of time as outlined in the contract. The interest crediting rates are determined by Lincoln, Transamerica, VALIC and Voya based on a specific formula tied to a current market index as outlined in the contract and are not based on the performance of the assets which back the investment contract. Such interest rates are reset quarterly.

Certain events limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer under the group annuity contract. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Upon contract discontinuance, money may be withdrawn from the stable value account subject to a market value adjustment or according to a withdrawal schedule. The Plan Administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

5. Fair Value Measurements

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market: Valued at the closing price reported on the active market on which the securities are traded.

Mutual funds: Valued at the net asset value (NAV) of shares (based upon quoted market price) held by the Plan at year end.

Pooled separate accounts: Valued based upon NAV of shares held by the Plan at year end, as determined by the account manager, based upon quoted market prices of the underlying investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The significant investment strategies of the pooled separate accounts measured at net asset value using the net asset value per share practical expedient are as follows:

Lifecycle funds: These funds are model portfolios that seek to provide a high total return through the balance of growth, income and capital conservatism through a mix of equity and fixed income exposures through the target retirement date, with a greater focus on income beyond the target date.

Lifestyle funds: These funds seek to achieve long-term growth of capital by investing in a combination of both equity and fixed income securities.

Growth funds: These funds seek capital appreciation foremost by investing in equity securities across domestic and international markets. The secondary focus on these funds is current income.

Growth and income funds: These funds seek a balance between a high level of income and the growth of capital, with a higher degree of emphasis on growth from exposure to various equity allocations.

Income funds: These funds seek current income with capital appreciation and growth of income, primarily by investing in fixed income securities through broad sectors of the bond market and gain exposure to various types of credit and interest rate risk.

Conservative funds: These funds seek to achieve maximum current income consistent with preservation of principal and liquidity. These funds seek to maintain a stable net asset value.

6. **Tax Status**

The Plan is subject to ERISA and certain provisions of the Internal Revenue Code (IRC). The Plan has adopted a volume submitter 403(b) Plan document sponsored by Lincoln Retirement Services Company LLC that has received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2017, stating that the form of the volume submitter 403(b) plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the approved Plan document. However, the Plan Administrator believes the Plan is designed, and is being operated, in conformity with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

In 2020, the Plan was selected for routine investigation by the DOL for the time period January 1, 2017 through August 15, 2020. The routine investigation closed as of May 2024. The Plan is subject to routine audits by taxing jurisdictions.

7. **Party-in-Interest Transactions**

Lincoln, Fidelity, MALIC, VALIC, Transamerica and Voya provided administrative services to the Plan. As such, investments and transactions with these entities qualify as party-in-interest. However, they are exempt from the prohibited transactions rules under ERISA. Notes receivable from Plan participants, and the related interest income and transactions, are also considered party-in-interest transactions.

8. **Reconciliation of Financial Statements to Form 5500**

Notes receivable from participants are reflected as a receivable on the financial statements which is different from the Form 5500 presentation. On the Form 5500, notes receivable are classified as investments under the caption "participant loans".
