Note A - Description of Plan:

The following brief description of Lewis Communications, Inc. 401(K) Retirement Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan booklet for more complete information.

1. General - The Plan, adopted March 31, 1977, is a defined contribution plan established by Lewis Communications, Inc. (the "Sponsor") under the provisions of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. Any salaried or commissioned employee of the Sponsor who is at least twenty-one years of age is eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
2. Plan Administration - The administration of the Plan is the responsibility of an administrator appointed by the Board of Directors of the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974. The trustee of the Plan is Lewis Communications, Inc.
3. Participant Contributions - Each year, participants may contribution up to 90% of pretax annual compensation, as defined by the Plan, subject to limitations under the IRC. Participants who have attained age 50 before the end of the Plan year are allowed non-matched elective catch-up contributions subject to limitations under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Company Contributions - For eligible participants, the Plan provides for the Company, at its discretion, to make an annual matching contribution, subject to certain limitations of the Code. Amounts to be contributed are determined by the Chief Executive Officer of the Company under delegation from the Board of Directors, pursuant to the terms of the Plan, which totaled \$156,219 for the year ended March 31, 2025. Generally, only eligible participants employed by the Company on the last day of the plan year and who have completed one year of service as defined by the plan document are eligible to receive the Company contribution, except in the event of death, job elimination, divestiture, total and permanent disability, or attainment of the normal or early retirement date occurring during the plan year. Participants have authority over the investment allocation of Company contributions.

4. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching discretionary contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Participant Loans - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan at a time. The loans are secured by the balance in the participant's account and bear interest at 2% plus the prime rate published in the Wall Street Journal on the first business day of each month. Interest rates were between 6.50% and 9.50% for all participant loans as of March 31, 2025. Principal and interest is paid ratably through monthly payroll deductions and are generally over periods ranging up to five years unless it is for the purchase of a primary residence. Participant loans are measured at the amount of unpaid principal plus any material accrued and unpaid interest.
6. Vesting - Participants are fully vested in their contributions and the earnings thereon. Vesting in employer matching and profit sharing is based on years of continuous service. Participants are entitled to the value of their accrued benefits upon termination of employment or retirement due to the attainment of age 65 or older, based on the following vesting schedule:

7. Payment of Benefits - Participants becoming totally and permanently disabled before reaching their normal retirement date will receive the full vested balance of their accounts under the Plan. For participants who die while working for the Sponsor, the full vested balance of their accounts under the Plan will be paid to their beneficiaries. Any unvested benefits at the time of withdrawal of funds will revert back to the Sponsor as forfeitures. Hardship distributions are permitted on vested balances in accordance with IRC requirements.
8. Forfeited Accounts - At March 31, 2025, forfeited nonvested accounts totaled \$20,364. These forfeitures can be used to pay administrative expenses and reduce employer contributions to the Plan. During 2023-2024, the Company applied \$989 of existing forfeitures toward administrative expenses and employer contributions. As of March 31, 2025, the balance in the Plan's forfeiture account was \$35,502.

Note B - Summary of Accounting Policies:

The following are the significant accounting policies followed by the Plan.

1. Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.
2. Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
3. Investment Valuation and Income Recognition - The Plan's investments are stated at fair value, which is measured on a recurring basis at March 31, 2025 and 2024, except for fully benefit-responsive investment contracts, which are reported at contract value. FASB ASC 820 Fair Value Measurements and Disclosures establishes a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note E for discussion of fair value measurements.  
  
Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.
4. Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of March 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.
5. Payment of Benefits - Benefit payments to participants are recorded upon distribution.
6. Operating Expenses - All expenses incurred maintaining the Plan are paid first from forfeiture, then by the Company. Any expenses paid by the company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments
7. Date of Management's Review - The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued, and noted no material events requiring disclosure.

Note D - Guaranteed Investment Contract:

The MetLife Stable Value Fund (Fund) is a group annuity contract that offers a full guarantee on principal and interest by the MetLife Insurance Company (Issuer). The contracts are fully benefit responsive.

The Fund qualified as a fully benefit-responsive investment contract because it meets all of the following criteria:

- a. The investment contract is effected directly between the Fund and the Issuer and prohibits the Fund from assigning or selling the contract or its proceeds to another party without the consent of the Issuer.
- b. The contract Issuer is obligated to (i) repay principal and interest, or (ii) apply prospective crediting rate adjustments with an assurance the crediting rate will not be less than zero.
- c. The terms of the investment contract require all permitted participant-initiated transactions with the Fund to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those transactions allowed by the underlying defined contribution plan, such as
- d. An event that limits the ability of the Fund to transact at contract value with the Issuer (for example, premature termination of the contracts by the Fund, plan termination, bankruptcy, mergers and early retirement incentives) and that also limits the ability of the Fund to transact at contract value with the participants in the Fund must be probable of not occurring.
- e. The Fund itself must allow participants reasonable access to their funds.

Investment contracts held in the Fund are recorded at their contract value. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

The Issuer may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, including the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, layoffs, plan disqualification or failure to adopt the Plan in a reasonable period of time. Upon termination by the Issuer, a market value adjustment or withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

The Plan Sponsor was not aware of any events that would have limited the Plan to transact at contract value as of March 31, 2025.

Note E - Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Mutual funds and Pooled Separate Accounts: Valued at the daily closing price as reported by the fund. Mutual funds and Pooled Separate Accounts held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and Pooled Separate Accounts by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the Trustees may determine.

Note G - Concentration of Credit Risk:

The Plan maintains a cash account in an investment account. Accounts are guaranteed by the Savings Investor Protection Corporation (SIPC) up to \$250,000.

Note H - Tax Status:

The Company adopted a Volume Submitter 401(k) Profit Sharing Plan (VSPS Plan) sponsored by the third party administrator. The Internal Revenue Service has determined and informed the VSPS Plan Sponsor by a favorable opinion letter dated March 31, 1977, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). The Plan's opinion letter is being relied on by the Plan. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

Note I- Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note J - Related Party Transactions:

The Plan is serviced by Wells Fargo Advisors Financial Network as its investment advisor and ADP Broker-Dealer, as its third-party administrator and its record keeper. During 2025 and 2024, the Plan made direct payments to these parties of \$32,709 and \$13,838, respectively.

These transaction qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management and custodian services are paid through revenue sharing, rather than direct payment, and are included in net appreciation in fair value investments.

Lewis Communications, Inc. paid certain administrative expenses.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
