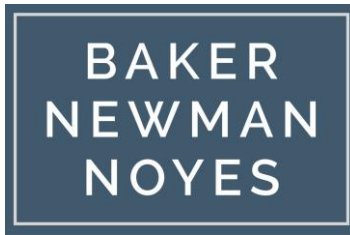

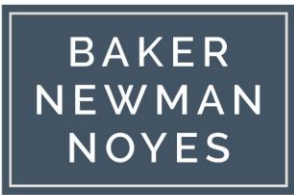

INDEPENDENT AUDITORS' REPORT

Plan Administrator and Participants
MaineHealth 403(b) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MaineHealth 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the MaineHealth 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan sponsored by MaineHealth Services, the parent organization of MaineHealth, NorDx, MaineHealth Care at Home and The Memorial Hospital at North Conway, N.H. (Memorial Hospital). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan covers employees of MaineHealth, including the following local health systems: Maine Medical Center, Maine Behavioral Healthcare, Southern Maine Health Care, Lincoln Health, Waldo County Healthcare and Pen Bay Healthcare, affiliates of Coastal Healthcare Alliance, Inc. (CHA), Franklin Health, Mid Coast — Parkview Health and Western Maine Health Care as well as employees of Memorial Hospital, MaineHealth Care at Home and NorDx.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

Eligibility

Employees become eligible to make salary deferrals on the first day of employment. Employees become eligible to receive employer matching contributions upon reaching age 18 and making elective deferrals.

Effective October 27, 2024, the Plan removed the age requirement for employer matching contributions. Employees become eligible for employer matching on the first day of employment.

Contributions

Contributions are made to participants' accounts as follows:

- Participants may elect to make pre-tax deferrals up to the maximum percentage of compensation and dollar amount permissible under Section 402(g) of the Internal Revenue Code (IRC) not to exceed the limits of IRC Sections 401(k), 404 and 415.
- Each MaineHealth Services affiliate determines the discretionary and/or nondiscretionary amount contributed to the Plan.
- Rollover contributions are subject to conditions stated in the Plan and in appropriate sections of the IRC.
- Effective January 1, 2017, participants are automatically enrolled and 4% of Plan compensation will be deferred unless the participant signs a salary reduction agreement specifically electing another amount or opting out. The automatic deferral will increase 1% each year up to a maximum of 8% unless the participant signs a salary reduction agreement specifically electing another amount or opts out.

1. Description of the Plan (Continued)

Participants elect to have their employee deferral and their respective employer contributions invested in various managed funds included in the Plan which have different investment objectives. Those funds include a guaranteed interest fund which provides for a specified return, as well as funds which are directed to investments in various bonds and equity securities.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of MaineHealth Services' contributions and Plan earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and all earnings thereon. Employer matching contributions, plus actual earnings or losses thereon are fully vested after one year of service. Employer core contributions are subject to a three-year cliff vesting schedule.

Benefit Payments

Participants are entitled to a distribution of their vested benefits upon attaining age 59 1/2 or upon separation from service. The Plan also provides for distributions upon death or disability, as well as economic hardship subject to certain criteria set forth in the Plan Agreement.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes receivable terms range from one to five years or up to fifteen years for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear an interest rate of prime plus 1% at the date the loan is issued.

Plan Termination

While MaineHealth Services intends to continue this Plan, MaineHealth Services reserves the right to amend or terminate at any time any provision of the Plan or the Plan in its entirety. In the event of Plan termination, participants will become 100% vested in their accounts. Upon termination of the Plan, the trustee, once notified by MaineHealth Services of the termination date, will distribute to each participant his or her account balance on that date in accordance with the terms of the Plan.

Administrative Expenses

MaineHealth Services is responsible for certain administrative costs of the Plan.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments, other than the stable value account, are stated at fair value. See Note 5 for disclosure of fair value measurements.

The Plan invests in the Lincoln Alliance Program Stable Value Separate Account, a fully benefit-responsive investment contract which is based upon contract value (See Note 4).

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participants have the option to invest assets in a self-directed brokerage service that allows participants access to a wide variety of mutual funds.

Notes Receivable From Participants

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024, the interest rates on outstanding participant loans ranged from 3.25% to 9.50% with maturities through 2040.

Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Transfers Into Plan

Effective March 13, 2023, MaineHealth Care at Home union employees became eligible to participate in the Plan. During 2023, this member organization transferred \$4,780,199 into the Plan.

Contributions

Contributions from employees are recorded during the period in which payroll deductions are made. Employer contributions are recorded in the same period as the corresponding employee contributions.

Benefits

Benefits are recorded when paid.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by the Plan Administrator to determine whether such events should be recognized or disclosed in the financial statements. The Plan Administrator has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

Effective April 1, 2025, the custodian and trustee of the Plan was changed to Fidelity.

3. Information Certified by Trustee

The Plan Administrator has elected the method of compliance as allowed under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's auditors not to perform any auditing procedures with respect to information certified by Lincoln Financial Group Trust Company, Inc. (Lincoln), the trustee of the Plan, except for comparing the information certified by the trustee with the related information included in the financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the trustee as of and for the years ended December 31, 2024 and 2023 stating that the information provided to the Plan Administrator by the trustee is complete and accurate to the best of their knowledge. Such information includes investments, participant notes receivable, interest and dividends, net appreciation in fair value of investments, investment transactions and interest income on participant notes receivable. The Plan Administrator has determined that the trustee meets the requirements of a qualified institution as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Investments

The Plan invests in the Lincoln Alliance Program Stable Value Separate Account, a group annuity contract with Lincoln National Life Insurance Company. The investment in this contract is stated according to the provisions of ASC Topic 946, *Reporting of Fully Benefit-Responsive Investment Contracts Held by Certain Investment Companies Subject to the AICPA Investments Company Guide and Defined-Contribution Health and Welfare and Pension Plans*, which states that contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to guaranteed investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by the trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There is no reserve against contract value for credit risk of the contract issuer or otherwise.

The issuer, Lincoln National Life Insurance Company, maintains the contributions to the Lincoln Alliance Program Stable Value Separate Account in a separate account. The account is credited with participant contributions plus earnings and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Such interest rates are reviewed and may be reset on a quarterly basis.

Certain events limit the ability of the Plan to transact at contract value. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

The Plan owns a promise to pay interest at crediting rates that are announced in advance and guaranteed for a specific period of time as outlined in the contract. The interest crediting rates are determined by Lincoln based on information tied to a current market index and are not based on the performance of the assets which back the investment contract.

The stable value account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. Fair Value Measurements

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize use of unobservable inputs.

Following is a description of the valuation methodologies used for investments of the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market and Mutual Funds: Valued at the net asset value of shares (based upon quoted market price) held by the Plan at year end.

Self-Directed Brokerage Account: Made up entirely of mutual funds that are valued at quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Income Tax Status

The Plan is subject to ERISA and certain provisions of the Internal Revenue Code (IRC). The Plan has adopted a volume submitter 403(b) Plan document sponsored by Lincoln Retirement Services Company LLC that has received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2017, stating that the form of the volume submitter 403(b) plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the approved Plan document. However, the Plan Administrator believes the Plan is designed, and is being operated, in conformity with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

In 2020, the Plan was selected for a routine investigation by the DOL for the time period January 1, 2017 through August 15, 2020. The routine investigation closed as of May 2024. The Plan is subject to routine audits by taxing jurisdictions.

7. Party-in-Interest Transactions

Lincoln Financial Group provides administrative services to the Plan. Therefore, investments in the Lincoln Alliance Program Stable Value Separate Account and administrative fees paid to Lincoln Financial Group are considered to be party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Administrative fees charged to the Plan and paid to the trustee during 2024 and 2023 totaled \$1,741,842 and \$1,585,061, respectively. Fees paid to other service providers considered to be parties-in-interest are \$156,350 and \$157,850 at December 31, 2024 and 2023, respectively. Certain fees incurred by the Plan are paid through revenue sharing, rather than direct payment. Notes receivable from Plan participants, and the related interest income and transactions are also considered party-in-interest transactions.
