Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of Waelz Sustainable Products, LLC (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. The Plan covers employees of Waelz Sustainable Products, LLC. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all full-time employees of the Company who meet the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective January 1, 2020, and was restated, most recently, on October 29, 2024.

Contributions

Each year, participants may elect to defer a percentage of eligible compensation up to ninety-two percent of their annual compensation, as defined in the Plan. The Company also may make a discretionary employer profit sharing contribution. The Company makes a QACA enhanced matching contribution of 100% up to 5% of compensation. Participants may also contribute amounts representing distributions from other qualified plans.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Plan earnings (losses). Allocations of earnings (losses) and expenses are based on participant account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service. Safe harbor employer contributions are immediately vested.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum in a non-rollover or direct rollover distribution, or any combination thereof.

Forfeited Accounts

At December 31, 2024, the forfeiture account balance was \$1. This account will be used to reduce future employer contributions.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE A - DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund to (from) the participant notes fund. Loan terms range from 1 - 5 years. Each loan is secured by the balance in the participant's account.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

NOTE F - ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments. Certain expenses of the Plan, including legal and accounting fees, are paid by the Employer. In addition, certain services to the Plan by the Employer were performed at no charge.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

NOTE H - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Mid Atlantic Trust Company is the trustee of the Plan assets as defined by the Plan and, therefore, administrative fees provided to Mid Atlantic Trust Company qualify as party-in-interest transactions. Fees paid by the Plan for such services totaled \$14,760 for the year ended December 31, 2024.
