Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Conner Industries, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

General

Conner Industries, Inc. 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan that was established and adopted effective October 1, 1985, for the benefit of eligible employees of Conner Industries, Inc. and Conner Transportation, Inc. (collectively the Company or Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and is subject to limitations imposed by the Internal Revenue Code (IRC).

The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan is Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal, Trustee, or Recordkeeper). The trustee is responsible for custody and management of the Plan's asset, and as Recordkeeper, they maintain the accounting of participant accounts and perform other services for the Plan.

Eligibility and Participant Accounts

Employees of the Company are considered eligible for participation, except for: (1) nonresident aliens with no U.S. source of income; and (2) employees covered by a collective bargaining agreement that does not provide for participation in the Plan.

Participants must be 21 years of age to participate in the Plan and must complete six months of service.

Eligible employees may enter the Plan on the first day of the month following the date in which initial eligibility requirements are met.

Contributions

The Plan is funded through employee pre-tax deferrals and Company matching contributions. A participant may elect to contribute up to 100% of eligible compensation, as defined in the Plan. Employees who are eligible to make elective deferrals under the Plan and who have attained age 50 before the close of the plan year are also eligible to make catch-up contributions. Rollover contributions representing distribution from other qualified retirement plans are permitted. There is no limitation on the amount of rollover contributions a participant may make to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan also allows for employer matching contributions and employer discretionary profit-sharing contributions in amounts to be determined by the Company. Highly compensated employees are not eligible for employer matching contributions. For 2024, the Company elected to match 50% of the participant's contribution, up to 3% of annual compensation. No employer discretionary profit-sharing contributions were made for the year ended December 31, 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at a pre-tax contribution rate of 3% of eligible compensation and their contributions invested into the Plan's default funds until changed by the participant. Automatic enrollment deferral contributions are increased by 1% every 12 months from the later of the participant's automatic enrollment date or the Plan entry date, unless elected otherwise, up to 10%.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with employee elective deferrals, Company matching contributions, Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested portion of their accounts.

Vesting

Participants are immediately vested in elective deferrals and rollover contributions plus actual earnings, thereon. Vesting of employer contributions and earnings thereon is based on years of service, and vest 100% after three years of qualified service or upon occurrence of the participant's retirement, death, termination, or disability, as defined by the Plan document.

Forfeitures

Upon separation from service for any reason other than retirement, participants forfeit any unvested portion of their employer contributions. Forfeitures are used to reduce the Plan's expenses and then used to reduce any future employer contributions. Unallocated forfeitures of \$0 and \$20 were available for future use as of December 31, 2024 and 2023, respectively. During 2024, forfeitures in the amount of \$49,049 were used to pay employer contributions and \$523 were used to pay administrative expenses.

Notes Receivable from Participants

Borrowings are available for all participants. Notes receivable from participants are limited to a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Any note must be repaid within five years unless for the purchase of a primary residence, in which case the repayment period may not exceed ten years. Participants may have two outstanding notes at a time but may not refinance existing notes. Repayments are made through payroll deductions and are reinvested in the participant accounts according to individual investment elections. Notes receivable are collateralized by the participant's vested account balance and bear interest at a reasonable rate as determined by the Plan Administrator which is fixed for the term of the note.

Payment of Benefits

Upon attainment of normal retirement age, death, disability, or termination, a participant's benefits are payable in a lump-sum amount equal to 100% of the participant's vested account balance. If a participant's vested account balance is less than \$5,000, the vested accrued benefit is

paid in a lump sum or rolled over to an IRA. If a participant's vested account is greater than \$5,000, the participant may elect to keep their funds in the plan or receive a lump sum payment, annuity, installment payments, or a combination thereof.

Immediate lump-sum distributions are generally made to terminated participants if the participant's vested account balance is \$1,000 or less.

Hardship withdrawals and certain other in-service withdrawals are also allowed by the Plan if certain criteria are met.

Withdrawals from the Plan may be made in accordance with the provisions specified in the Plan.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements have been prepared under the accrual method in accordance with United States generally accepted accounting principles (GAAP).

Estimates and Assumptions

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, changes therein, and associated disclosures. Accordingly, actual results may vary from the estimates used in preparing the accompanying financial statements.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Shares of registered investment companies (mutual funds) are valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan at each year end. The fair value of investments in the common collective trust is measured by using NAV as a practical expedient to estimate fair value and is determined by each fund trustee at year end based on the fair value of the underlying securities within that trust.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances, plus any accrued unpaid interest. Related fees are recorded as administrative expenses when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions

Participant and related company contributions are recorded in the period payroll deductions are made.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees paid related to benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Investments in mutual funds are valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts (CCTs) - The fair value of participation units held in collective trusts are based on the NAV reported by fund managers as of the financial statement dates and recent transaction prices. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is probable that the fund will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedules, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedules are in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

5. Risks and Uncertainties

The Plan provides for various investment options in mutual funds of registered investment companies and common collective funds. Such investments are exposed to various risks, such as interest rate, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

7. Tax Status of The Plan

The Plan uses a pre-approved plan document sponsored by Principal. Principal received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Party-in-Interest Transactions

The Plan invests in certain mutual funds of registered investment companies and common collective funds. As Principal is the Plan's trustee and recordkeeper, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for various administrative expenses, including investment management services, amounted to \$115,252 for the year ended December 31, 2024. Notes receivable from participants qualify as a party-in-interest. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

9. Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.
